

### ARTICLE VI ADDITIONAL MEMBERS

Unless the Members unanimously agree to admit a person as a Member in accordance with the foregoing and the terms of the Operating Agreement, no person who acquires an interest or financial right in the Limited Liability Company (by transfer, assignment or devise from another Member or otherwise) shall become a Member, and such a person shall only be entitled to receive such distributions and allocations in respect of such interest or financial right as may be provided in the Operating Agreement.

#### **ARTICLE VII** DISSOLOUTION AND CONTINUATION


The Limited Liability Company may be dissolved and its affairs wound up as specified in the Operating Agreement.
