
IN THE DISTRICT COURT OF SHELBY COUNTY, ALABAMA

9. The affiant requests entry of judgment by the Court.

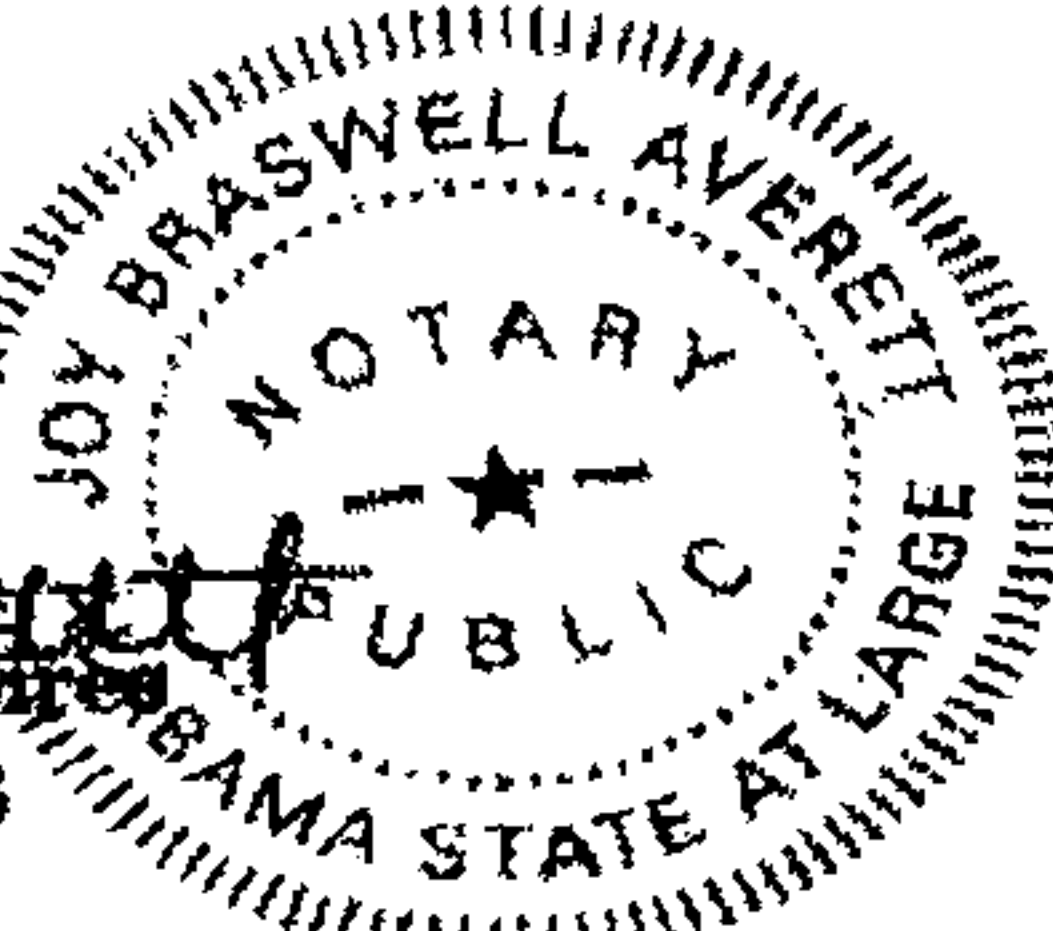

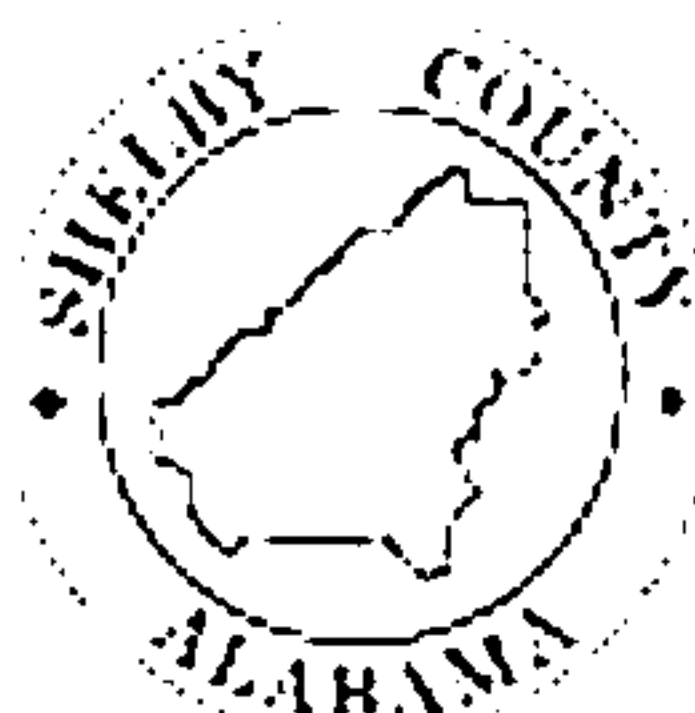
