Cain and John Thomas Cain**, wife and husband (herein referred to as Grantor, whether one or more), grant, bargain, sell and convey unto **Joan Vickery and James Vickery**, (herein referred to as Grantee, whether one or more), the following described real estate, situated in Shelby, County, Alabama, to wit;




\$35,250.30 of the purchase price of the above described property was financed with the proceeds of a mortgage loan closed simultaneously herewith.

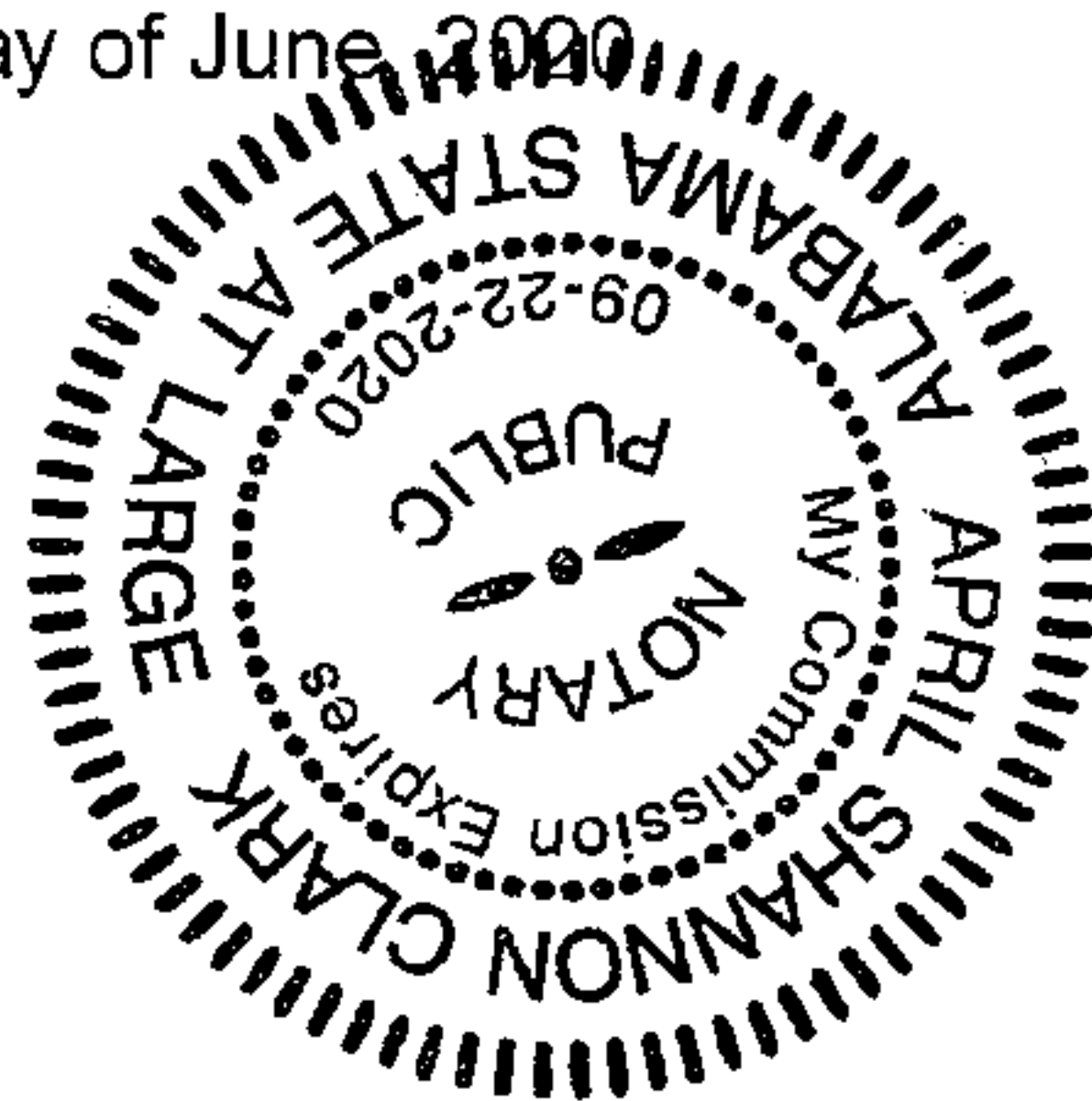
