The Schaefer Trust has not been revoked, modified, or amended in any way that would cause the representations in this Certification of Trust to be incorrect.

By signing below, we each declare under penalty of perjury under the laws of the State of California that the foregoing declarations are true.


RELIANCE ON THIS CERTIFICATION


