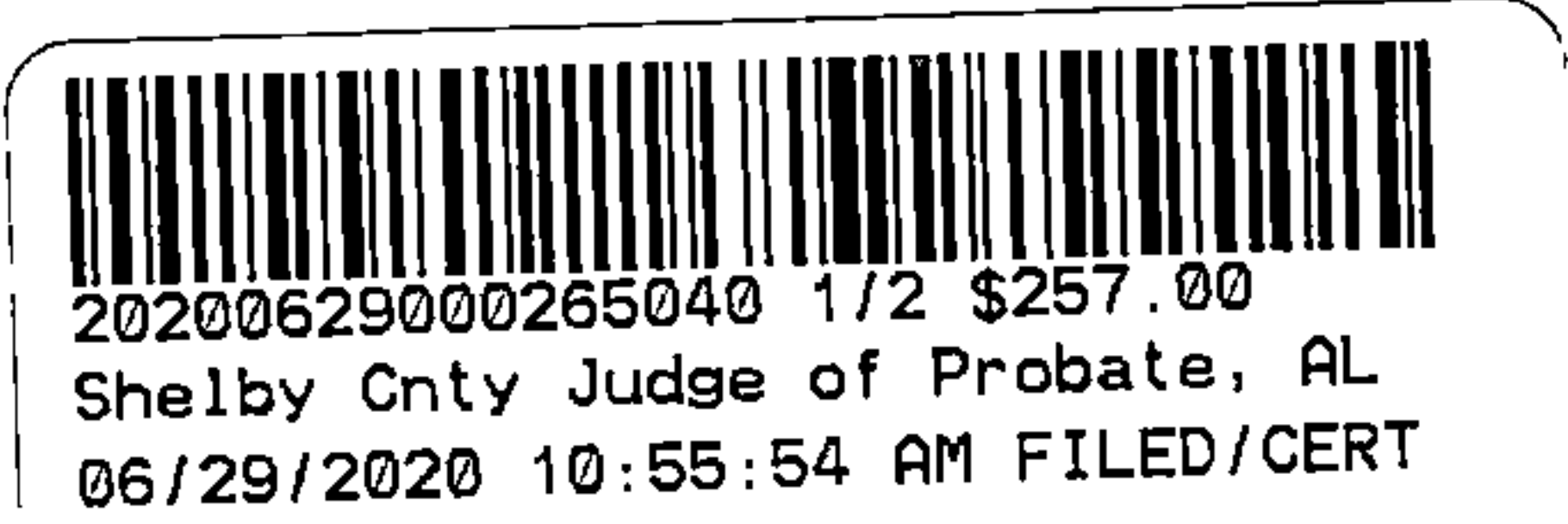

KNOW ALL MEN BY THESE PRESENTS: That, for and in consideration of **Two Hundred Thirty-Two Thousand and 00/100 (\$232,000.00)**, and other good and valuable consideration, this day in hand paid to the undersigned **John T. Harkins, Trustee of the Harkins Living Trust dated September 7, 1999**, (hereinafter referred to as GRANTOR), in hand paid by the GRANTEE herein, the receipt whereof is hereby acknowledged, the GRANTOR does hereby give, grant, bargain, sell and convey unto the GRANTEE, **Cherry K. Jones**, (hereinafter referred to as GRANTEE), her heirs and assigns, the following described Real Estate, lying and being in the County of **Shelby**, State of Alabama, to-wit:

Lot 24, according to the Survey of Chesser Plantation, Phase I, Sector 2, as recorded in Map Book 33, pages 121 A & B, in the Probate Office of Shelby County, Alabama.

Together with the nonexclusive easement to use the Common areas as more particularly described in the Declaration of Covenants, Conditions and Restrictions for Chesser Plantation as recorded in Instrument 2002-10788, First Amendment to Declaration as recorded in Instrument 20070515000227970, in the Probate Office of Shelby County, Alabama, as may be amended from time to time (which together with all amendments thereto, is hereinafter referred to as the Declaration).
