THAT IN CONSIDERATION OF **Ten Dollars and NO/100 (\$10.00)** to the undersigned grantors, in hand paid by the Grantees herein, the receipt whereof is acknowledged, we, **Virginia S. Hess, a** single **woman conveying property that is not her homestead nor that of her spouse, and Stephen C. Hess and Cheryl M. Hess, husband and wife,** (herein referred to as **Grantors**), grant, sell, bargain and convey unto, **Stephen C. Hess and Cheryl M. 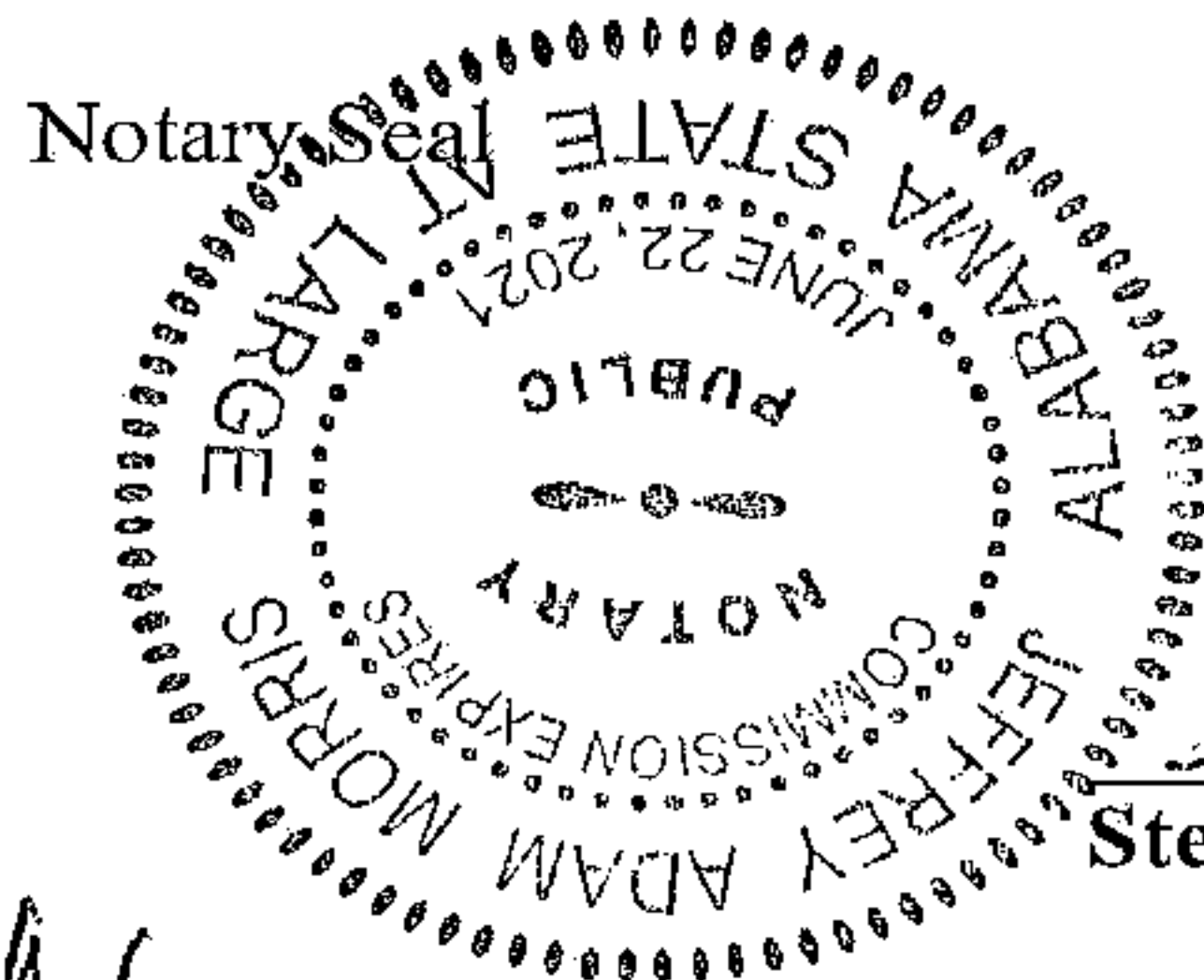
