(herein referred to as grantees) as joint tenants with right of survivorship, the following described real estate property situated in Shelby County, Alabama, the address of which is: 5257 Highway 26, Columbiana, AL 35051 to-wit:

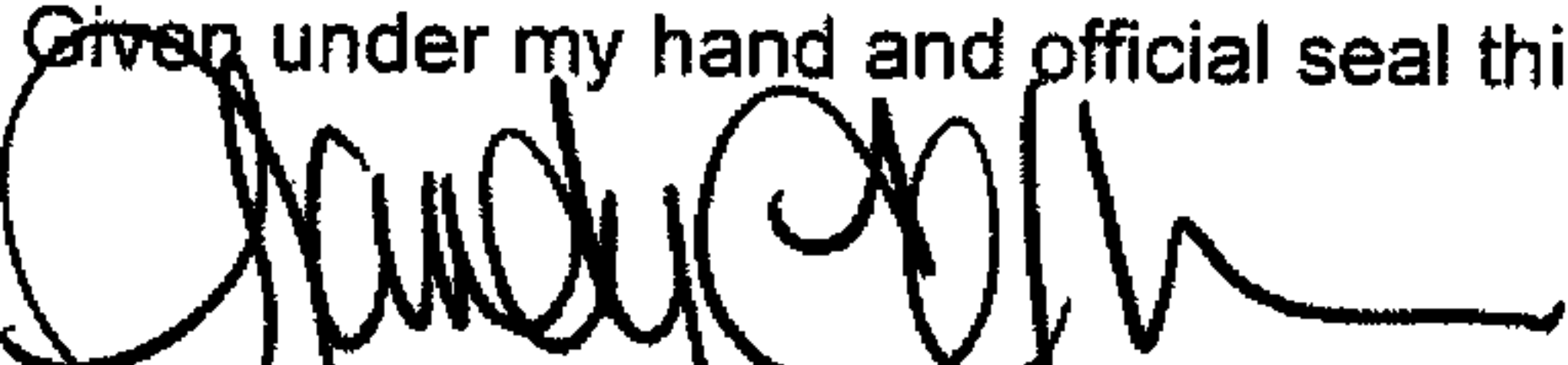
