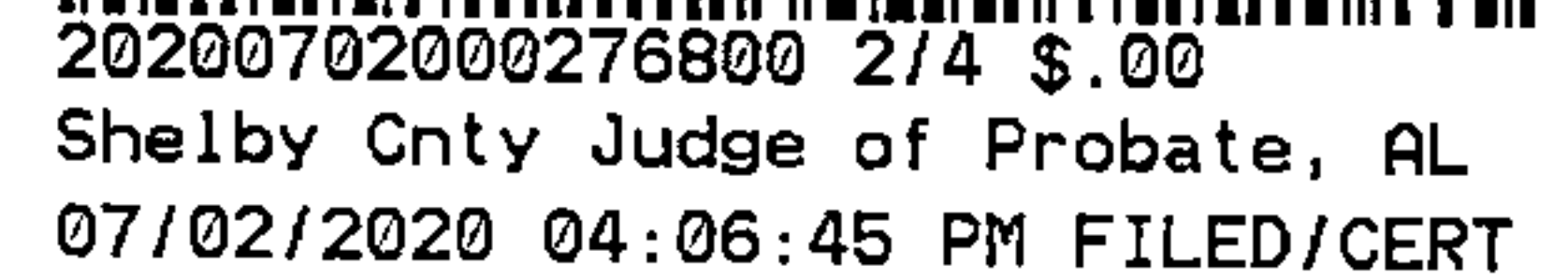

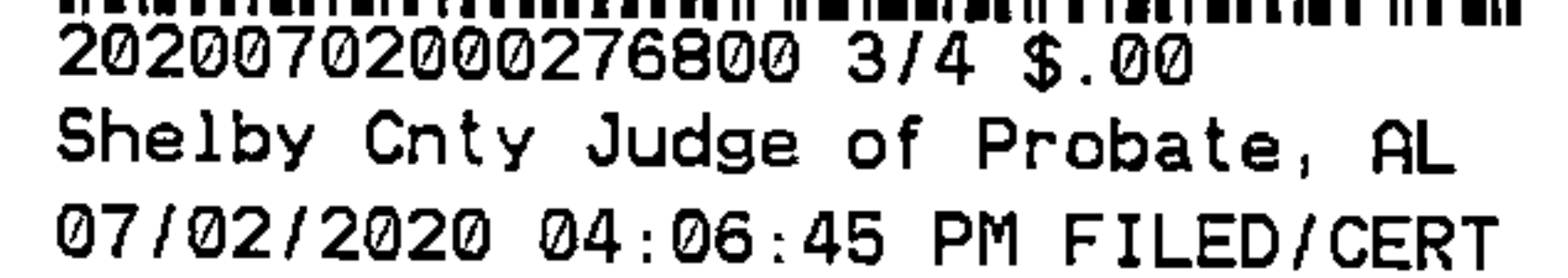


FORM 3: In-Kind Contributions received by candidate or elected official

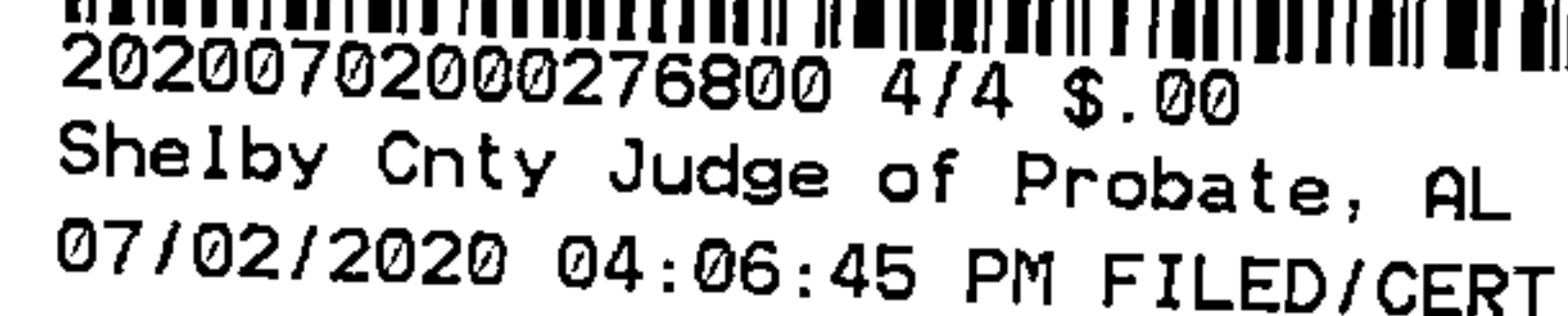
