Daley and Ashley N. Daley, a married couple** (herein referred to as grantor), grant, bargain, sell and convey unto **Erin Akers and Jeffrey B. Akers**, (herein referred to as grantees), for and during their joint lives, and upon death of either of them, then to the survivor of them in fee simple, together with every contingent remainder and right of reversion, the following described real estate situated in **Shelby County, Alabama**, to wit:


