

DEED FOR PERMANENT UTILITY EASEMENT

know all Men By These Presents, that for and in consideration of the sum of _______ dollar(s) cash in hand paid the receipt whereof is hereby acknowledged, I (we), the undersigned grantor(s) Patricia Tucker, Joe Tucker Jr., and Debbie Fields Tucker have this day bargained and by these presents do hereby grant, bargain, convey, transfer, and deliver unto the City of Helena a permanent utility easement and right of way for the following purposes, to-wit: The right to enter upon the hereinafter described land and to construct and maintain utilities as may be necessary, on, over and across the ground embraced within the boundaries of a tract or parcel of my (our) land situated in the County of Shelby, State of Alabama.

The easement and right of way hereby granted is more particularly located and described as follows, to-wit: And as shown on the right-of-way map of record with the City of Helena, Alabama as an aid to persons and entities interested therein and as shown on the Property Plat attached hereto and made a part hereof:

PERMANENT UTILTY EASEMENT NO. 1 OF 1:

A part of the SE ¼ of the NE ¼ of Section 21, T-20-S, R-03-W, in Shelby County, Alabama, identified as Tract No. 6 and being more fully described as follows:

COMMENCE at a 1/2" Rebar Found at the Southwest Corner of the Southeast Quarter of Northeast Quarter of Section 21, Township 20S, Range 03W;

thence run North 00° 04' 42" East for a distance of 959.48 feet;

thence run South 89° 55' 18" East for a distance of 586.99 feet to a point on the Northwest Right-of-Way of Helena Road and the **POINT OF BEGINNING** of the following described Permanent Utility Easement;

thence leaving the Northwest Right-of-Way of Helena Road run North 51° 54' 05" West for a distance of 10.00 feet;

thence run North 38° 05' 55" East for a distance of 7.00 feet;

thence run North 38° 05' 55" East for a distance of 35.22 feet;

thence run North 38° 05' 55" East for a distance of 178.02 feet;

thence run South 51° 54' 05" East for a distance of 10.00 feet to a point on the Northwest Right-of-Way of Helena Road;

thence run South 38° 05' 55" West along the Northwest Right-of-Way of Helena Road for a distance of 220.24 feet to the POINT OF BEGINNING;

said Permanent Utility Easement containing 0.05 acres more or less.

To have and to hold, the said easement and right of way, unto the City of Helena and unto its successors and assigns.

And the said grantor(s) hereby covenant(s) with the City of Helena that I (we) am (are) lawfully seized and possessed of the afore-described tract or parcel of land; that I (we) have a good and lawful right to convey it; that it is free from all encumbrances; and that I(we) will warrant and forever defend the title and quiet possession thereto against the lawful claims of all persons whomsoever.

As a further consideration for the payment of the price above stated, I (we) hereby release the City of Helena, its employees and officials, from all claims for damage, from whatsoever cause, present or prospective, incidental or consequential, to the exercise of any of the rights herein granted.


