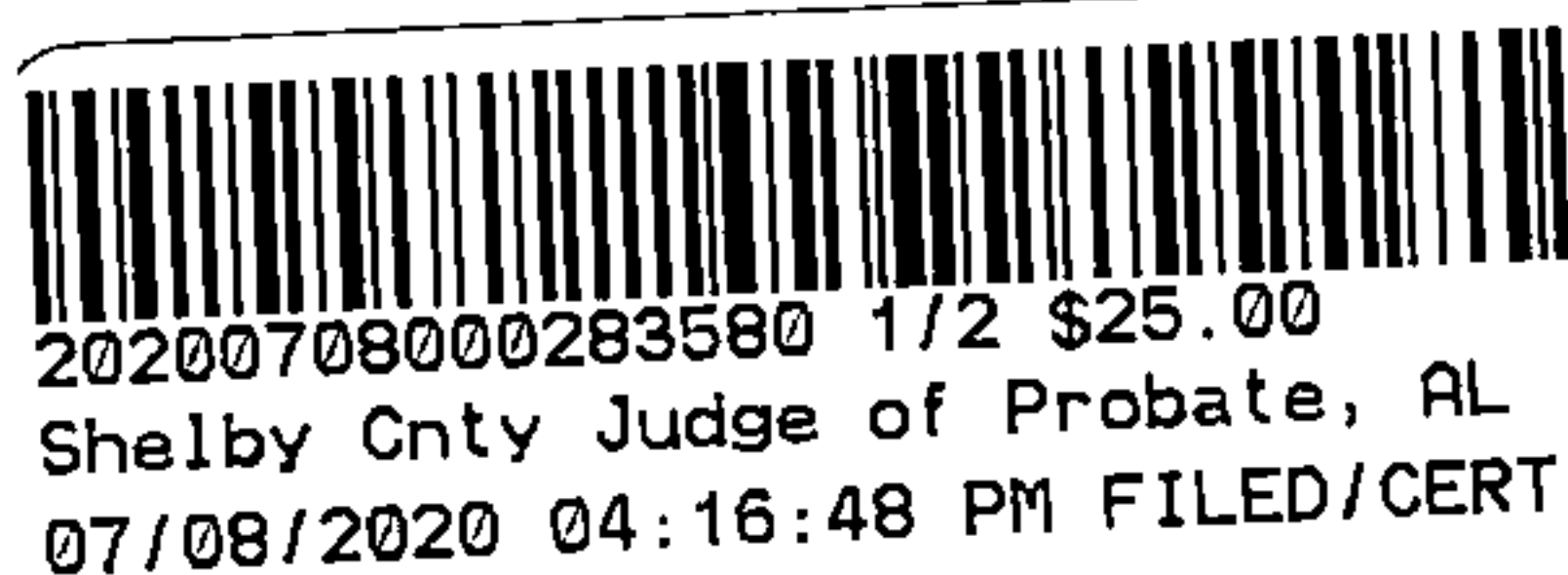

DEED FOR INTERMENT RIGHTS

No conveyance or transfer of the interment rights herein granted shall be valid without the prior written consent of the Grantor and unless proper instrument of transfer is recorded in the Offices of the Shelby Memory Gardens.

Restrictive Covenant – This Deed for Interment Rights is subject to Rules and Regulations of the Grantor Company as to the appropriate cemetery which said Rules and Regulations may be amended from time to time as stated in the said Rules and Regulations. A copy of the said Rules and Regulations have been received and reviewed by Grantee.
