

First: The name and state of incorporation of each of the entities that are parties to the merger to which these Articles of Merger relate (the "Constituent Entities") are as follows:

Second: An Agreement and Plan of Merger dated as of November 3, 2019 (the "Agreement") providing for the merger of IBERIABANK Corporation with and into First Horizon National Corporation (the "Merger") has been adopted and approved by the Constituent Entities in accordance with the requirements of Section 1-1104 of the LBCA.

Third: The participation of First Horizon National Corporation was duly authorized as required by its organic law.

Fourth: The Merger is to be effective at 11:59 p.m., Central Time, on July 1, 2020 (the "Effective Time").

Fifth: The name of the surviving entity is "First Horizon National Corporation" (the "Surviving Entity").

Sixth: The Restated Charter of the Surviving Entity, as in effect on the date hereof, as amended immediately prior to the Effective Time pursuant to the terms of the Agreement, shall continue in full force and effect as the Restated Charter of the Surviving Entity until altered, amended or repealed as provided therein or by law.

Seventh: The Agreement was approved by the shareholders of IBERIABANK Corporation in the manner required and by the Articles of Incorporation.

Eighth: A copy of the executed Agreement is on file at the principal place of business of the Surviving Entity, located at 165 Madison Avenue, Memphis, Tennessee 38103.

Ninth: A copy of the Agreement will be furnished by the Surviving Entity, on request and without cost, to any shareholder of the Constituent Entities.






