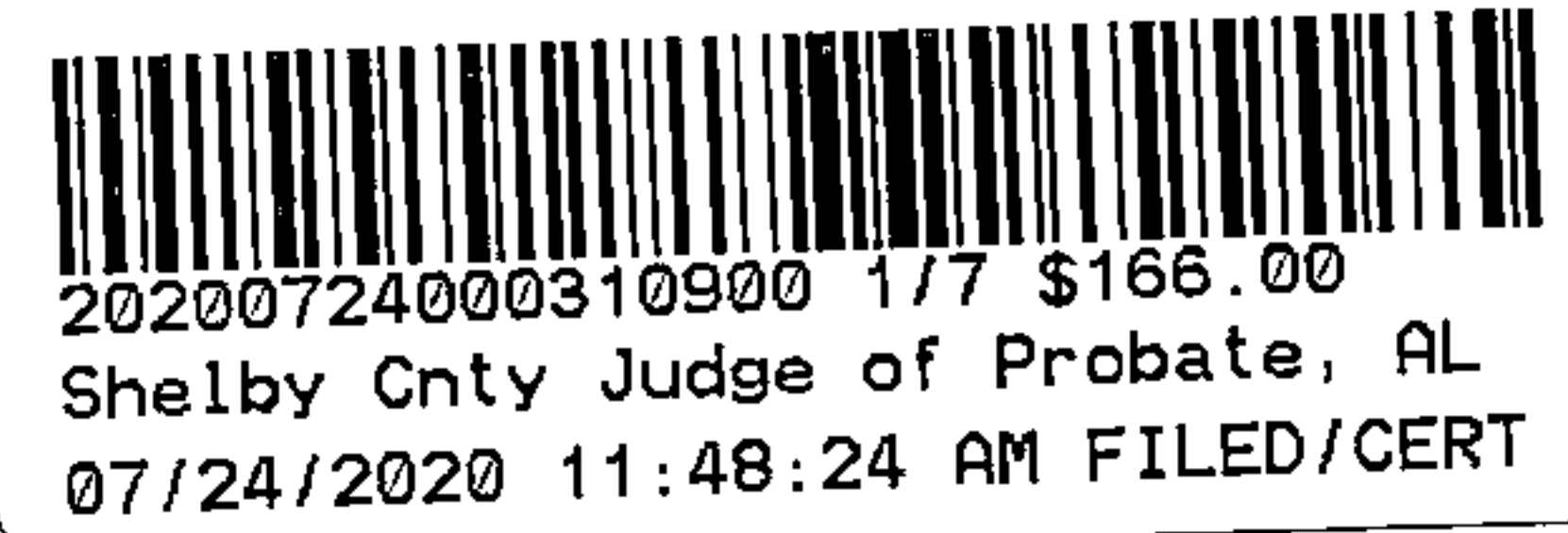




CERTIFICATE OF FORMATION OF

3. The Initial capital has been contributed to the Company in the manner set forth on Exhibit "C" attached hereto, and the following individuals have the Membership Interests as set forth below:

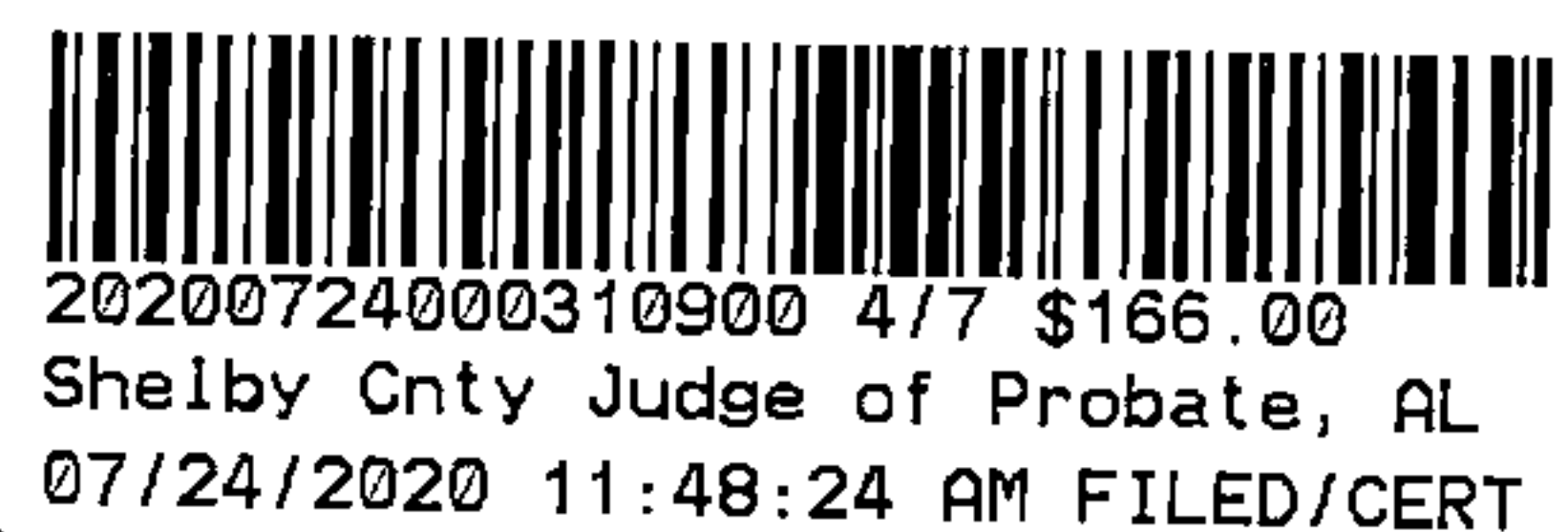

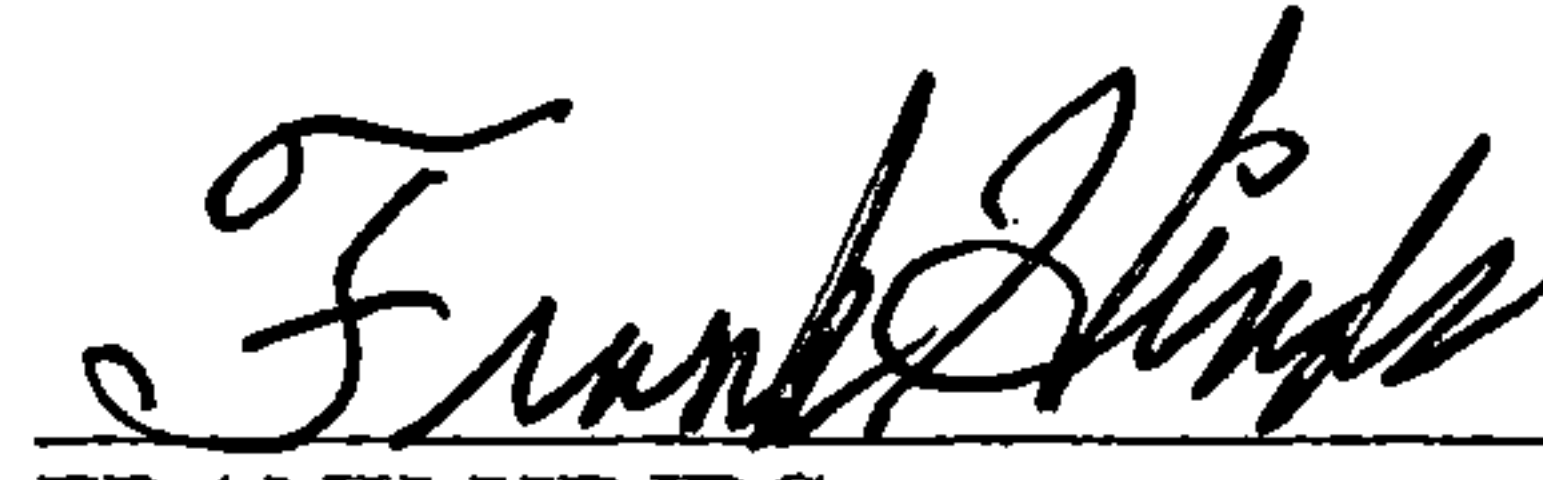
5. The fiscal year of the Company is selected as the twelve month period ending on the last day of December of each year.

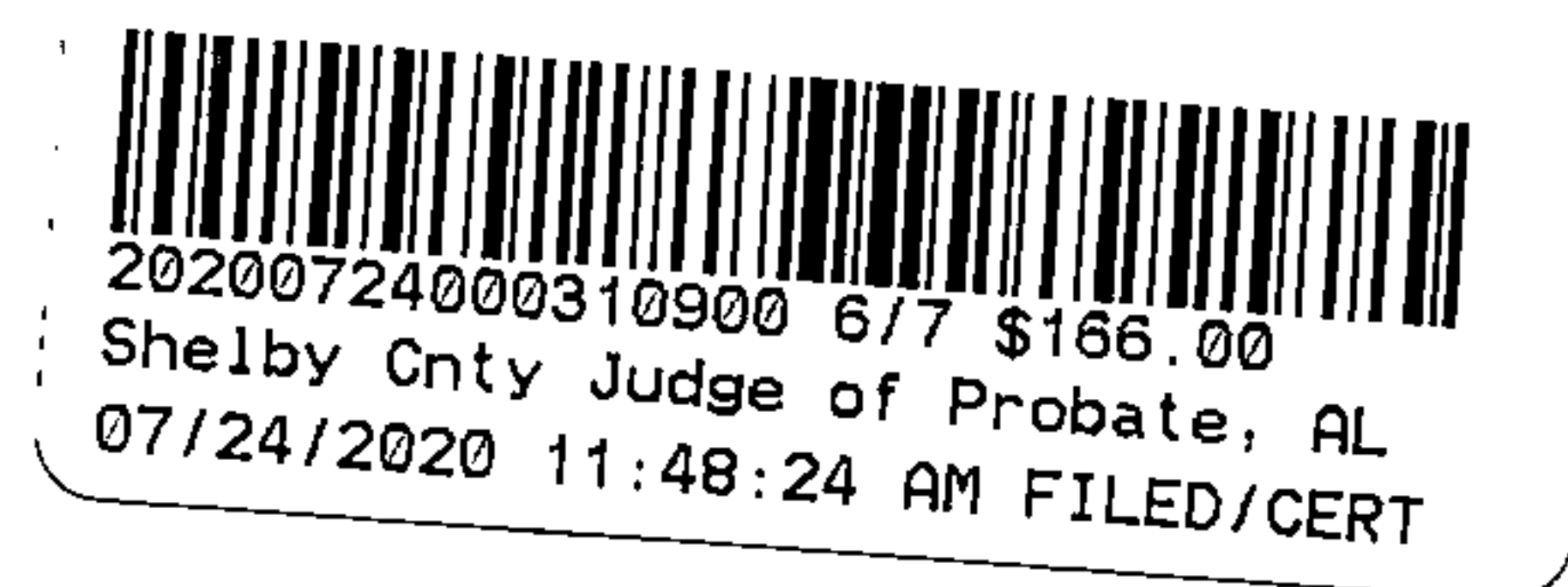
