Know All Men by These Presents: That in consideration of **Two Hundred Thirty-Seven Thousand Two Hundred Sixty and 00/100 Dollars (\$237,260.00)**, to the undersigned Grantor, in hand paid by the Grantees herein, the receipt where is acknowledged, **SDH BIRMINGHAM, LLC** (herein referred to as Grantor) grant, bargain, sell and convey unto **TONI HAMPTON and CARL T. SPENCER** (herein referred to as Grantees), the following described real estate, situated in **SHELBY** County, Alabama, to-wit:

Lot 1, according to the Survey of Country View Estates, Phase 3, as recorded in Map Book 51, Page 41 A & B, situated in Shelby County, Alabama.

Subject to mineral and mining rights if not owned by Grantors. Subject to existing easements, restrictions, set-back lines, rights of way, limitations, if any of record.

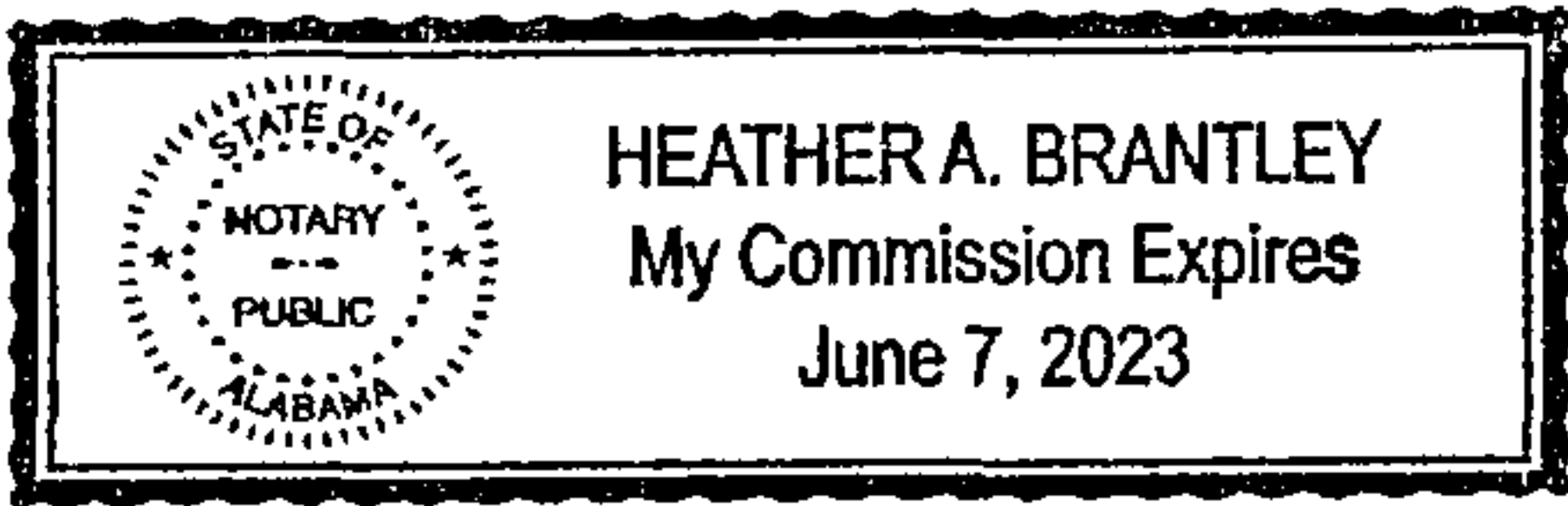

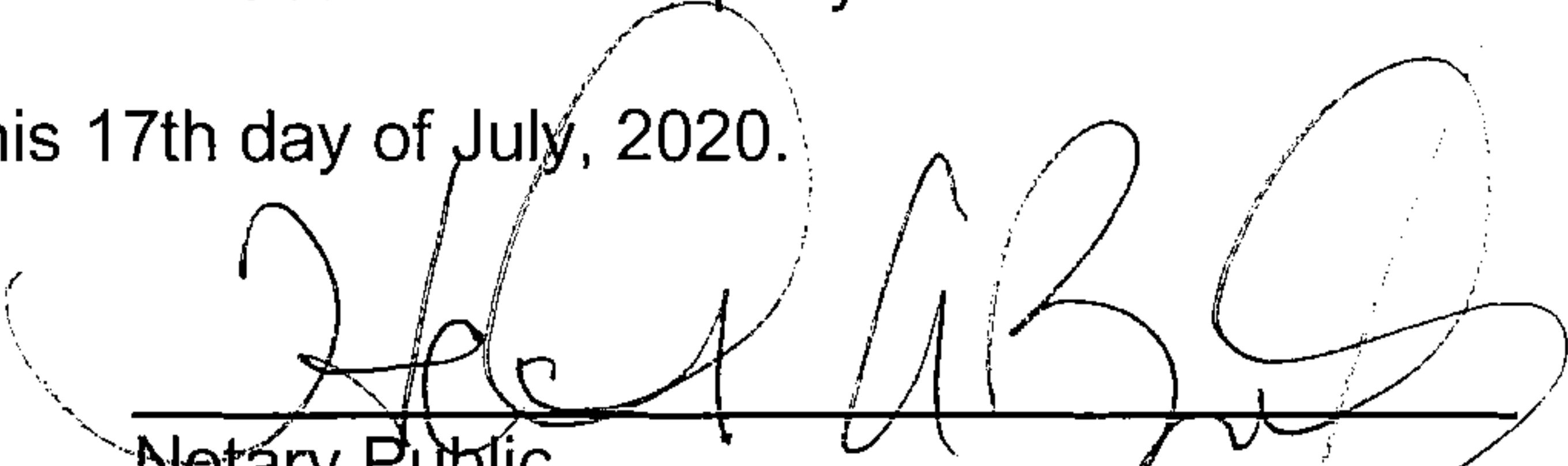

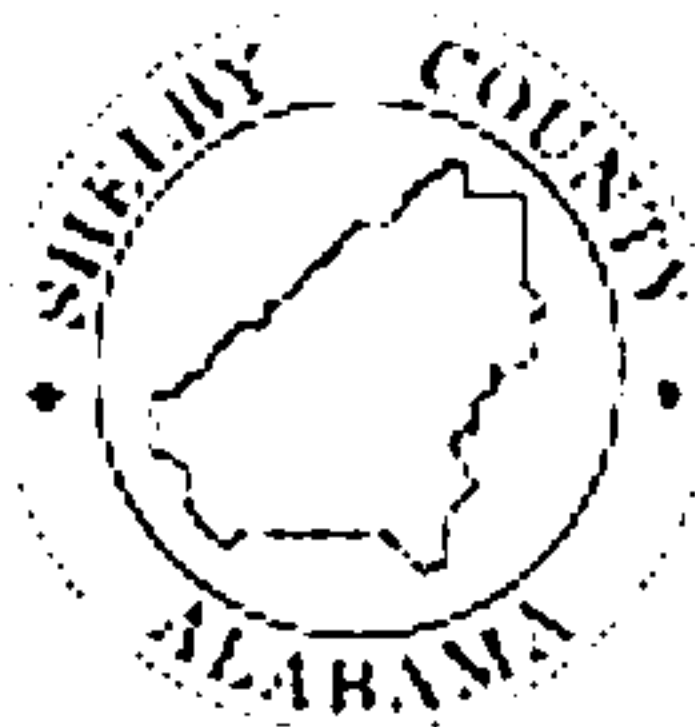
