Pike**, a Single woman (herein referred to as Grantor, whether one or more), grant, bargain, sell and convey unto **Robert Walter McManus, Jr. and Holli J. McManus**, (herein referred to as Grantee, whether one or more), the following described real estate, situated in Shelby, County, Alabama, to wit;
