WARRANTY DEED WITH JOINT RIGHT OF SURVIVORSHIP

KNOW ALL MEN BY THESE PRESENTS,

On this July 31, 2020, That for and in consideration of **THREE HUNDRED FORTY NINE THOUSAND NINE HUNDRED AND NO/100 (\$349,900.00) DOLLARS**, and other good and valuable consideration, this day in hand paid to the undersigned GRANTOR **VIRGINIA E. HAGENBUCH, an unmarried person, by Amanda G. Baker as her attorney-in-fact**, (herein referred to as "Grantor"), in hand paid by the Grantees herein, the receipt whereof is hereby acknowledged, the Grantor does hereby give, grant, bargain, sell and convey unto the Grantees, **MUHAMMAD ZOHAIK and SARAH AKBAR**, (herein referred to as "Grantees"), for and during their joint lives and upon the death of either, then to the survivor of them in fee simple, together with every contingent remainder and right of reversion, all of the Grantor's interest in the following-described Real Estate situated in, **SHELBY COUNTY, ALABAMA**, to wit:

Lot 87, according to the Survey of Final Plat for Bent River Phase IV, as recorded in Map 41, Page 64 A & B, in the Probate Office of Shelby County, Alabama.

Subject to:

2. Municipal improvements, taxes, assessments, and fire district dues against subject property, if any.
3. Mineral and mining rights not owned by Grantor.
4. Any applicable zoning ordinances.
5. Easements, encroachments, building set back lines, rights-of-ways as shown of record by recorded plat or other recorded instrument, including any amendments thereto.
6. All matters, facts, easements, restrictions, assessments, covenants, agreements and all other terms and provisions in Map Book 41, Page 64.

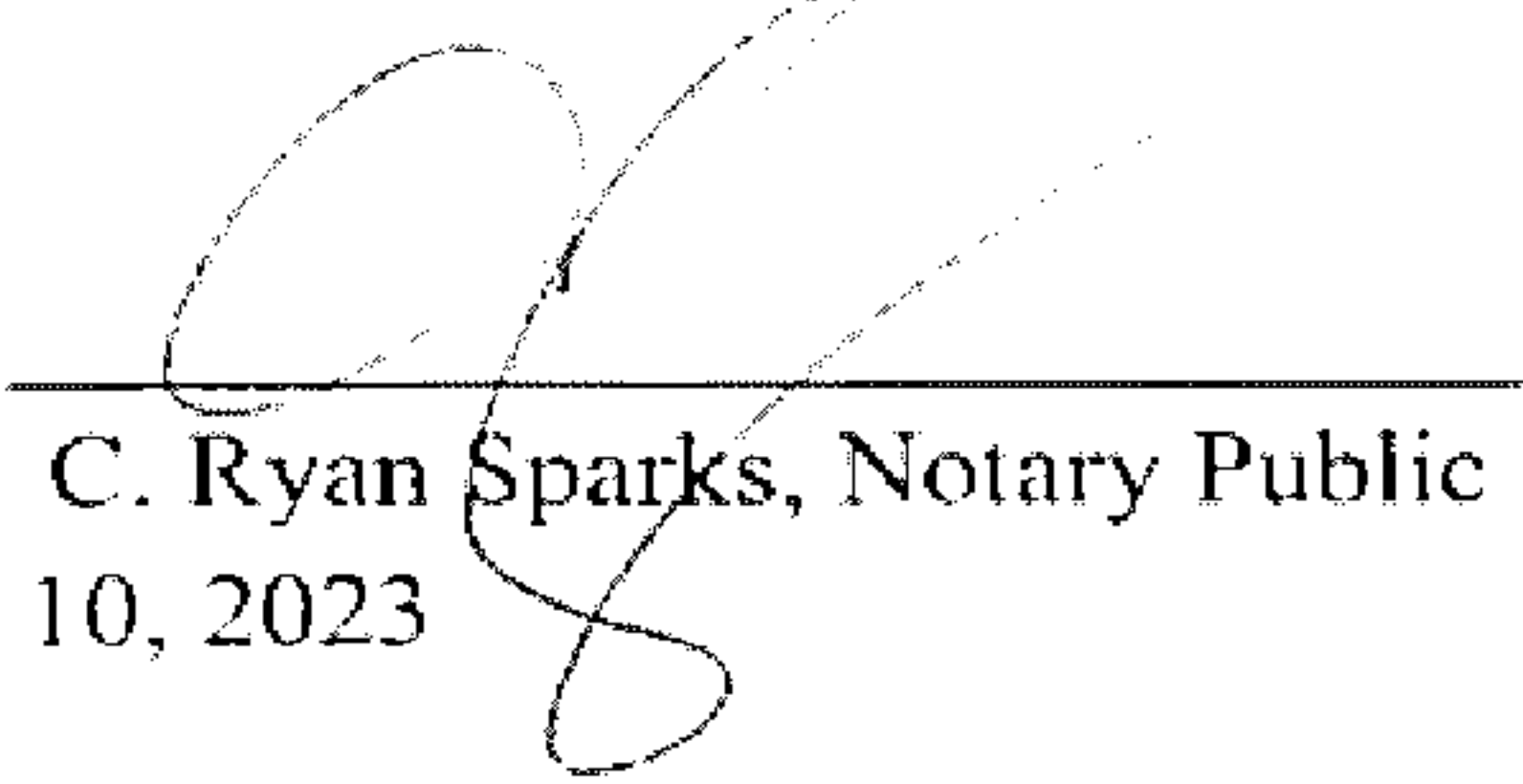

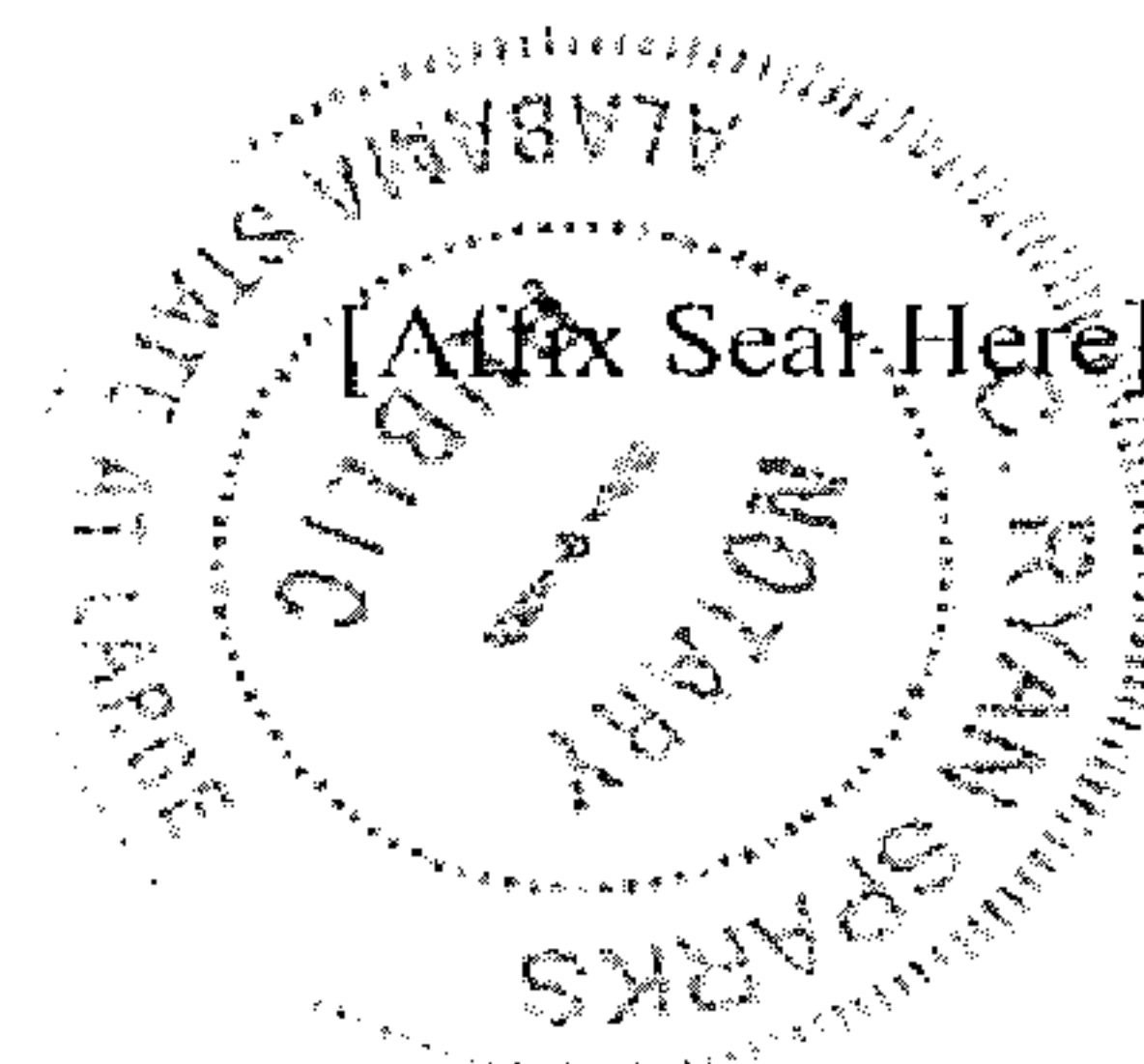
