WARRANTY DEED WITH JOINT RIGHT OF SURVIVORSHIP

KNOW ALL MEN BY THESE PRESENTS,

That for and in consideration of **FOUR HUNDRED THIRTY SIX THOUSAND NINE HUNDRED AND NO/100 (\$436,900.00) DOLLARS**, and other good and valuable consideration, this day in hand paid to the undersigned **ERIN M. TATUM and PHILIP TATUM, wife and husband**, (herein referred to as "Grantors"), in hand paid by the Grantees herein, the receipt whereof is hereby acknowledged, the Grantors do hereby give, grant, bargain, sell and convey unto the Grantees, **CHRISTOPHER A. JEFFERSON and JACEY G. JEFFERSON**, (herein referred to as "Grantees"), for and during their joint lives and upon the death of either, then to the survivor of them in fee simple, together with every contingent remainder and right of reversion, all of the Grantors' interest in the following-described Real Estate situated in, **SHELBY COUNTY, ALABAMA**, to wit:

Lot B-26, according to the Survey of Griffin Park at Eagle Point, Sector 2, Phase 1, as recorded in Map Book 48, Page 98 A, B, C, D & E, in the Probate Office of Shelby County, Alabama.

Subject to:

1. General and special taxes or assessments for the year 2020 and subsequent years not yet due and payable.
2. Municipal improvements, taxes, assessments, and fire district dues against subject property, if any.


The purchase of the herein described real property is being financed in whole or in part by the proceeds of a purchase money mortgage being executed simultaneously herewith.


