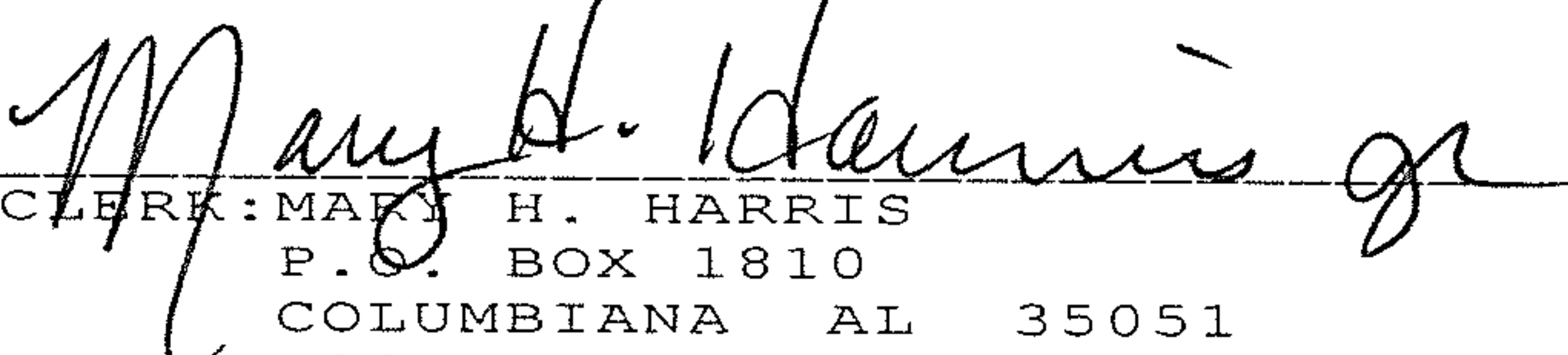

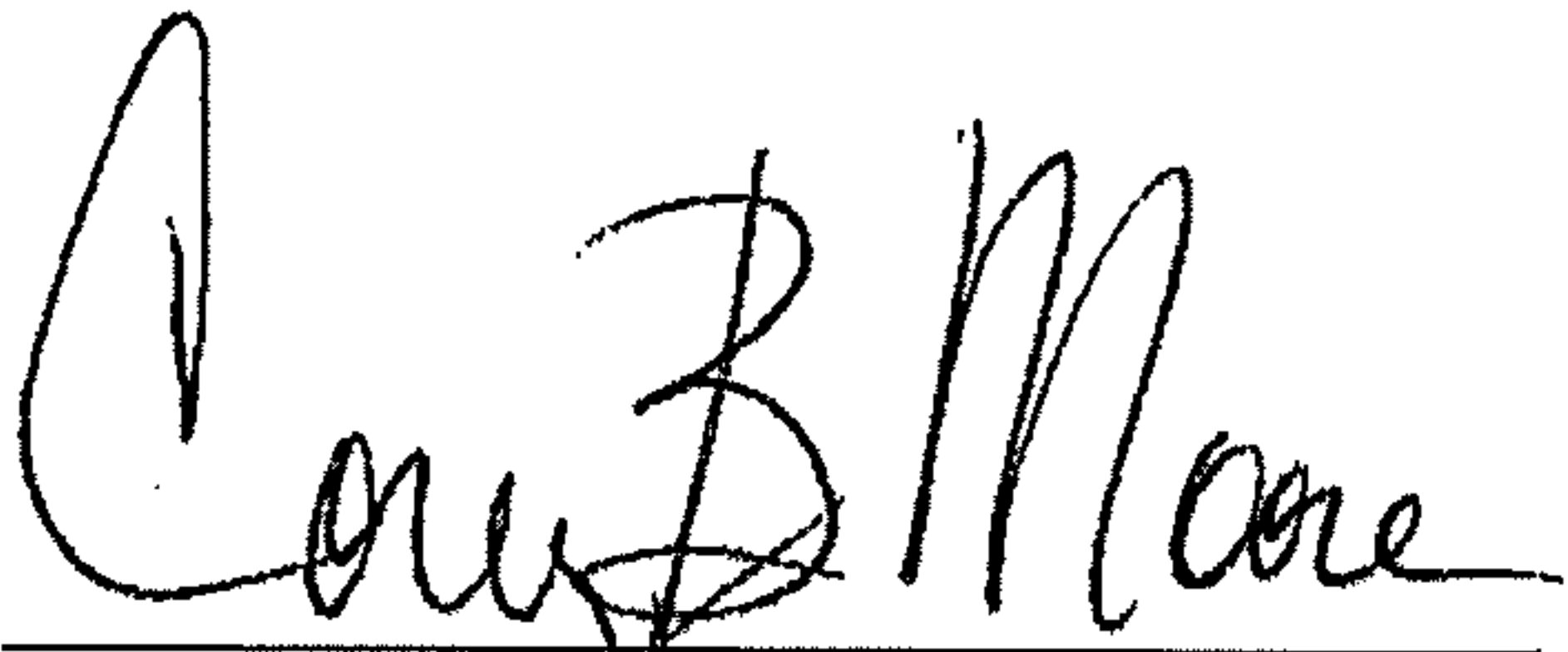

Consequently, the Plaintiff is entitled to the relief sought in its Complaint by default. It is therefore ORDERED, ADJUDGED, and DECREED as follows:

1. Judgment is rendered in favor of the Plaintiff and against the Defendant, for \$34,983.40
2. The Court hereby declares the Plaintiff has a lien against the Property to secure the indebtedness of the Defendants to Plaintiff as set out in the aforementioned paragraph.
