Jernigan & Alexis A. Jernigan** (herein referred to as grantor), grant, bargain, sell and convey unto **Ernest Curtis Sellers and Sherry S. Sellers**, (herein referred to as grantees), for and during their joint lives, and upon death of any of them, then to the survivor(s) of them in fee simple, together with every contingent remainder and right of reversion, the following described real estate situated in **Shelby County, Alabama**, to wit:

Lot 2032, according to the Survey of Old Cahaba, Phase V, 6th Addition, as recorded in Map Book 37, Page 62, in the Office of the Judge of Probate of Shelby County, Alabama.

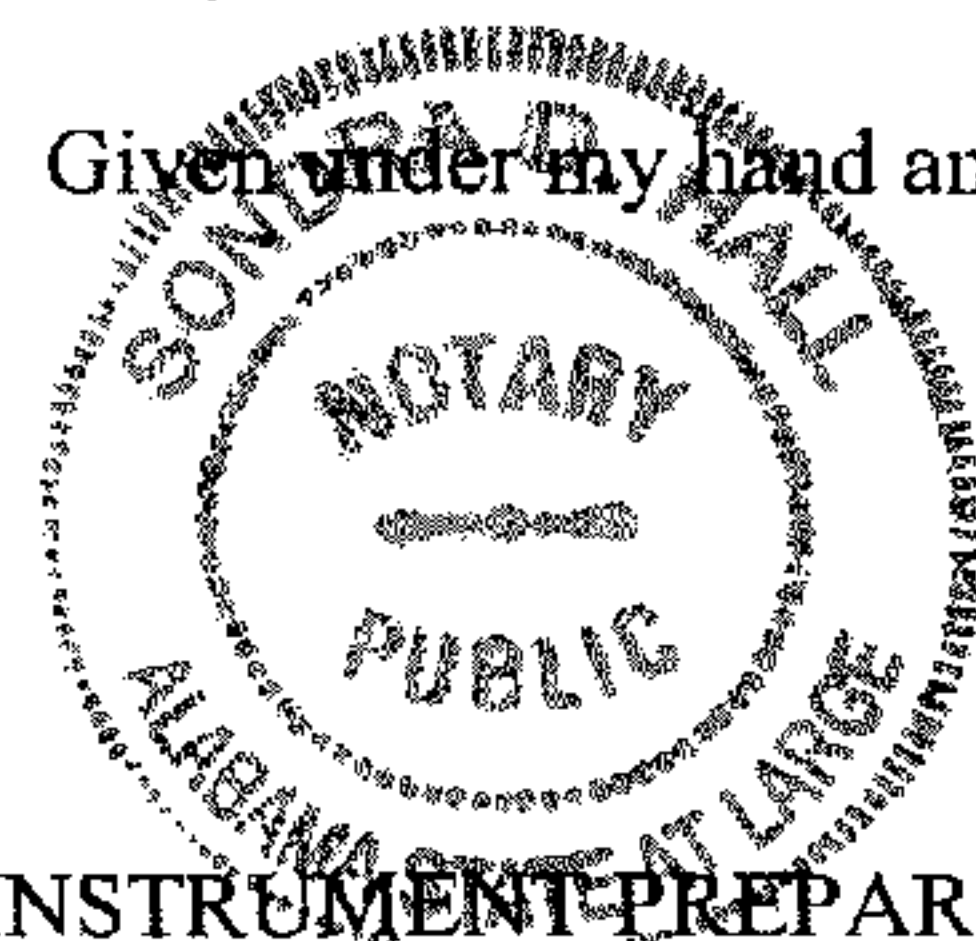
