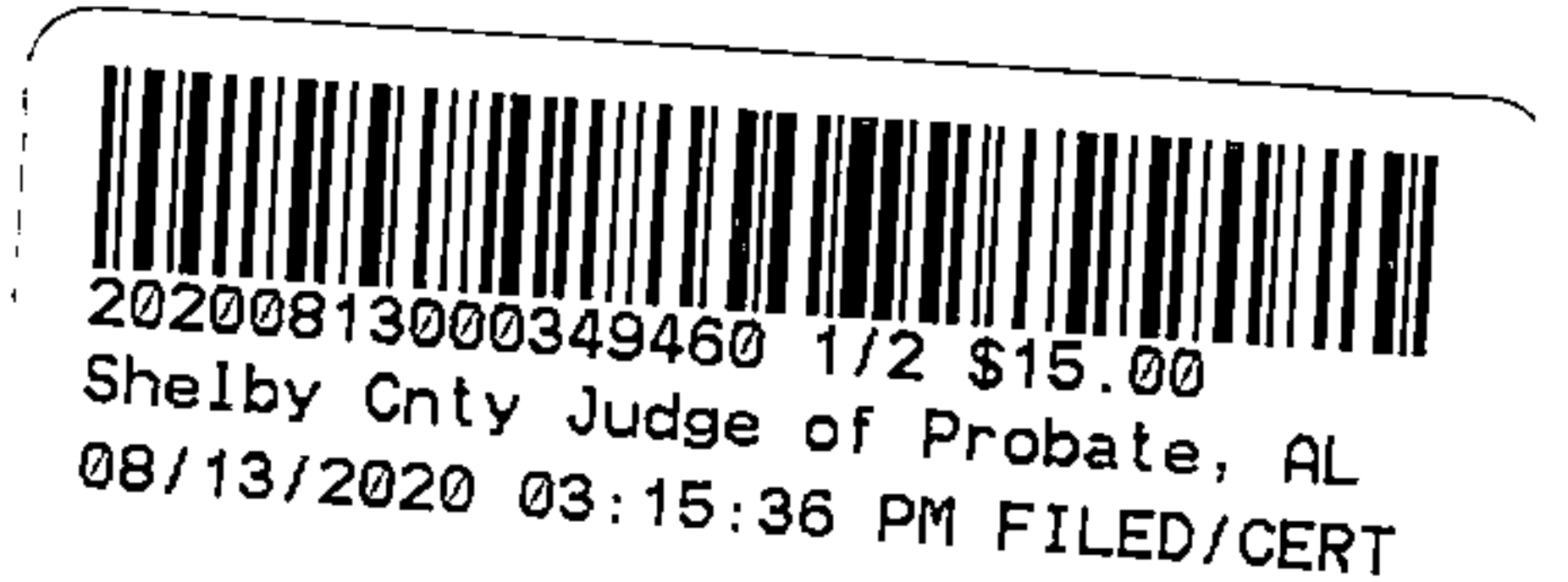

Powers of each Trustee:

In administering the trust, each Trustee may, *inter alia*, exercise the following powers, individually or jointly, as to real and personal property, and in furtherance of the trust purposes: to hold, retain, invest, reinvest and manage without diversification as to kind, amount or risk of nonproductivity in realty or personalty and without limitation by statute or rule of law; to partition, sell, exchange, grant, convey, deliver, assign, transfer, lease, option, mortgage, pledge, abandon, borrow, loan, contract, distribute or allocate in cash or kind or partly in each at fair market value on the date of distribution or allocation and without requiring pro rata distribution or allocation of specific assets and without requiring pro rata allocation of the tax bases of such assets; hold in nominee form, continue businesses, carry out agreements, deal with itself, other fiduciaries and business organizations in which Trustee may have an interest, effect transactions between any trusts created by Settlor or between any trusts created by Settlor and Settlor's estates, establish reserves, release powers and abandon, settle or contest claims, and do all other things permitted by law, including §§ 19-3-11, *et seq.* & 19-3B-101, *et seq.*, 1975 *Code of Alabama*.

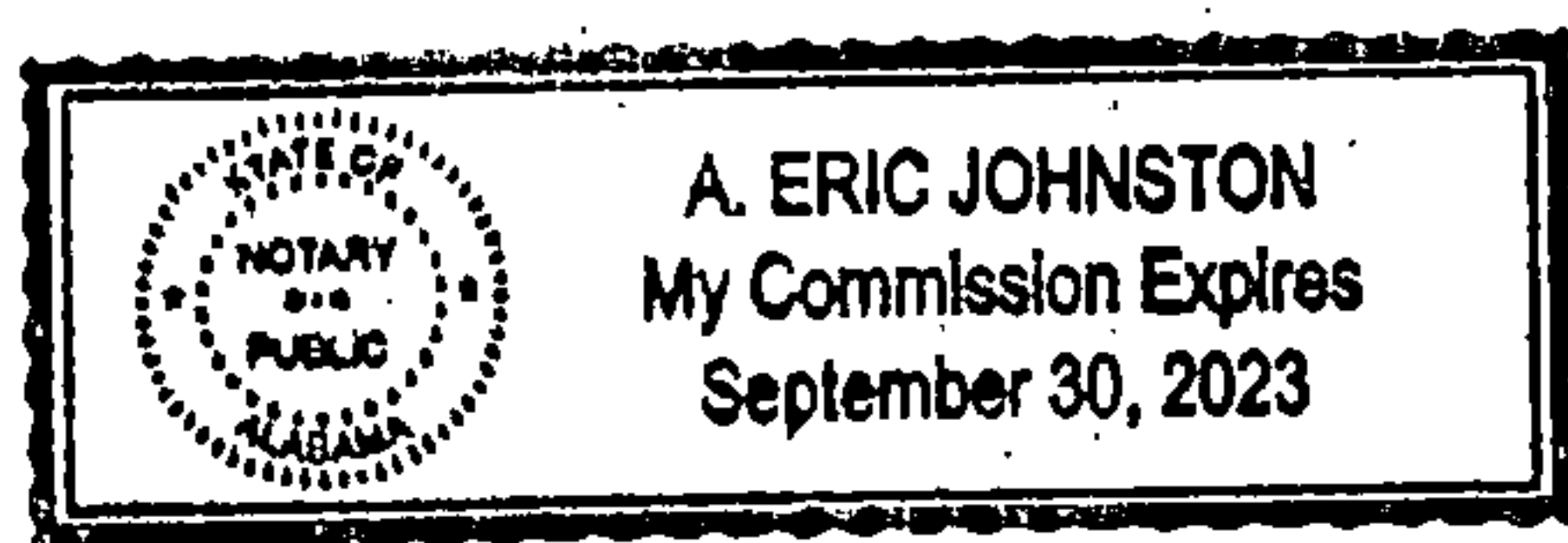

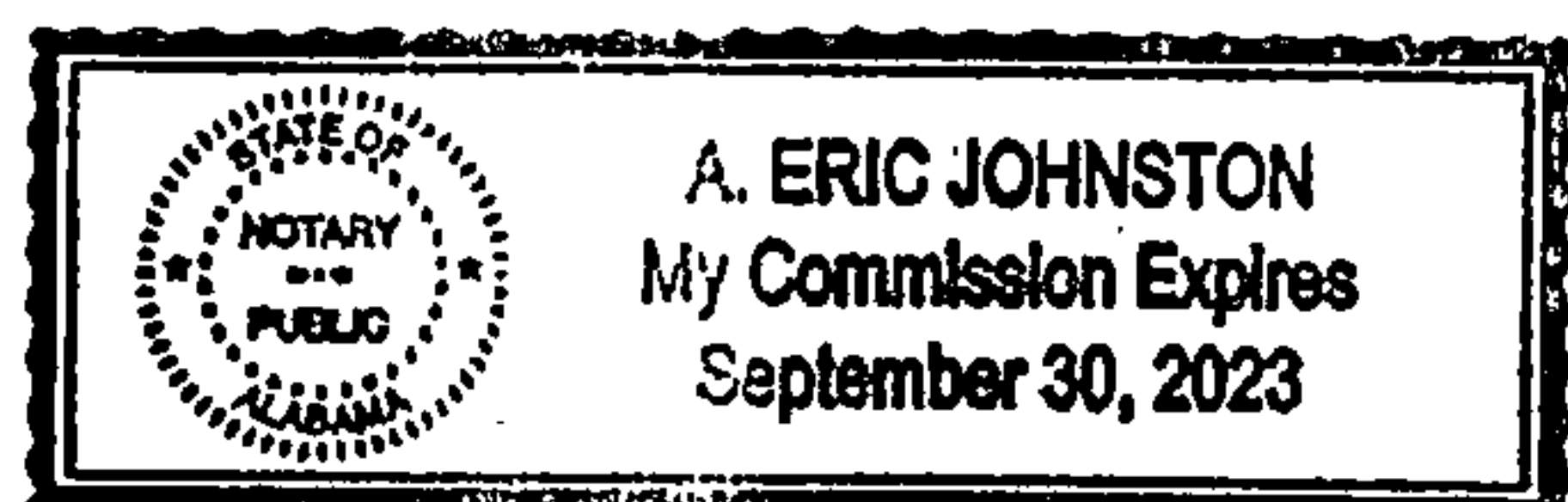
