**WARRANTY DEED**  
**Joint Tenancy With Right of Survivorship**

**KNOW ALL MEN BY THESE PRESENTS**, that in consideration of **One Hundred Fifty Seven Thousand Three Hundred Dollars and No Cents (\$157,300.00)** and other good and valuable consideration the receipt and sufficiency whereof is hereby acknowledged, **Jonathan Wiggins and Kirsten Wiggins, husband and wife** (herein referred to as GRANTOR) does by these presents grant, bargain, sell and convey unto **Quincy James Barnhill and Tatum Barnhill, husband and wife** (herein referred to as GRANTEE, whether one or more) as joint tenants with right of survivorship, the following described real estate situated in Shelby County, Alabama, to-wit:

Lot 57, according to the Map and Survey of Summerchase, Phase 4, as recorded in Map Book 26, Page 11, in the Probate Office of Shelby County, Alabama.




Note: \$152,581.00 of the purchase price is being paid by the proceeds of a first mortgage loan executed and recorded simultaneously herewith.

And said GRANTOR does for itself, its successors and assigns, covenant with said GRANTEES, their heirs and assigns, that it is lawfully seized in fee simple of said premises, that they are free from all encumbrances, that it has a good right to sell and convey the same as aforesaid, and that it will, and its successors and assigns shall, warrant and defend the same to the said GRANTEES, their heirs, executors and assigns forever, against the lawful claims of all persons.

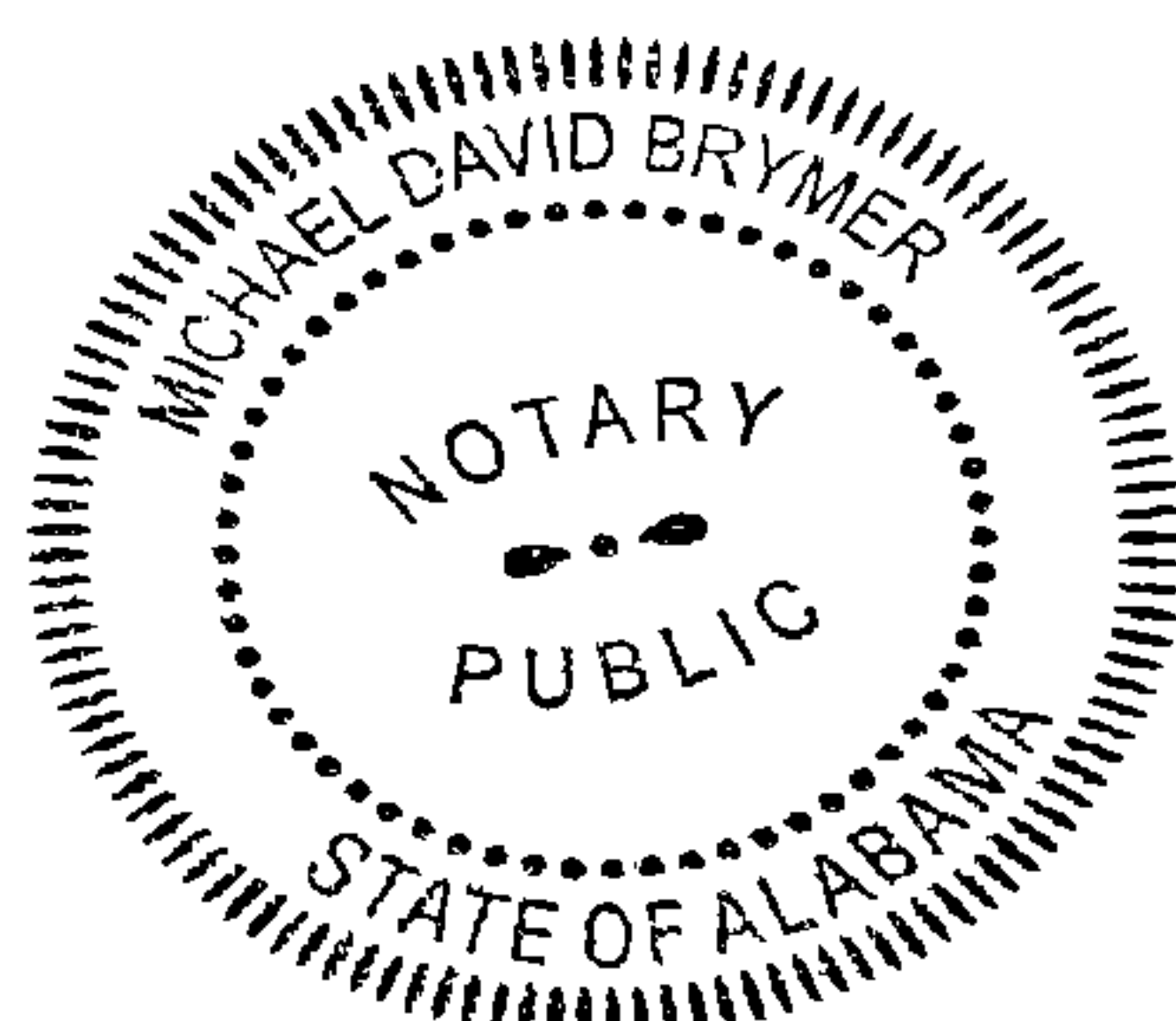



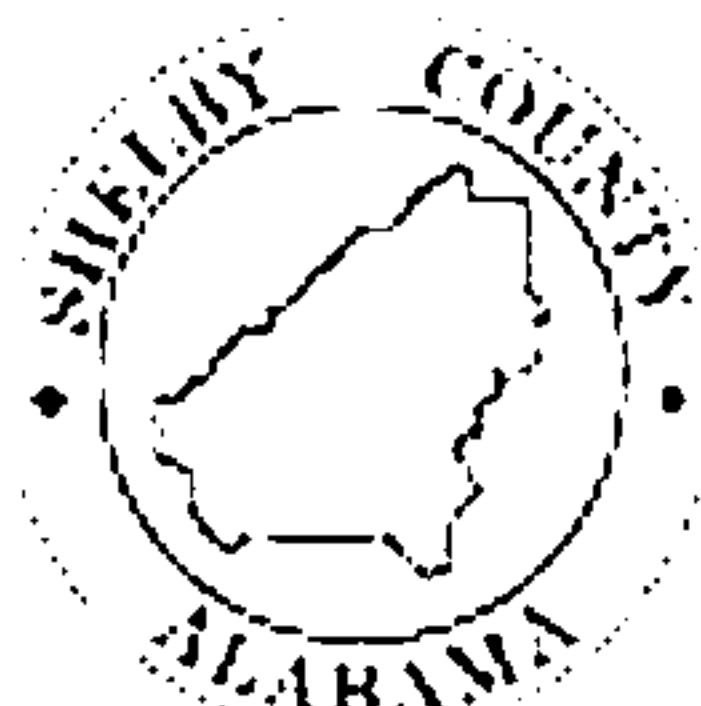
