KNOW ALL MEN BY THESE PRESENTS, That in consideration **FIFTY THREE THOUSAND SEVEN HUNDRED NINETY (\$53,790.00)**, and other good and valuable considerations to the undersigned grantor (whether one or more), in hand paid by grantee herein, the receipt whereof is acknowledged, we, **Candi Jamella Mitchem, a married woman** (herein referred to as **Grantor**) grant, bargain, sell and convey unto **Christopher Dale Robertson and Rachel Lynn Robertson** (herein referred to as **Grantees**), the following described real estate, situated in: **SHELBY** County, Alabama, to-wit:

PARCEL 1

A parcel of land situated in the NE ¼ of Section 9 and the NW ¼ of Section 10, all in Township 21 South, Range 1 East, Shelby County, Alabama, and being more particularly described as follows:

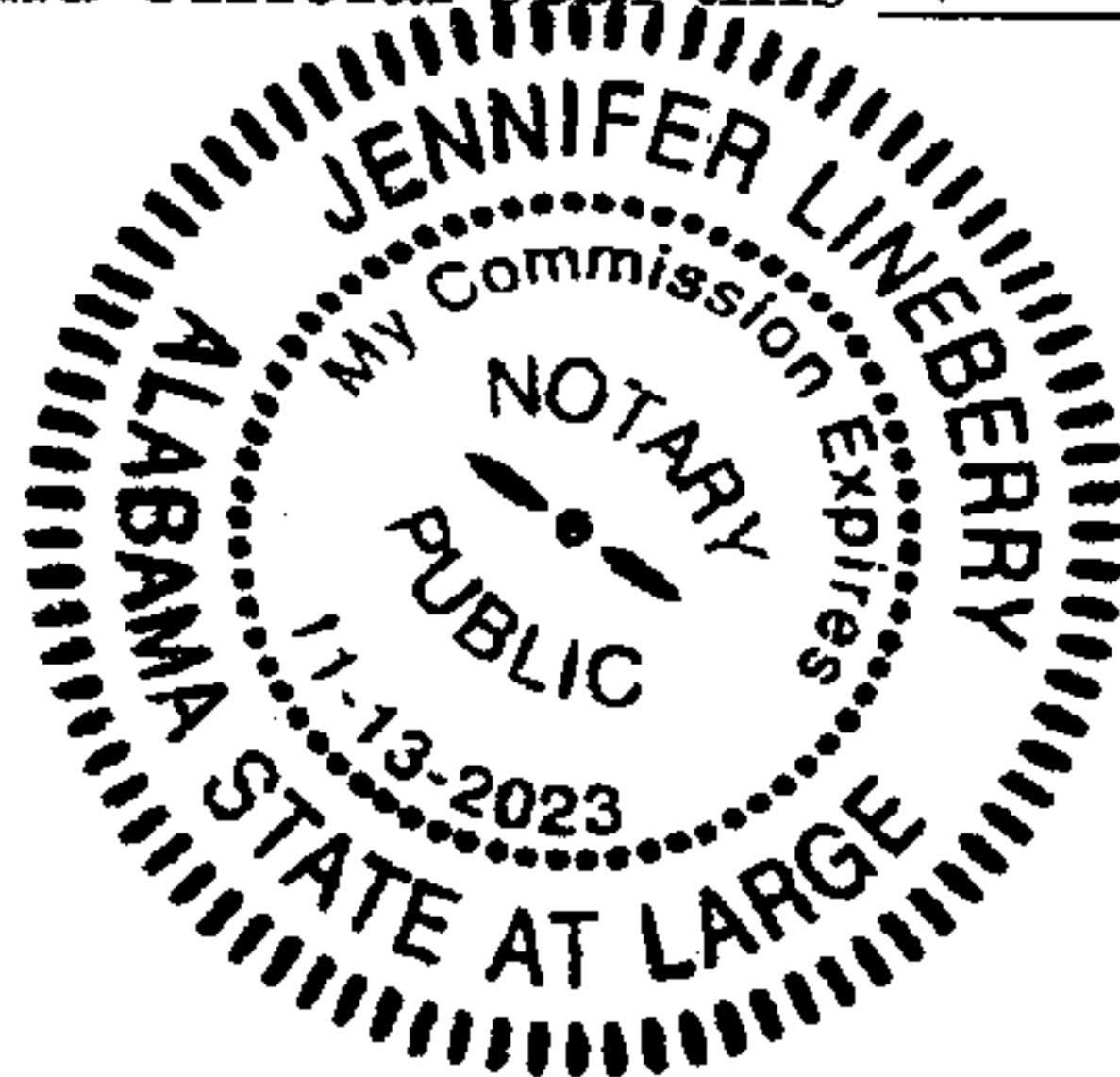

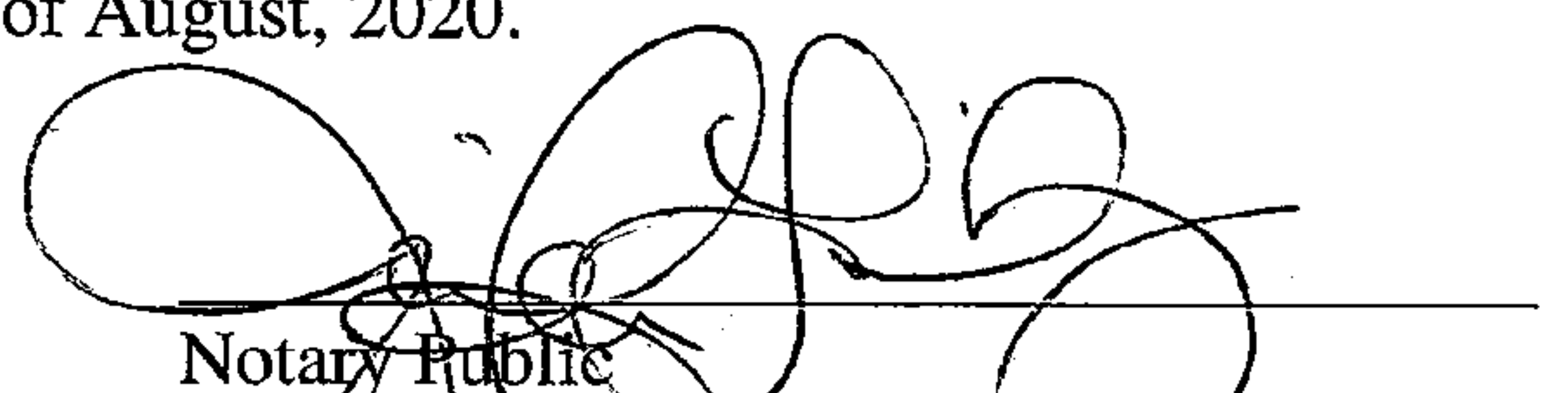
