MEMORANDUM OF THIRD AMENDMENT OF COAL MINING LEASE

KNOW ALL MEN BY THESE PRESENTS, that Camellia Met Mining, LLC (the "Lessee"), a Delaware limited liability company, by virtue of a Coal Mining Lease dated April 3, 2012 (the "Lease") is the successor lessee to a lease of certain rights to mine the Helena Seam of coal by underground mining methods as may exist in certain lands located in Shelby County, Alabama from **RGGS LAND & MINERALS, LTD., L.P.**, a Delaware limited liability company, successors to United States Steel Corporation who was successor by conversion to United States Steel LLC and remote successor to USX Corporation, which Lease was amended by that certain First Amendment to Coal Mining Lease dated September 13, 2010 and by that certain Second Amendment to Coal Mining Lease dated April 26, 2017.

This Memorandum of Third Amendment of Coal Mining Lease is placed of record by Lessor and Lessee to serve as notice of the execution and existence of the Third Amendment of Coal Mining Lease, and is in no way to supersede, abrogate, change or modify any of the terms, conditions, rights or obligations of any of the parties, all of which are set forth in detail in said Lease. The Third Amendment of Coal Mining Lease provides for the removal from the Premises of the Lease the lands described on Exhibit A and shown on the map labeled Exhibit B, both attached hereto and made a part hereof along with other terms and conditions that are personal to the Lessor and Lessee. Except as modified or amended by the Third Amendment to Coal Mining Lease, all other terms and conditions of the Lease including the right to further extend the term of the Lease subject to certain performance shall remain unchanged and in full force and effect. The terms and conditions of said Lease are made a part hereof by reference for all purposes, to be the same effect as though written in extenso herein.

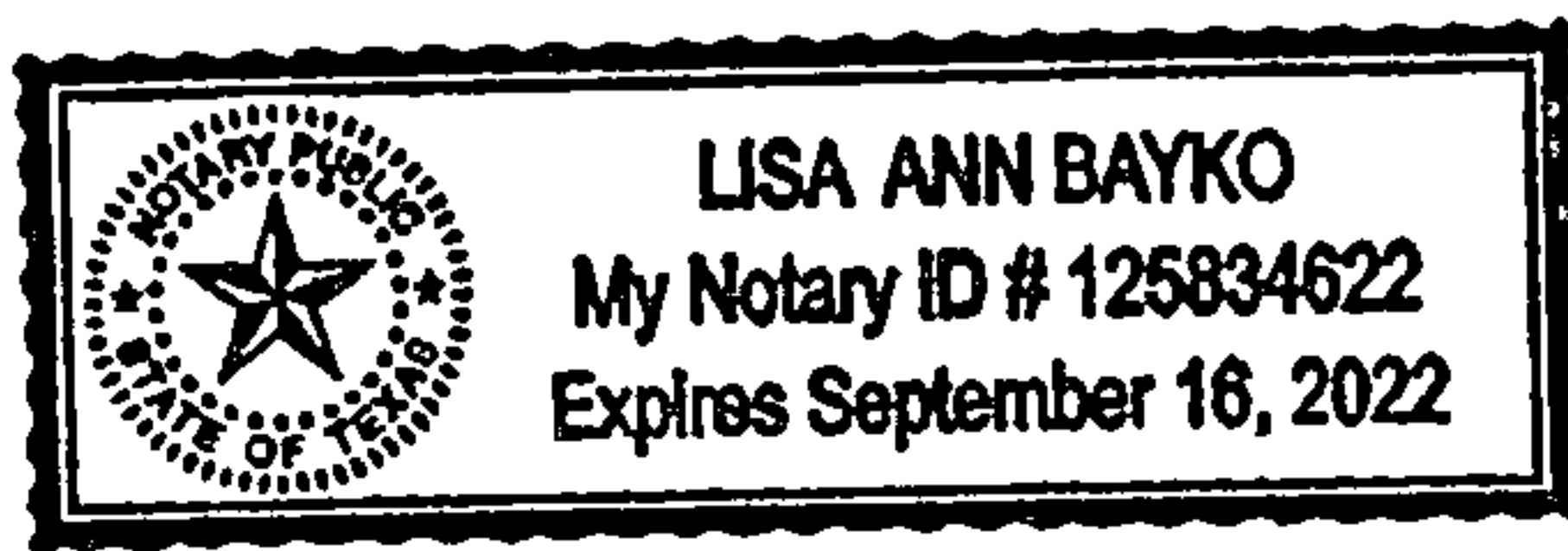

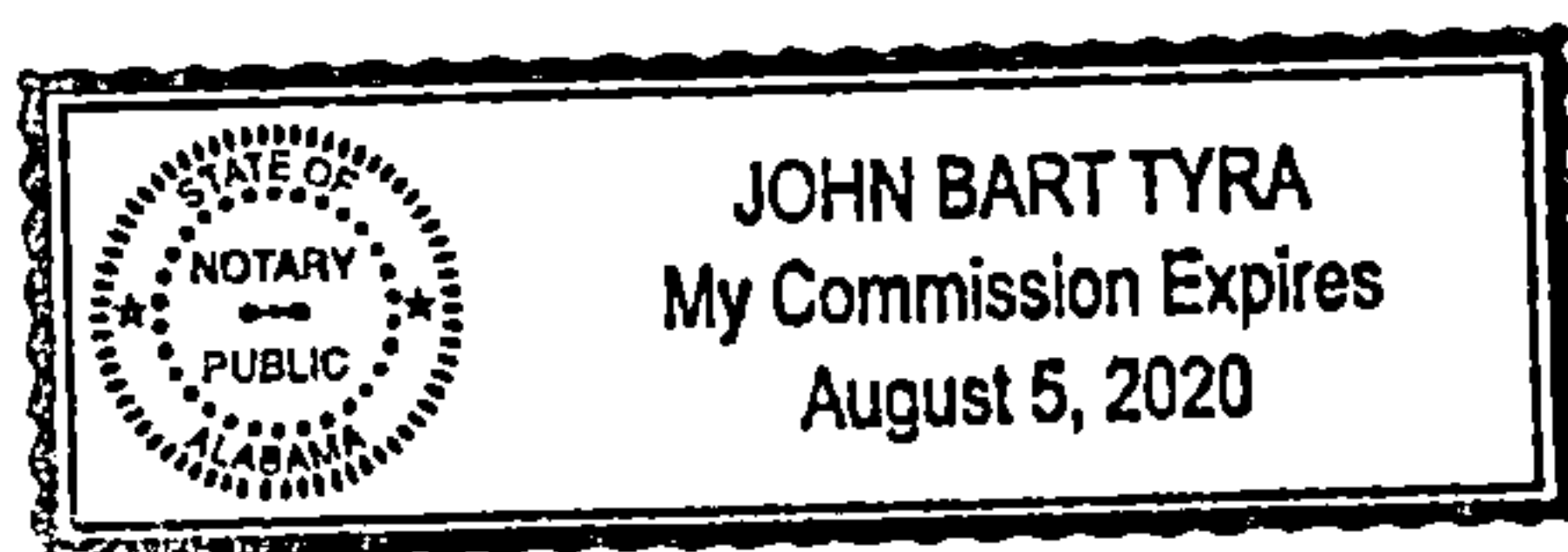

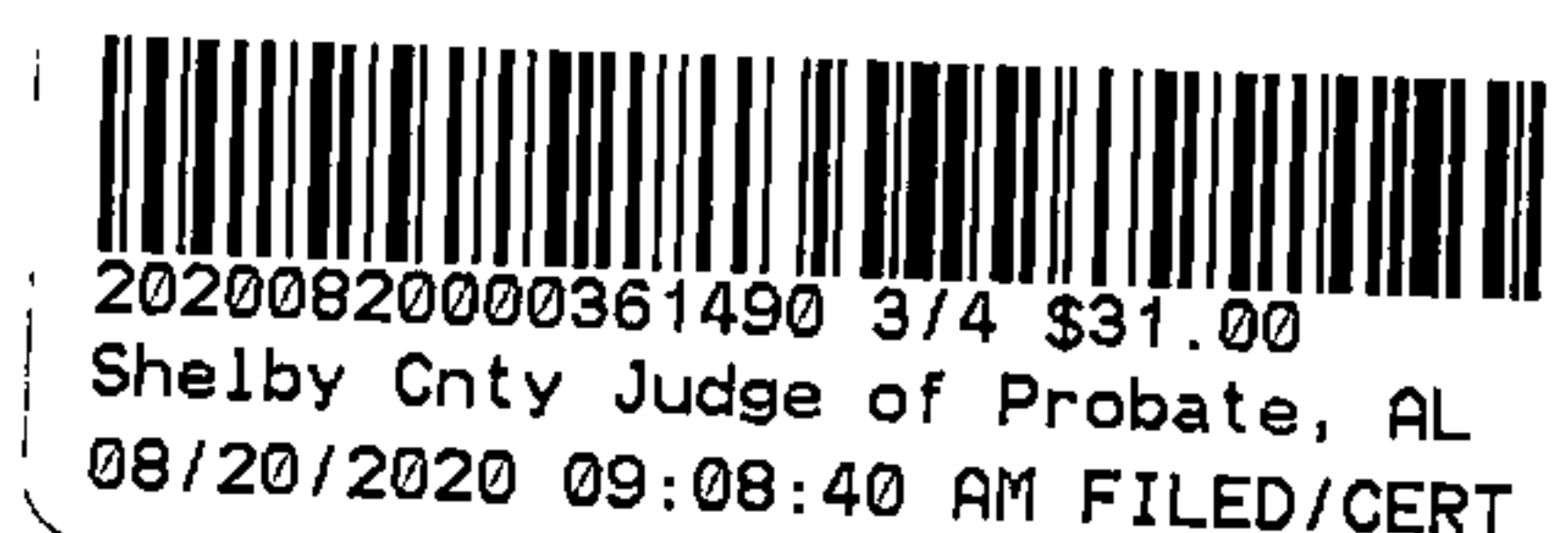

8960 Acres

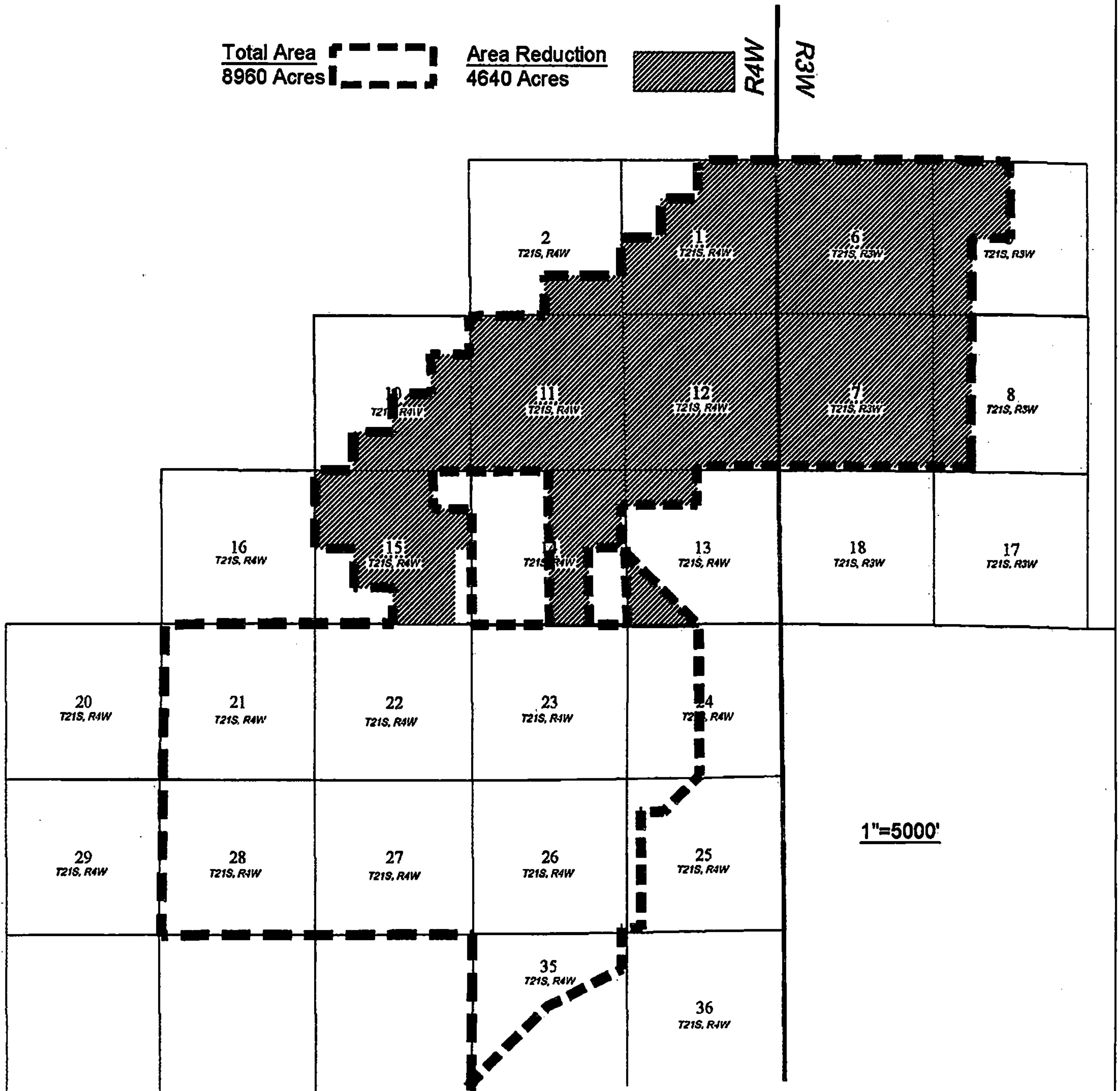


Area Reduction
