ANNA LEIGH WEBB LAMB IS ONE AND THE SAME AS ANNA LEIGH WEBB AS SHOWN ON TITLE.



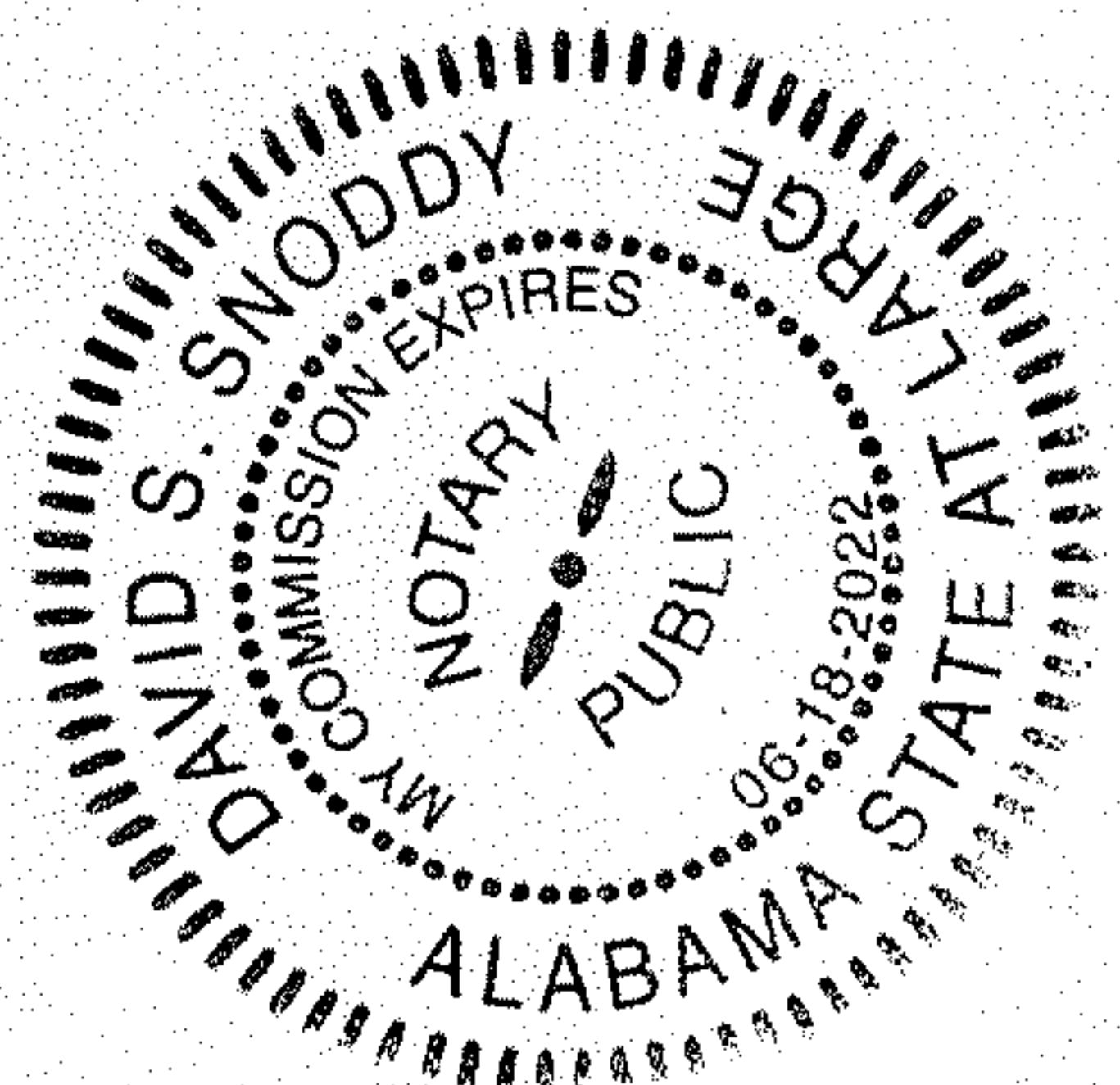
