WITNESSETH THAT:



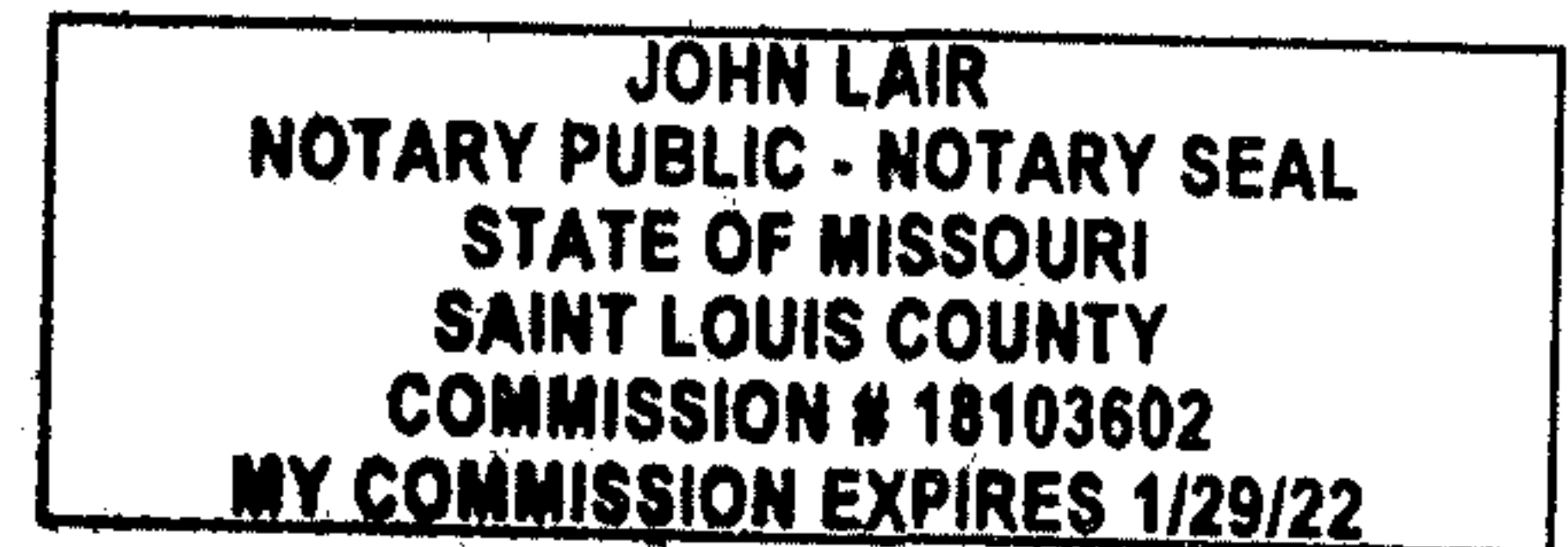
