

Larsen Revocable Living Trust under Trust Agreement Dated October 9, 2015, and further states as follows:

1. The Kevin L. Larsen and Sondra L. Larsen Revocable Living Trust under Trust Agreement Dated October 9, 2015, is a valid, existing trust, having been created by that Declaration of Trust dated October 9, 2015.
2.
 - A. The original Grantors of the trust are Kevin L. Larsen and Sondra L. Larsen.
 - B. The following persons contributed money, funds, real property, or personal property to the trust: Kevin L. Larsen and Sondra L. Larsen.
 - C. The Grantors of the trust and the contributors to the trust are living.
 - D. The name and address of the currently acting Trustees are Kevin L. Larsen and Sondra L. Larsen, whose address is 420 Allatoona Trail, Woodstock, GA 30189.
 - E. The named successor Trustees are Kevin L. Larsen and Sondra L. Larsen.
3. The Kevin L. Larsen and Sondra L. Larsen Revocable Living Trust under Trust Agreement Dated October 9, 2015, has a definite beneficiary.
4. The administrative and/or managerial powers of the Trustees are broad and flexible, and include the right to manage all property of the trust.
5.
 - A. The trust is revocable during the lifetime of Kevin L. Larsen and Sondra L. Larsen.
 - B. The persons holding the power to revoke the trust are Kevin L. Larsen and Sondra L. Larsen.


6. The conditions for the succession of the successor Trustee are the resignation, incapacity or death of the primary Trustee.


