Ordinance 2020-04

AN ORDINANCE OF THE TOWN OF HARPERSVILLE, PROVIDING THAT THE CODE OF ORDINANCES, TOWN OF HARPERSVILLE, ALABAMA, BE AMENDED BY ADDING A SECTION TO BE NUMBERED 2020-04 PROVIDING THE FOLLOWING AMENDMENT TO THE ZONING ORDINANCE:

BE IT ORDAINED BY THE TOWN COUNCIL OF THE TOWN OF HARPERSVILLE, ALABAMA AS FOLLOWS:

Section 1. The rezoning of property located south of Farmingdale Estates Subdivision on Shelby County Road 444 changing the present zoning A-1 (Agricultural District) to RG (Garden Home Residential District).

Applicant: SDH Birmingham LLC

Legal Description is attached as Exhibit A.

- Section 2. Any ordinance or resolution in conflict herewith is repealed as of the effective date of this Ordinance.
- Section 3. This Ordinance shall become effective upon its passage and publication or posting as required by law.
- Section 4. The sections, subsections, paragraphs, sentences, clauses, and phrases of this Ordinance are severable. If any section, subsection, paragraph, sentence, clause, or phrase of this Ordinance is declared unconstitutional or invalid by a valid judgement of a court of competent jurisdiction, such judgment shall not affect the validity of any other section, subsection, paragraph, sentence, clause, or phrase of this Ordinance. The town council declares it is its intent it would not have enacted this Ordinance with such invalid or unconstitutional provisions.

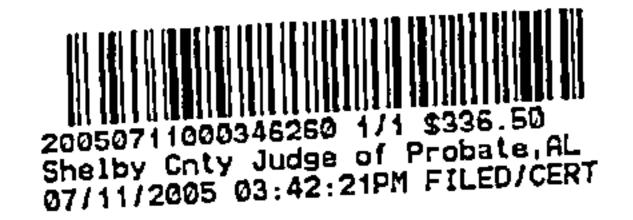

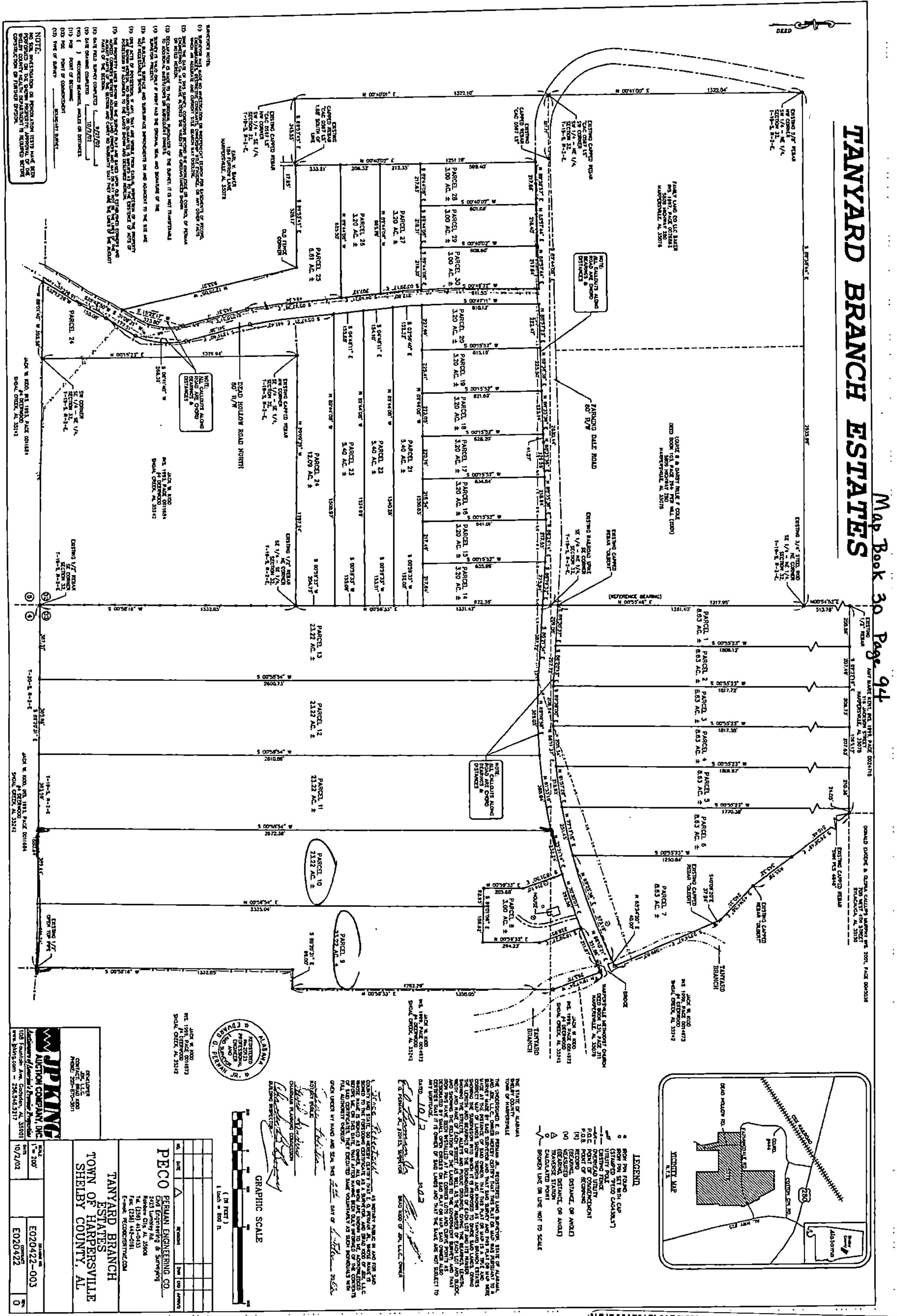
