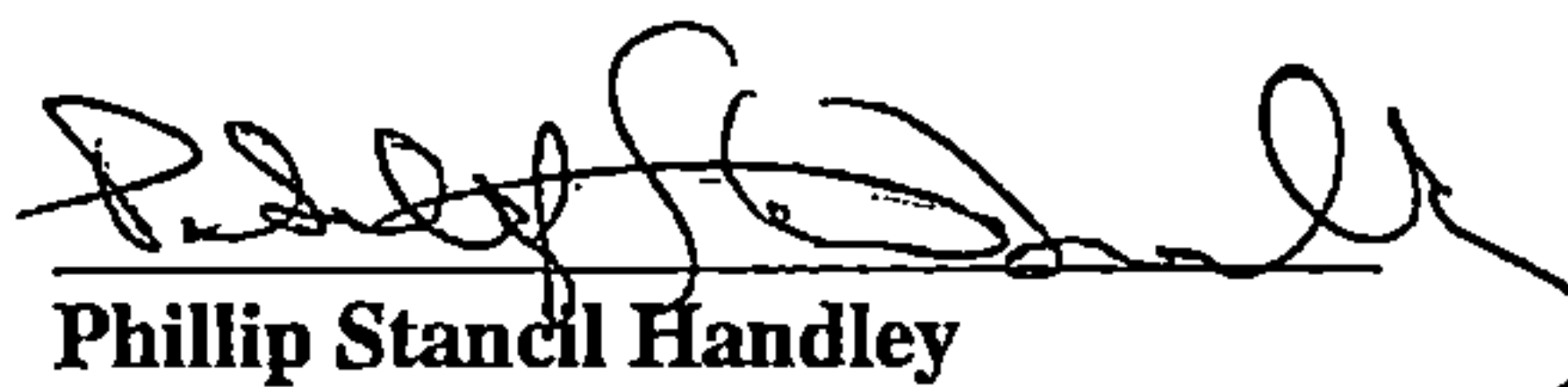
PARCEL 6:

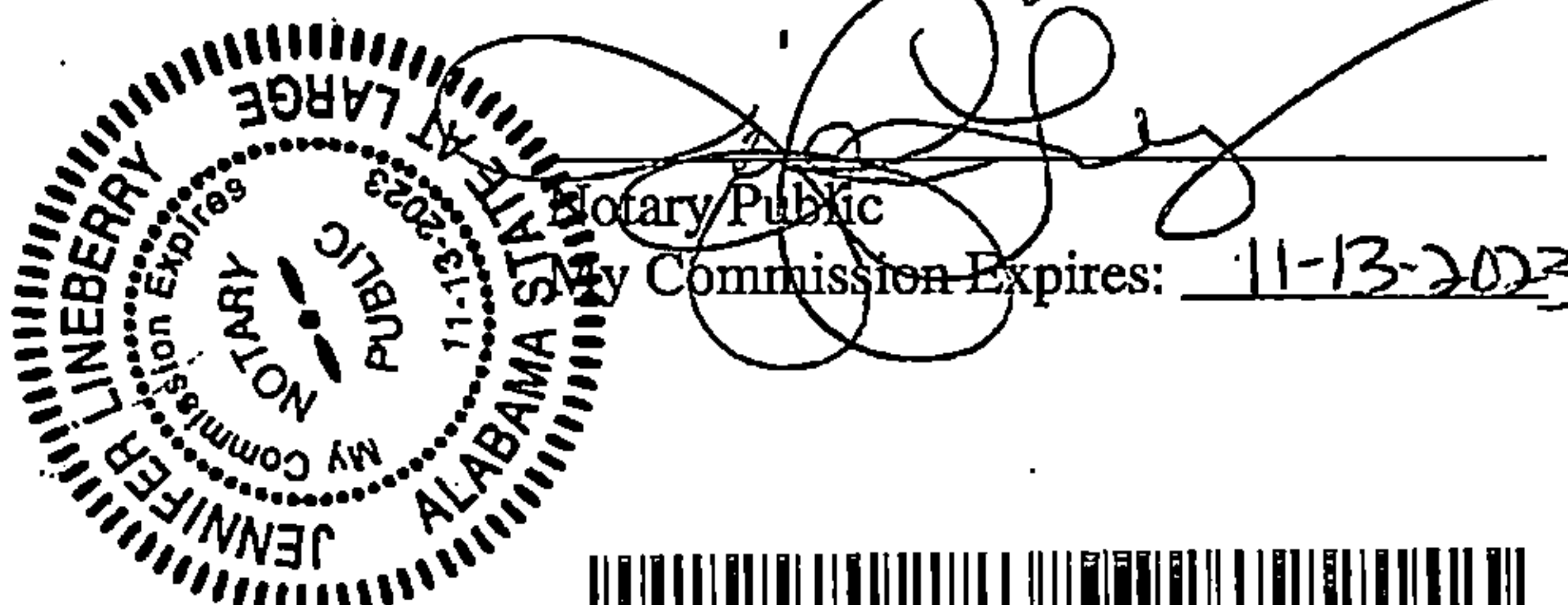
