That in consideration of the sum of **Six Hundred Twenty Thousand Dollars and No Cents (\$620,000.00)**, the amount of which can be verified in the Sales Contract between the parties hereto, to the undersigned Grantor (whether one or more), in hand paid by the Grantee herein, the receipt whereof is acknowledged, I or we, **Nancy G. Crowder, a single woman** (herein referred to as Grantor, whether one or more), grant, bargain, sell and convey unto **Terry R. Hosmer and Rebekah L. Hosmer**, (herein referred to as Grantee, whether one or more), the following described real estate, situated in Shelby, County, Alabama; to wit;

Lot 4AA, according to the Final Plat of a Resurvey of Lots 3A and 4A, as recorded as a Resurvey of Lots 2 and 3, Oak Harbour, Phase I, Map Book 28, Page 53, and a Resubdivision of Lot 4A, as recorded as a resubdivision of Lots 4 through 8, Oak Harbour, Phase I, Map Book 34, Page 62, recorded in Map Book 36, Page 14, in the Probate Office of Shelby County, Alabama.

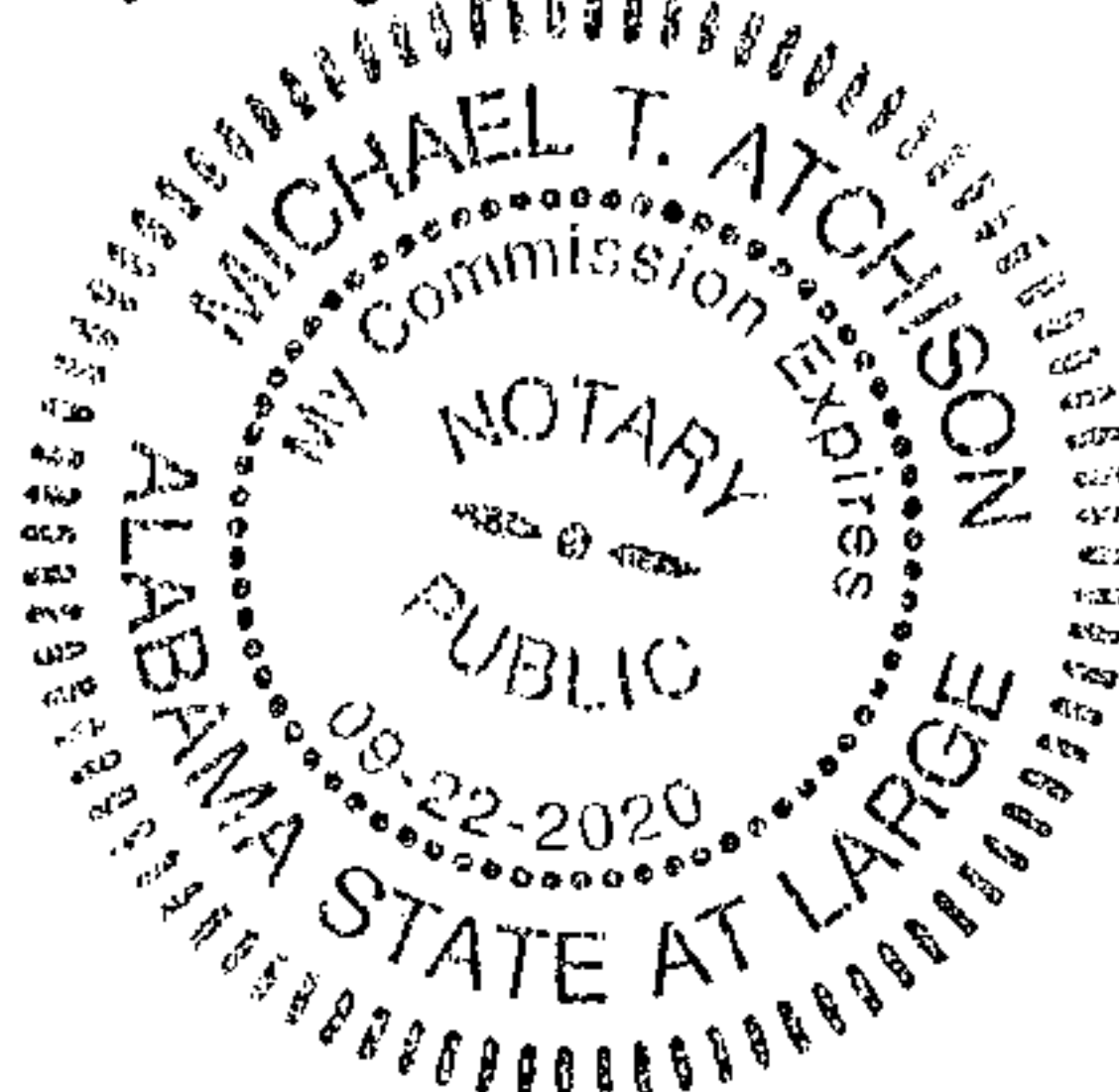
