WARRANTY DEED WITH JOINT RIGHT OF SURVIVORSHIP

KNOW ALL MEN BY THESE PRESENTS,

On this September 3, 2020, That for and in consideration of **THREE HUNDRED EIGHTY ONE THOUSAND AND NO/100 (\$381,000.00) DOLLARS**, and other good and valuable consideration, this day in hand paid to the undersigned GRANTOR **FRANCES K. ROBERTSON, an unmarried person**, (herein referred to as "Grantor"), in hand paid by the Grantees herein, the receipt whereof is hereby acknowledged, the Grantor does hereby give, grant, bargain, sell and convey unto the Grantees, **BILLY H. ROBERTS and PHYLLIS J. ROBERTS**, (herein referred to as "Grantees"), for and during their joint lives and upon the death of either, then to the survivor of them in fee simple, together with every contingent remainder and right of reversion, all of the Grantor's interest in the following-described Real Estate situated in, **SHELBY COUNTY, ALABAMA**, to wit:

Lot 2678, according to the Survey of Weatherly Highlands, The Ledges, Sector 26, Phase Three, as recorded in Map Book 38, Page 71 A, B & C, in the Probate Office of Shelby County, Alabama.

Subject to:

1. General and special taxes or assessments for the year 2020 and subsequent years not yet due and payable.-
2. Municipal improvements, taxes, assessments, and fire district dues against subject property, if any.
3. Mineral and mining rights not owned by Grantor.
4. Any applicable zoning ordinances.

8. Restrictions and Covenants appearing of record in Inst. No. 2000-14750 and Inst. No. 2011-6376.

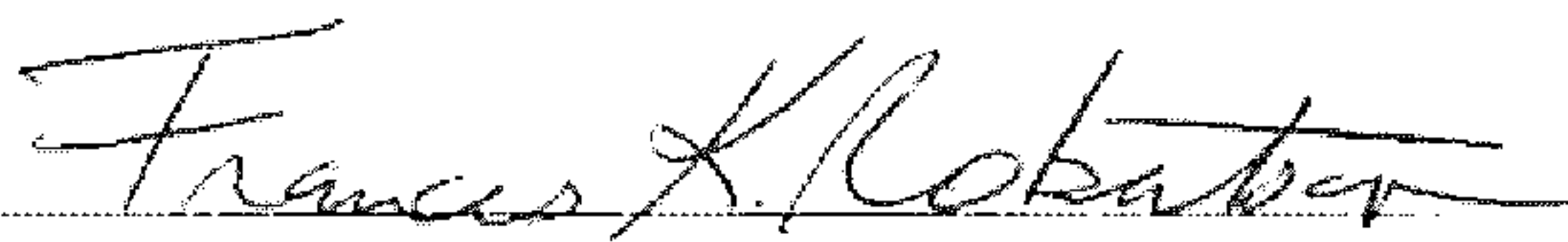
The purchase of the herein described real property is being financed in whole or in part by the proceeds of a purchase money mortgage being executed simultaneously herewith.

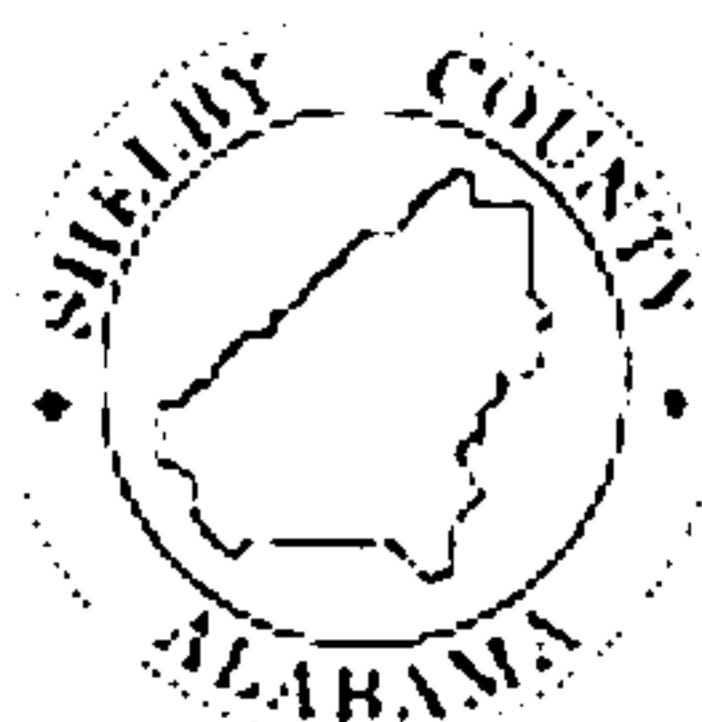
