Know All Men by These Presents: That in consideration of **One Hundred Eighty-Thousand Eight Hundred Fifty-Five and 00/100 Dollars (\$180,855.00)**, to the undersigned Grantor, in hand paid by the Grantees herein, the receipt where is acknowledged, **SDH BIRMINGHAM, LLC** (herein referred to as Grantor) grant, bargain, sell and convey unto **CAITLIN MICHELLE WHITE and QUINTERRIUS TYREE MONTGOMERY** (herein referred to as Grantees), the following described real estate, situated in **SHELBY** County, Alabama, to-wit:

To Have and to Hold to the said Grantees, as joint tenants, with right of survivorship, their heirs and assigns forever; it being the intention of the parties to this conveyance, that (unless the joint tenancy created is severed or terminated during the joint lives of the Grantees herein) in the event one Grantee herein survives the other, the entire interest in fee simple shall pass to the surviving Grantee, and, if one does not survive the other, then the heirs and assigns of the Grantees herein shall take as tenants in common.

And the Grantor does for itself, its successors and assigns, covenant with said Grantees, their heirs and assigns, that it is lawfully seized in fee simple of said premises; that it is free from all encumbrances, unless otherwise stated above; that it has a good right to sell and convey the same as aforesaid; that it will and its successors and assigns shall warrant and defend the same to the said Grantees, their heirs and assigns forever, against the lawful claims of all persons.

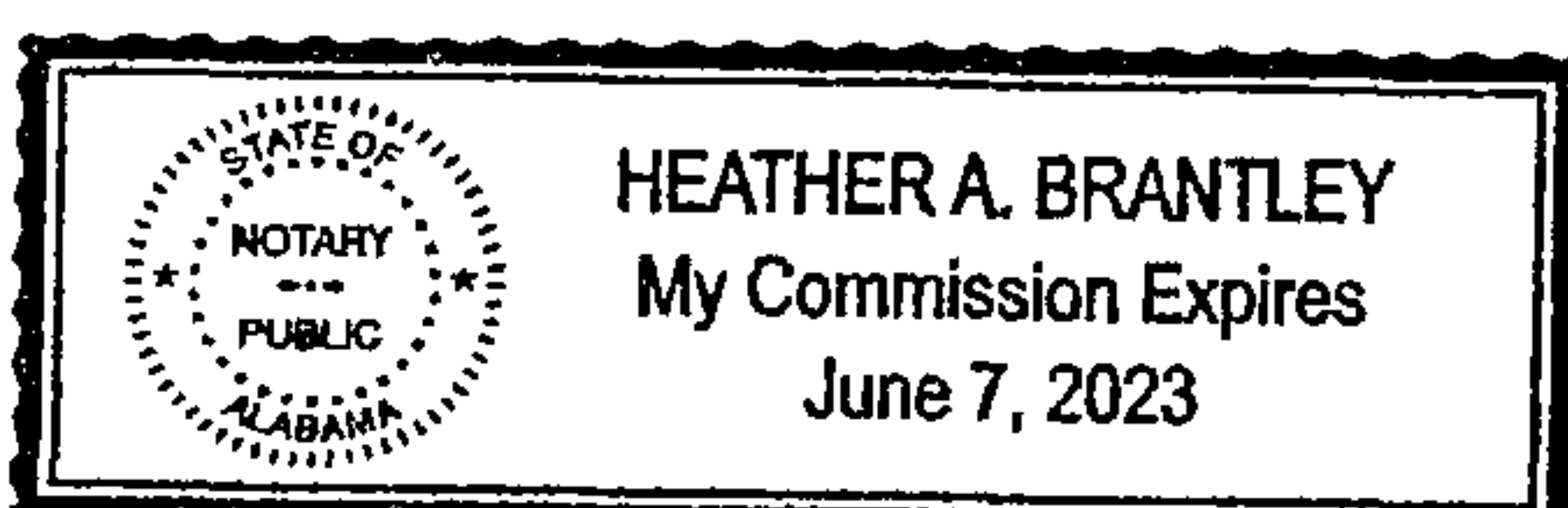



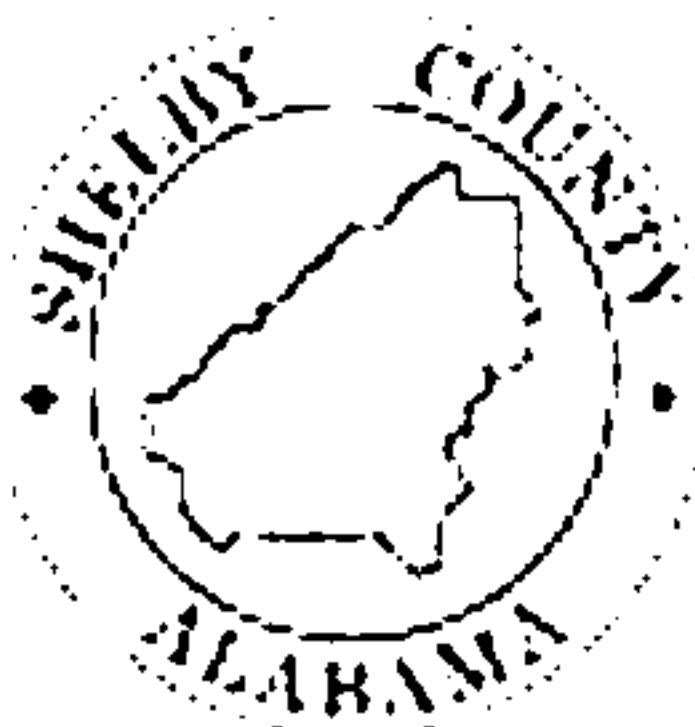
