Know All Men by These Presents: That in consideration of **Two Hundred Fifty-One Thousand Five Hundred Fifty and 00/100 Dollars (\$251,550.00)**, to the undersigned Grantor, in hand paid by the Grantees herein, the receipt where is acknowledged, **SDH BIRMINGHAM, LLC** (herein referred to as Grantor) grant, bargain, sell and convey unto **NICHOLAS SHEA SCHOGGEN and GUDRID SCHOGGEN** (herein referred to as Grantees), the following described real estate, situated in **SHELBY** County, Alabama, to-wit:

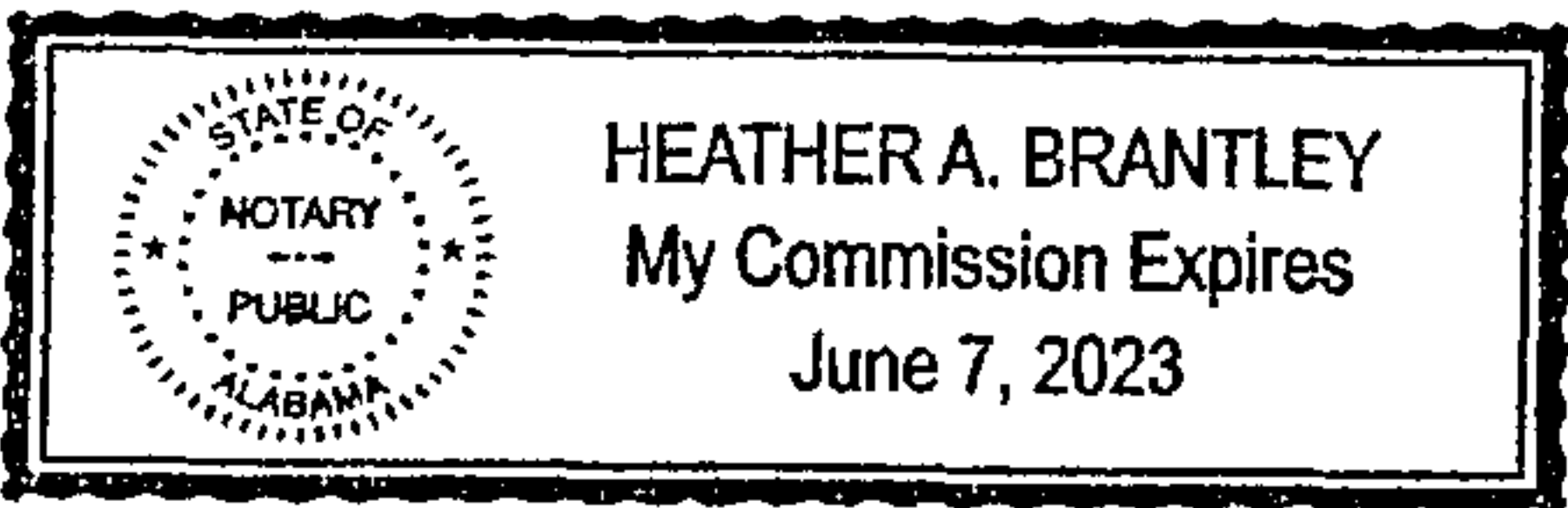

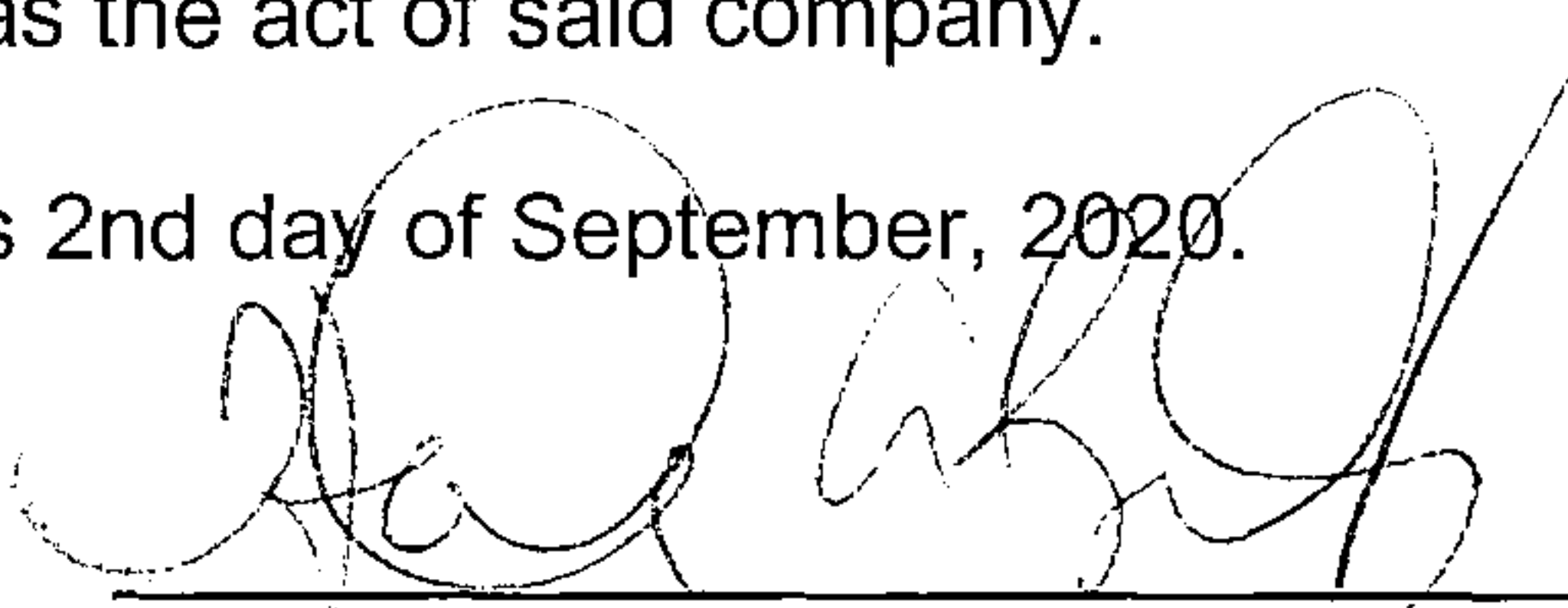

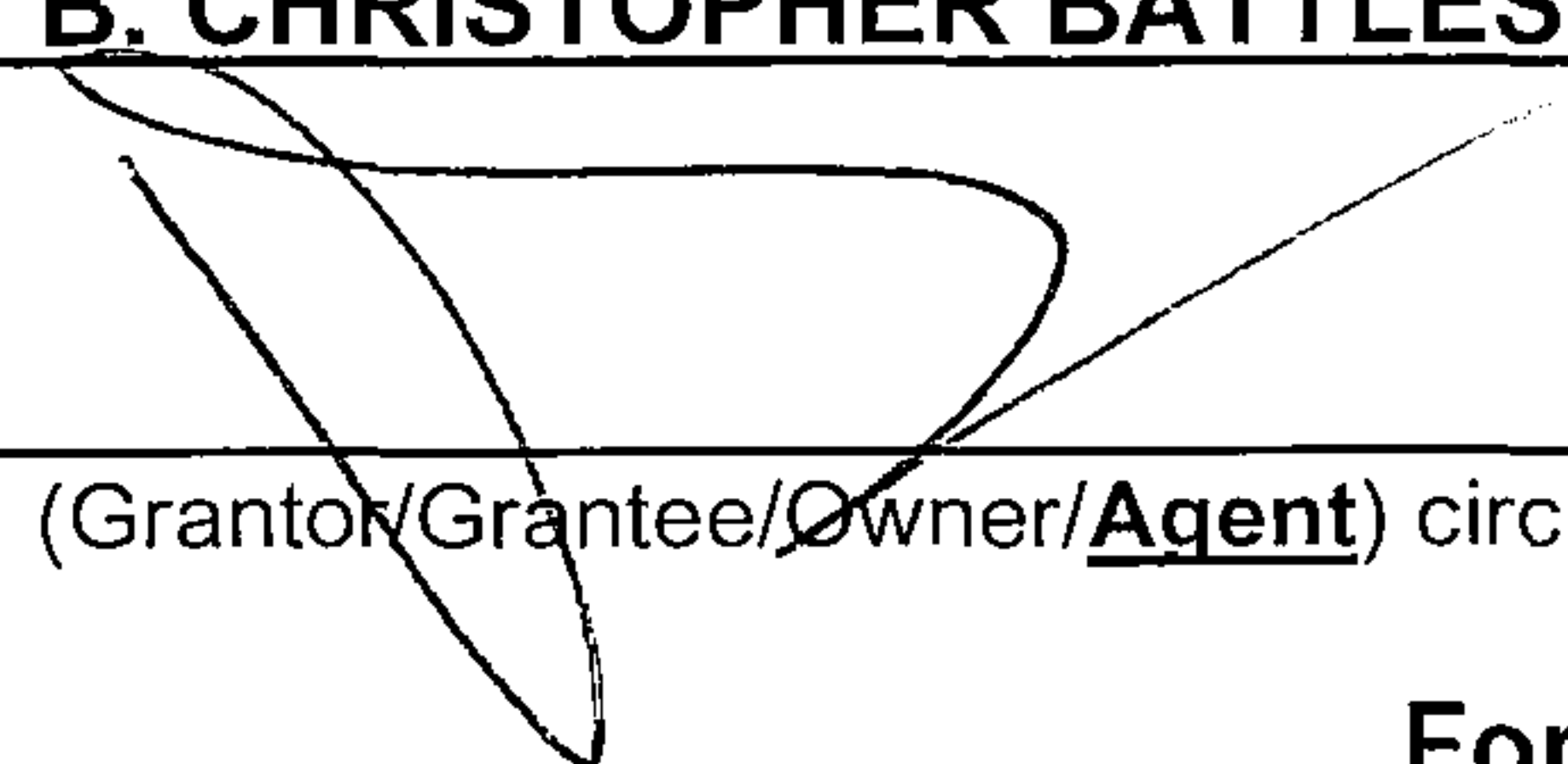
