


Last Will and Testament

I, **Linda R. Castleberry**, of Shelby County, Alabama, being of sound mind and disposing memory, do hereby make and publish this as my Last Will and Testament, hereby revoking any and all former wills or codicils, if any, heretofore made by me:

ITEM ONE: It is my desire and I hereby direct that all of my just and legal debts, including my funeral expenses and the expenses of my last illness, be paid out of my estate as soon after my death as may be practicable and convenient.

ITEM TWO: Including the specific property described hereinbelow in ITEM THREE, I hereby give, devise, and bequeath all property to which I may own at the time of my death, or in which I may have an interest, real, personal or mixed, and wherever situated, to **Brian Randall Castleberry** and **Alan Reid Castleberry**, in equal shares, per stirpes. If any of them should predecease me, then the share to which such person would have been entitled shall go to the descendants of such person, if any, and if none, then to the survivors.

ITEM THREE: I leave my interest in the Hueytown Plaza property, said property being more particularly described in the legal description attached to this, my Last Will and Testament, as Exhibit A and incorporated by reference as if fully set out herein, to **Brian Randall Castleberry** and **Alan Reid Castleberry** in equal shares, per stirpes. If either of them should predecease me, then the share to which such person would have been entitled shall go to the descendants of such person, if any, and if none, then to the survivor(s).

ITEM FOUR: I hereby nominate and appoint my son, **Alan Reid Castleberry**, as executor of this my Last Will and Testament. I hereby relieve and exempt my personal representative from making bond and also from the filing of any accounts, appraisals, inventories, or settlements in any court pertaining to the administration of my estate. I hereby

give my personal representative the power and authority to sell, if necessary to the administration of my estate, any real, personal, or mixed property of my estate at public or private sale at representative's discretion, and to execute all deeds, mortgages, powers of attorney, assignments, releases, and any other documents in connection with the administration of my estate without having to obtain approval of any court. If a public sale, my personal representative may be the purchaser if the highest bidder therefore.

I, the undersigned testator, sign my name to this instrument on this the 10th day of September, 2020, and being first duly sworn, do hereby declare to the undersigned authority that I execute it as my Last Will and Testament and that I sign it willingly, that I execute it as my free and voluntary act for the purposes therein expressed, and that I am nineteen years of age or older, of sound mind, and under no constraint or undue influence.






EXHIBIT A

Begin at the southwest corner of the NW 1/4 of the NE 1/4 of Section 30, T-18-S, R-4-W thence run north along the west line of said 1/4-1/4 section for 336.08 feet; thence 91 degrees 27 minutes right and run east for 720.0 feet; thence 88 degrees 27 minutes right and run south for 200 feet; thence 91 degrees 33 minutes right and run west for 25 feet; thence 91 degrees 34 minutes left and run south for 136.35 feet to a point on the south line of said 1/4-1/4 section for 695.89 feet to the point of beginning.
