

Last Will and Testament of

Charles Edward Hyde

I, Charles Edward Hyde, a resident of Montevallo, Shelby County, Alabama, being of sound mind and disposing memory and over the age of eighteen (18) years, and not being actuated by any duress, menace, fraud, mistake, or undue influence, do make, publish, and declare this to be my Last Will and Testament, hereby expressly revoking any and all Wills and Codicils previously made by me.

ITEM I

I direct that my Executor, hereinafter named, shall pay from my estate, with equitable apportionment, any lawful debts, the expenses of administering my estate, estate taxes and other taxes due at the time of my death which shall become payable by reason of my death, whether in respect to property passing under this Will or otherwise, as soon after my death as practical. I further direct that any debts on any real property bequeathed in this Will shall be assumed by the person to receive such real property and not paid by my Executor, nor out of my residual estate.

ITEM II

I hereby appoint my wife, Judith Carolyn Hyde, to be the Executor of this Will. My Executor shall be authorized to carry out all provisions of this Will and pay my just debts, obligations and funeral expenses as soon after my death as practical. Should my wife, Judith Carolyn Hyde, be unwilling or unable to serve as Executor, I hereby appoint my son, Eddie Glen Hyde, to be the Alternate Executor. The term "Executor" in this Will is synonymous with and includes the terms "Personal Representative", Administrator and Executrix without regard to gender.

ITEM III

My Executor and alternate Executor shall serve without bond and no security of any kind shall be required of any Executor. I hereby waive the necessity of preparing or filing any inventory, accounting, appraisal, reporting, approvals or final appraisement of my estate. I direct that no expert appraisal be made of my estate unless required by law. My Executor shall have any and all additional powers with respect to my estate, to be exercised from time to time at my Executor's discretion without further license or order of any court as allowable by Alabama law.

ITEM IV

I am married to Judith Carolyn Hyde and all references in this Will to my wife are references to her. I have two children, namely, Eddie Glen Hyde and Carol Lynn Hyde Caldwell.

ITEM V

In the event that my wife shall die simultaneously with me or there is no direct evidence to establish that my wife and I died other than simultaneously, I direct that I shall be deemed to have survived my wife, notwithstanding any provision of law to the contrary, and that the provisions of my Will shall be construed on such presumption.

ITEM VIII

I hereby will, give, devise and bequeath unto my son, Eddie Glen Hyde and my daughter, Carol Lynn Hyde Caldwell, my home place and real property where my wife and I currently reside, to be theirs evenly, share and share alike, per stirpes, Said real property being located at 5965 Hwy. 10, Montevallo, Alabama.

I hereby direct that my wife shall have full use, care and control of said home place and said real property until such time as my Estate is Probated and all property has been devised under said Probate.

In the event my wife desires to continue to reside in the above mentioned home, then, in that event, she has the absolute right to purchase from the devisees their share of said home place and said real property.

ITEM IX

I hereby will, give, devise, and bequeath all of the rest, residue, and remainder of my estate, of whatever kind and character, personal and real, and wherever located, including all of the contents of our home place, to my wife, Judith Carolyn Hyde, provided that she survives me. If my wife does not survive me, then I give, devise, and bequeath all of the rest, residue, and remainder of my estate, of whatever kind and character, and wherever located, to my two children, Eddie Glen Hyde and Carol Lynn Hyde Caldwell, share and share alike, per stirpes.
