That in consideration of **Six Hundred Twenty-Five Thousand and No/100 Dollars (\$625,000.00)** to the undersigned grantor(s) (whether one or more); in hand paid by the grantee(s) herein, the receipt and sufficiency of which is hereby acknowledged, I or we, **Eric Mumper and Heather Mumper, Husband and Wife** (herein referred to as grantor(s), whether one or more), grant, bargain, sell and convey to **Mohamed Awwad and Dalal Elkoubroussi**, hereinafter referred to as grantee(s), whether one or more), the following described real estate situated in Jefferson County, Alabama to-wit:



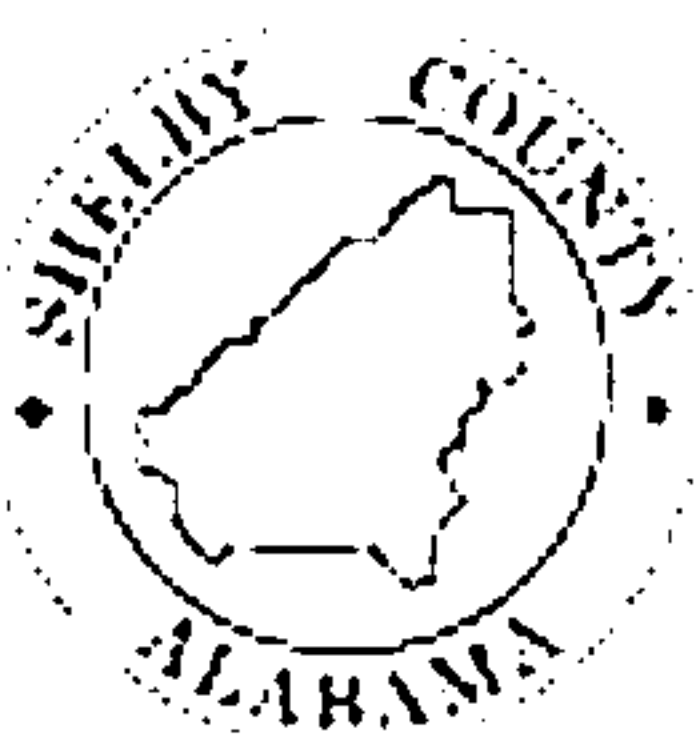
