CERTIFICATE OF FORMATION
OF
PIPER HOLDINGS, LLC

TO THE JUDGE OF PROBATE OF SHELBY COUNTY, ALABAMA:

The undersigned, for the purpose of forming a limited liability company under the Alabama Limited Liability Company Law of 2014 (the “Act”), hereby files the following Certificate of Formation with the Judge of Probate of the County in which the initial registered office of the limited liability company will be located and attests that the facts stated in this Certificate of Formation are true and correct:

ARTICLE I
NAME

The name of this entity (the “Company”) shall be: **PIPER HOLDINGS, LLC.**

ARTICLE II
TYPE

The Company is a limited liability company.

ARTICLE III
PURPOSES

The nature of the business of the Company and its objects, purposes and powers are as follows:

- (a) To manage, purchase or acquire by assignment, transfer or otherwise, and hold, mortgage or otherwise pledge, and to sell, exchange, transfer, deal in and in any manner dispose of, real or personal property of any kind, class, interest or type, wheresoever situated, and to exercise, carry out and enjoy any license, power, authority, concession, right or privilege which any limited liability company may make or grant in connection therewith; and

(b) In general, to carry on any other lawful business whatsoever in connection with the foregoing or which is calculated, directly or indirectly, to promote the interest of the Company or to enhance the value of its properties.

The enumeration herein of the powers, objects and purposes of the Company shall not be deemed to exclude or in any way limit by inference any powers, objects or purposes which the Company is empowered to exercise, whether expressly by purpose or by any of the laws of the State of Alabama or any reasonable construction of such laws.

ARTICLE IV
REGISTERED AGENT/OFFICE

The location and mailing address of the initial registered office of the Company shall be **133 Belcher Drive, Pelham, AL 35124**, and its registered agent at such address shall be **Shawn O'Brien**.

ARTICLE V
MEMBERS

There is at least one member of the Company. The member(s) of the Company (the "Members") reserve the right to admit additional Members upon the agreement of the Members as to the admission of, and the consideration to be paid by, such new Members, and subject to the terms and conditions of the Company's Operating Agreement.

ARTICLE VI
LIMITED LIABILITY COMPANY AGREEMENT



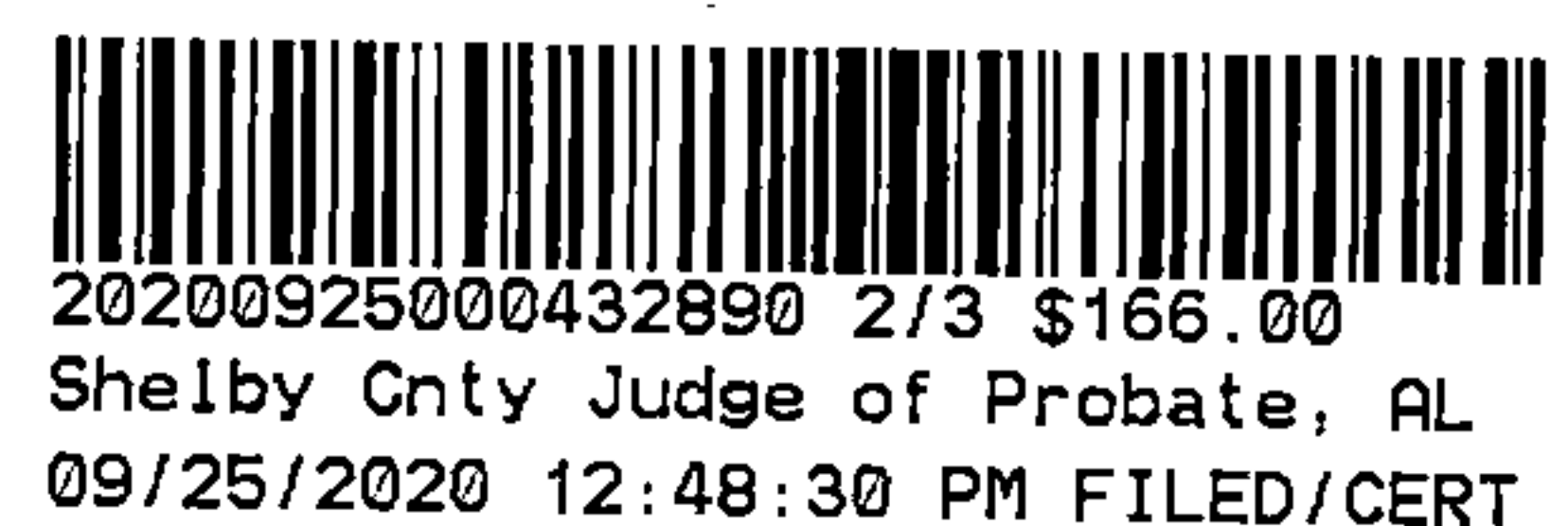
