KNOW ALL MEN BY THESE PRESENTS:

THAT IN CONSIDERATION OF **Eighty-Seven Thousand Five Hundred Dollars and NO/100 (\$87,500.00)** to the undersigned grantors, in hand paid by the Grantees herein, the receipt whereof is acknowledged, we, **Steven Craig Tuggle and Amanda Marie Tuggle, husband and wife**, (herein referred to as **Grantors**), grant, sell, bargain and convey unto, **Ronald N. Gully and Cheryl L. Gully** (herein referred to as **Grantees** whether one or more), for and during their joint lives as joint tenants with rights of survivorship and upon the death of either of them, then to the survivor of them in fee simple, together with every contingent remainder or right of reversion, the following described real estate, situated in Shelby County, Alabama to wit:

All that part of the E 1/2 of W 1/2 of SE 1/4 of NE 1/4 and the E 1/2 of W 1/2 of NE 1/4 of SE 1/4 of Section 23, Township 19 South, Range 1 East, lying South of old U. S. Highway 280.

Also, a piece of land in the E 1/2 of the NE 1/4 of the SE 1/4 of Section 23, Township 19 South, Range 1 East, described as follows, to-wit:

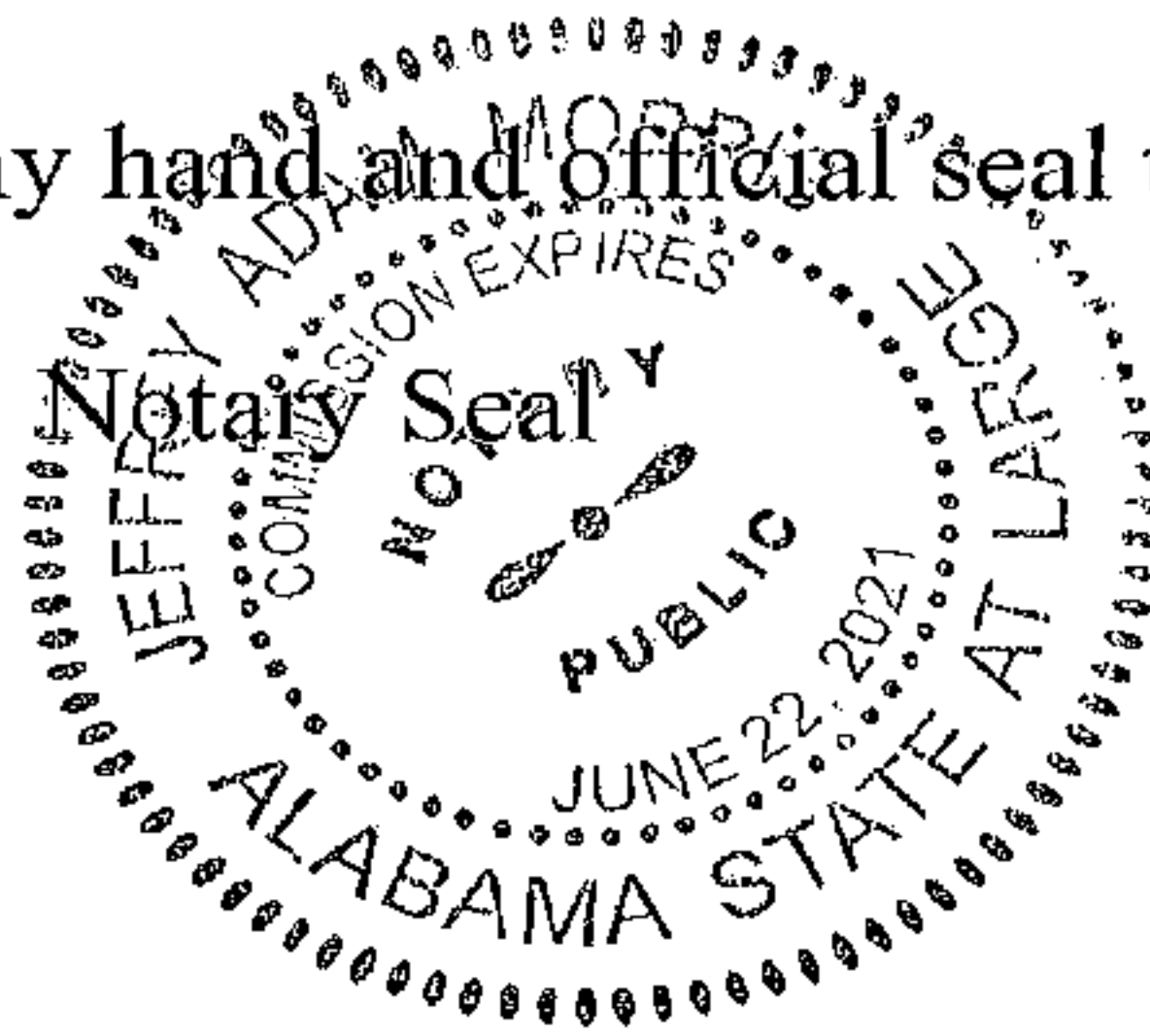

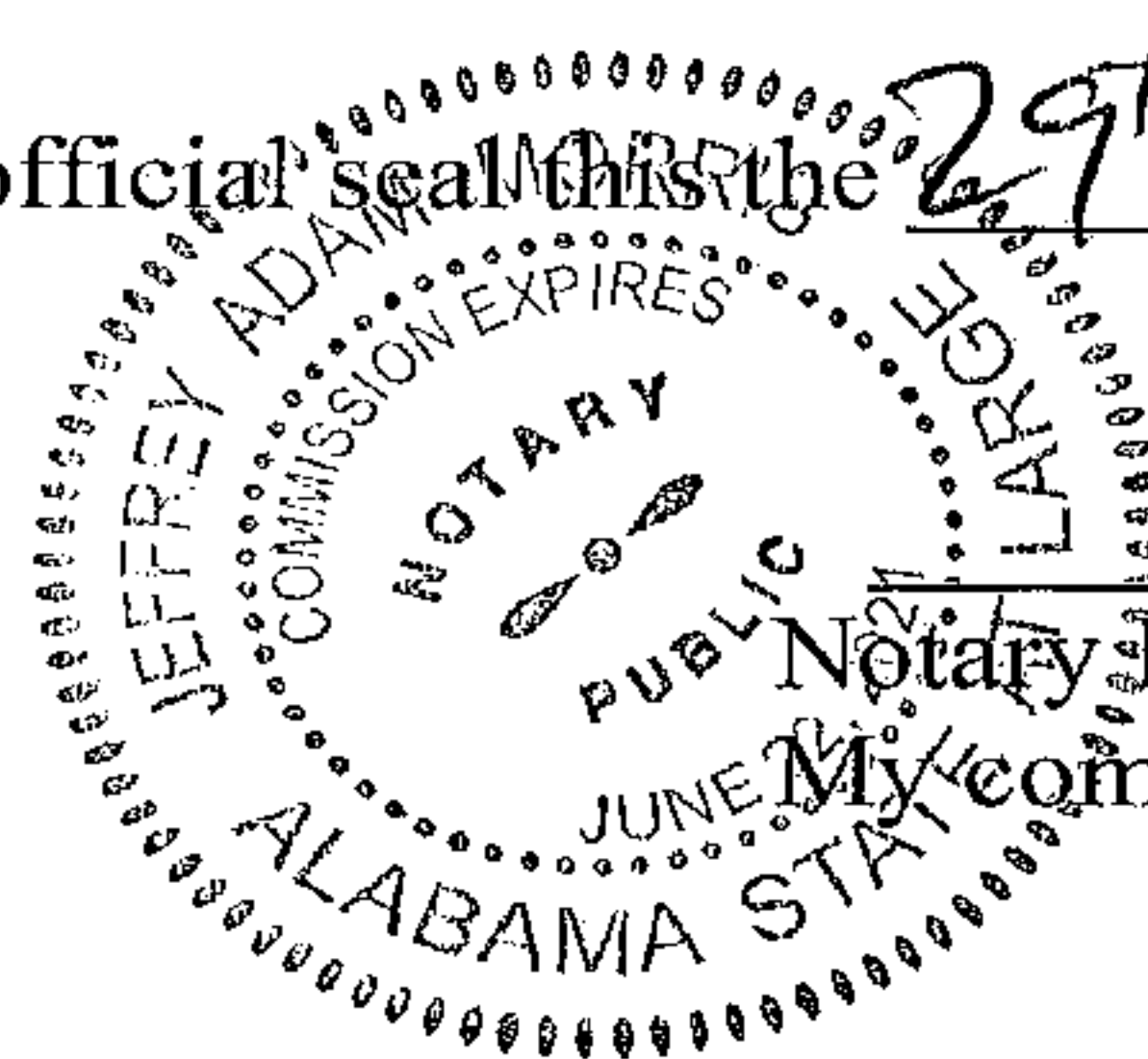
