


Subject to a third-party mortgage in the amount of \$257,050.00 executed and recorded simultaneously herewith.



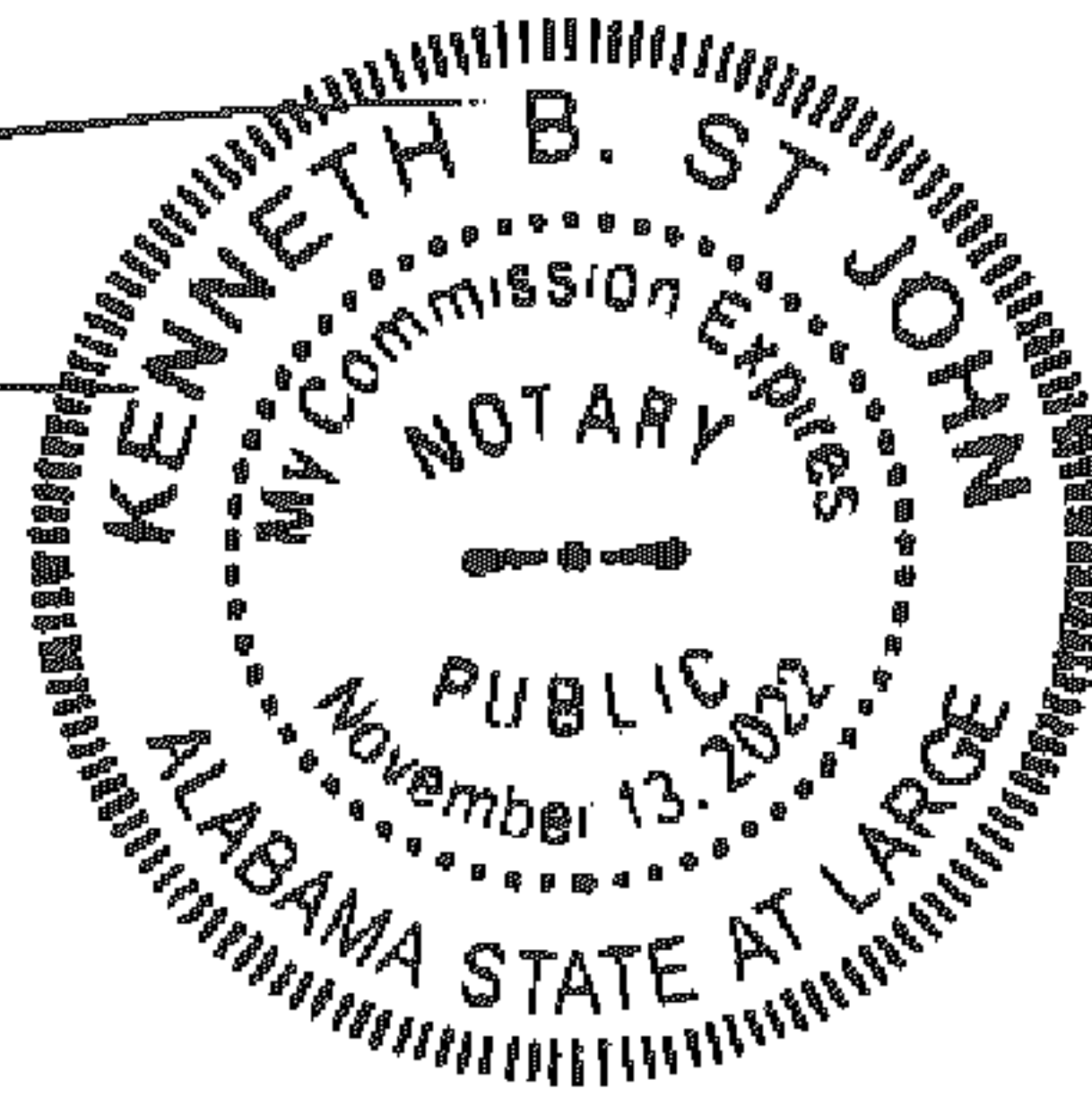
