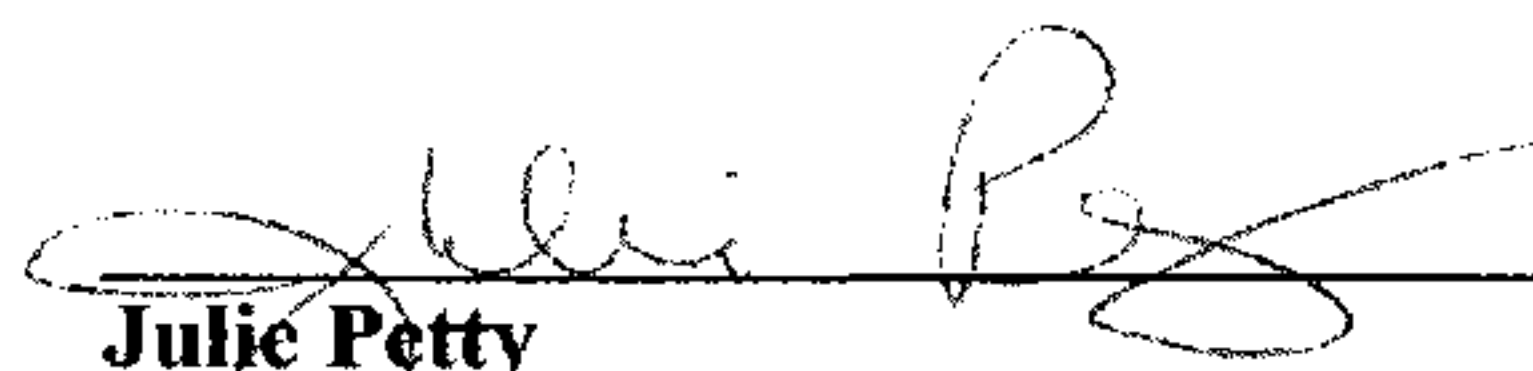
For ad valorem tax purposes only, the address for the above described property is 960 Haddington Dale, Pelham, AL 35124.

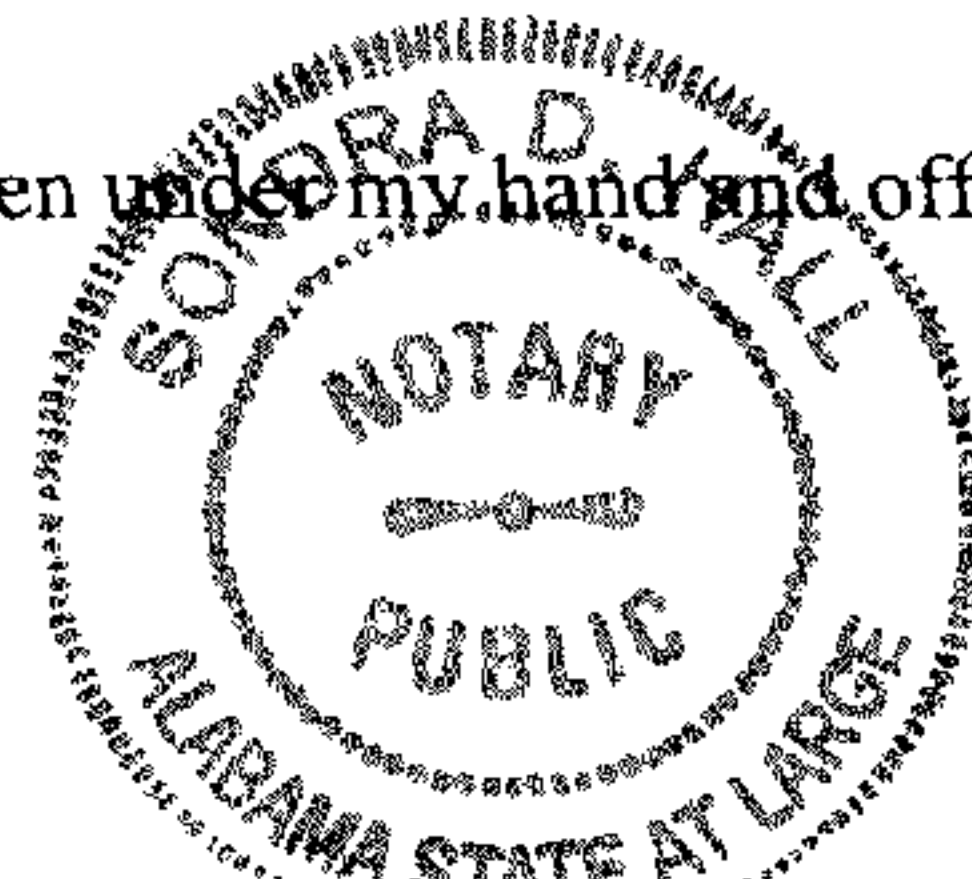

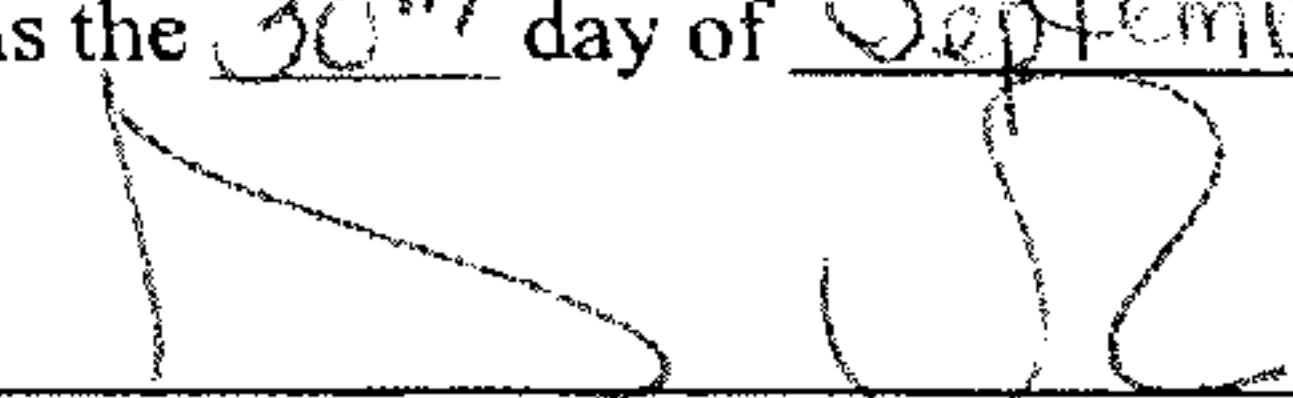
