**WARRANTY DEED**  
**Joint Tenancy With Right of Survivorship**

**KNOW ALL MEN BY THESE PRESENTS**, that in consideration of **One Hundred Seventy Nine Thousand Dollars and No Cents (\$179,000.00)** and other good and valuable consideration the receipt and sufficiency whereof is hereby acknowledged, **Tiffini Leigh Clemons Colvert and Tyler Colvert, wife and husband**, (herein referred to as GRANTOR) does by these presents grant, bargain, sell and convey unto **Charles David Murphy Jr and Ramona Lynn Murphy, husband and wife** (herein referred to as GRANTEE, whether one or more) as joint tenants with right of survivorship, the following described real estate situated in Shelby County, Alabama, to-wit:

Lot 105, according to the Survey of Reserve at Timberline, as recorded in Map Book 34, pages 117A, B, C & D, in the Probate Office of Shelby County, Alabama.



And said GRANTOR does for itself, its successors and assigns, covenant with said GRANTEES, their heirs and assigns, that it is lawfully seized in fee simple of said premises, that they are free from all encumbrances, that it has a good right to sell and convey the same as aforesaid, and that it will, and its successors and assigns shall, warrant and defend the same to the said GRANTEES, their heirs, executors and assigns forever, against the lawful claims of all persons.
