**AFFIDAVIT OF HEIRSHIP
OF

I, W. L. Landrum, whose address is 2281 Hillcrest Drive, Meridian, Mississippi 39301, represent that according to my best recollection that the information hereinafter sworn constitutes a true, correct and complete statement of the heirship of Mary Jane Stanford:

Mary Jane Stanford was also known as Janie Stanford, Mary Stanford, Janie Feige and Mary Jane Feige.

I have personally known Mary Jane Stanford since she was born. Mary Jane Stanford was my first cousin. Her mother Ladosia Jean Landrum Stanford was my aunt.

Mary Jane Stanford was born on July 15, 1957, to Ladosia Jean Landrum Stanford and Georgie Keldon Stanford, Sr.

Mary Jane Stanford died on or about October 22, 2019, while being domiciled in Shelby County, Alabama, residing at 108 Sommersby Drive, Pelham, Alabama 35124.

Mary Jane Stanford was unmarried at the time of her death. She had previously been married to Daryl M. Feige, but was divorced from him on October 24, 2000. She did not remarry after her divorce. No children were born to or adopted by Mary Jane Stanford.

Georgie Keldon Stanford, Sr., the father of Mary Jane Stanford, died on or about July 23, 1986. The only children born to Georgie Keldon Stanford, Sr. were Georgie Keldon Stanford, Jr., Mary Jane Stanford and Beverly Jeannene Stanford Badger. Ladosia Jean Landrum Stanford, the mother of Mary Jane Stanford, died on or about March 9, 2010. The only children born to Ladosia Jean Landrum Stanford were Georgie Keldon Stanford, Jr., Mary Jane Stanford and Beverly Jeannene Stanford Badger. No children were adopted by Ladosia Jean Landrum Stanford.

Mary Jane Stanford was survived by her two siblings, Georgie Keldon Stanford, Jr. (whose address is 3000 County Road 33, Tuscumbia, Alabama 35674, telephone [REDACTED]) and Beverly Jeannene Stanford Badger (whose address is 804 Forrest Drive, Homewood, Alabama 35209-5212, telephone [REDACTED]). They were her only siblings. Said siblings are the sole and only heirs-at-law of Mary Jane Stanford.

I have been advised that Mary Jane Stanford died intestate without leaving a Last Will and Testament.

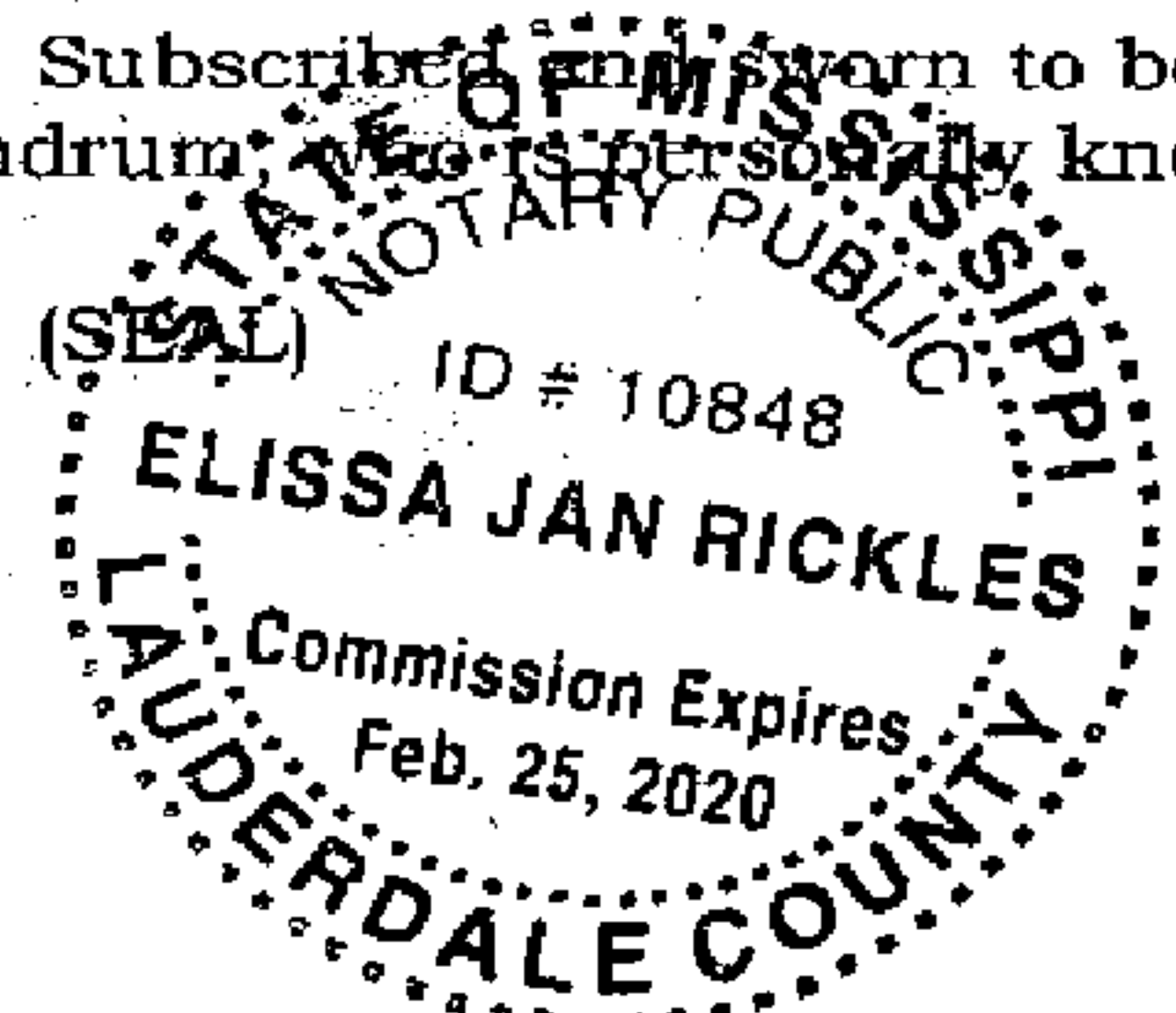
