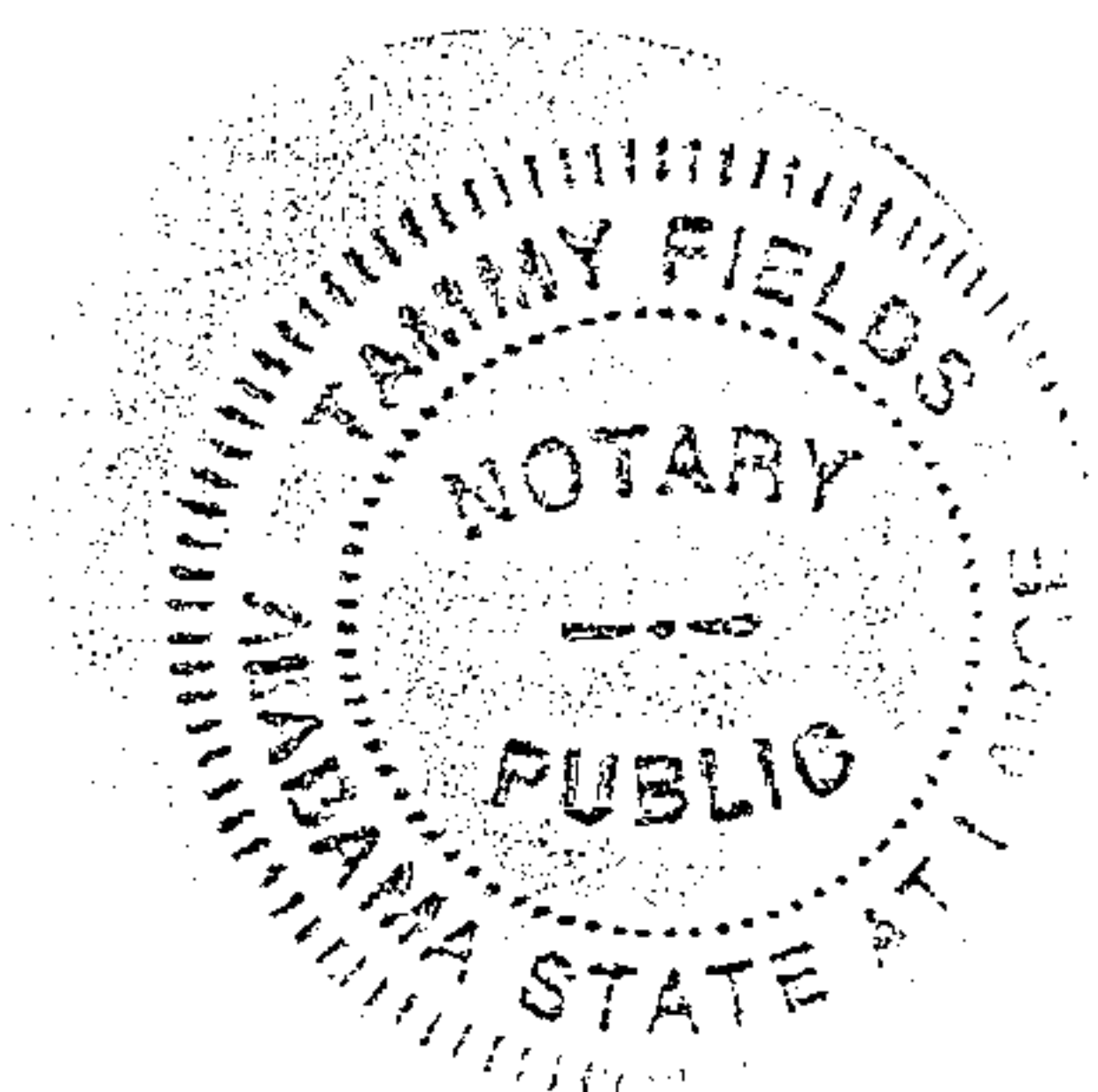


EXHIBIT "A" – LEGAL DESCRIPTION



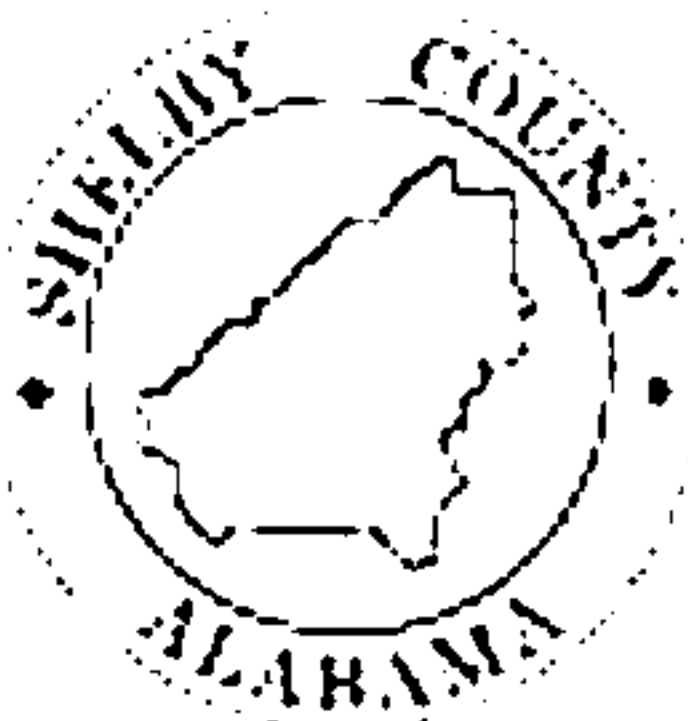
