



**CERTIFICATE OF FORMATION
OF
SCORDINO DESIGNS, LLC
A LIMITED LIABILITY COMPANY
ORGANIZED UNDER THE LAWS OF ALABAMA**

The undersigned, acting as the organizer and the initial member of a limited liability company under the Alabama Limited Liability Company Law (the "Act"), CODE OF ALABAMA, 1975 § 10A-5-2.01, *et. seq.* hereby adopts this Certificate of Formation for the purpose of organizing a limited liability company.

1. The name of the filing entity being formed is Scordino Designs, LLC, hereinafter referred to in this Certificate of Formation as the LLC (the "LLC").
2. The type of filing entity being formed is a limited liability company.
3. The LLC shall continue in perpetual existence until it is dissolved in accordance with the provisions of the operating agreement, or, if there is no operating agreement or no provision in the operating agreement governing the duration of the LLC, then in accordance with the Alabama Limited Liability Company Act, or other applicable laws.
4. The LLC is organized and will be operated for the purpose of engaging in a screen-printing business as well as any other lawful business for which a limited liability company may be organized.

8. Management of the LLC shall be vested in manager(s). There shall be one initial managers of the LLC and the name and address of the persons who are to serve as the initial managers until their successor(s) are elected and qualify are as follows:

10. The initial member of the LLC shall have the right to admit additional members to the LLC in accordance with the terms and conditions of the Operating Agreement of the LLC in effect at that time.

11. In the event a member withdraws or ceases to be a member of the LLC for any reason, such member's interest in the LLC shall be dealt with in accordance with the Operating Agreement of the LLC in effect at the time, and any applicable provisions of the Alabama Business and Nonprofit Entities Code.


12. Upon the dissolution and winding up of the business and affairs of the LLC for any reason, all assets and properties of the LLC remaining after the payment of its debts and obligations shall be distributed exclusively to the members as set forth in the Operating Agreement at that time.

13. The regulation of the internal affairs of the LLC shall be governed by the Operating Agreement of the LLC in effect at that time.


14. The legal existence and business of the Company may be continued by the written consent of all the remaining members within ninety days after an event of disassociation of a member.
