That in consideration of **SIX HUNDRED FIFTEEN THOUSAND AND 00/100 Dollars (\$615,000.00)** to the undersigned grantor in hand paid by the grantee herein, the receipt and sufficiency of which is acknowledged,

(hereinafter referred to as "Grantor") does grant, bargain, sell and convey unto

(hereinafter referred to as "Grantee"), as joint tenants with right of survivorship, the following described real estate situated in Shelby County, Alabama to-wit:

\$492,000.00 of the proceeds come from a mortgage recorded simultaneously herewith.


- Subject to:

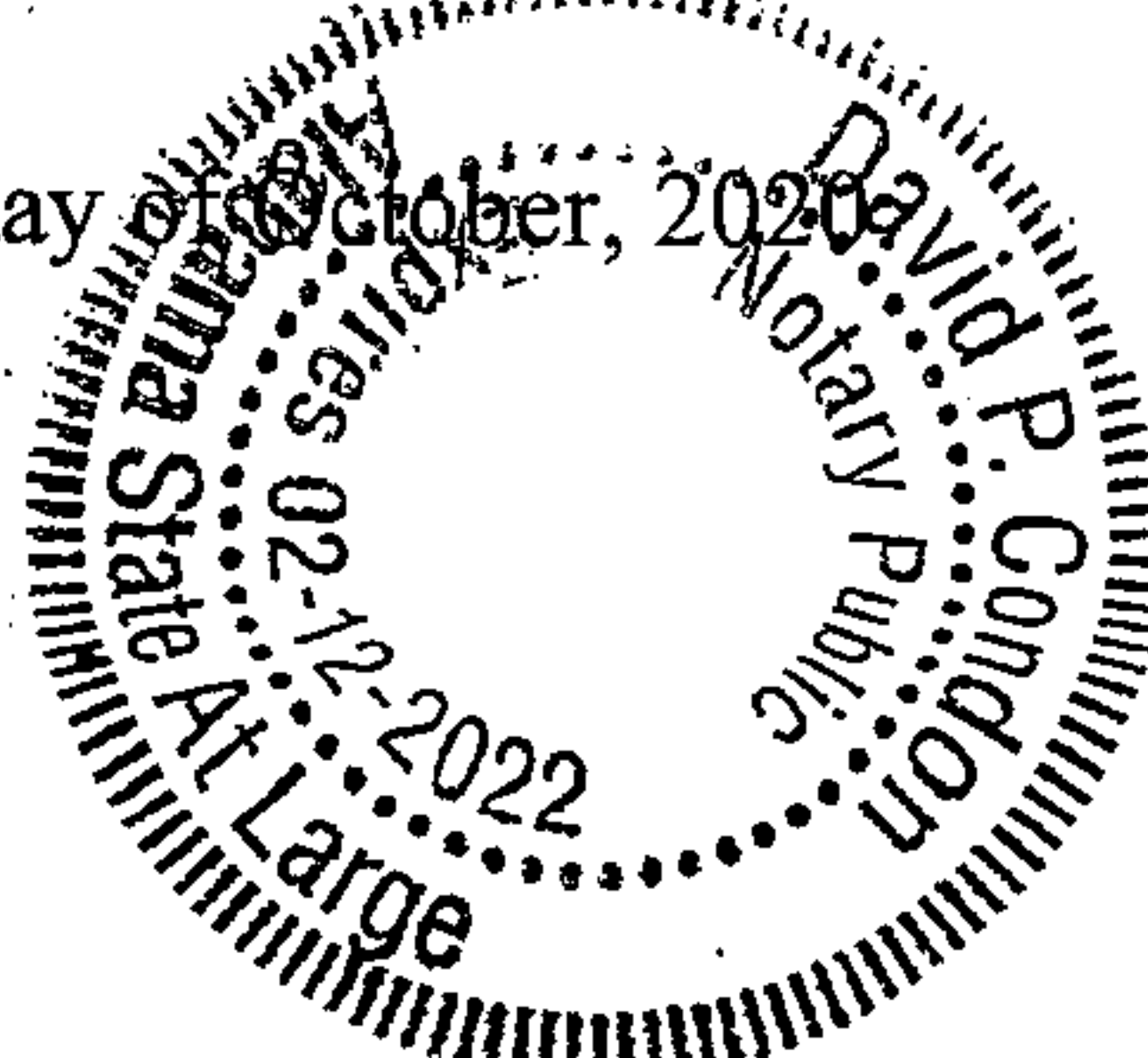

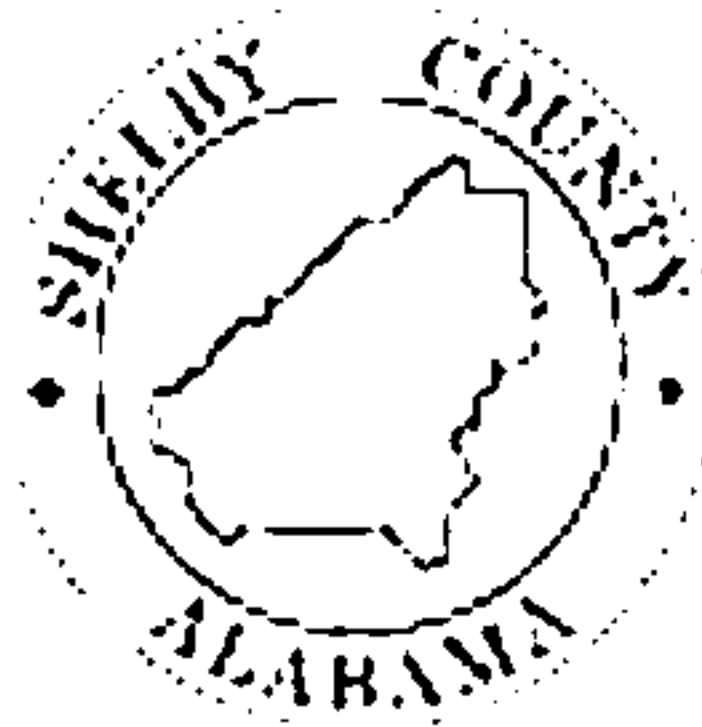
