
For ad valorem tax purposes only, the address for the above described property is 104 Hastings Lane, Maylene, AL 35114.

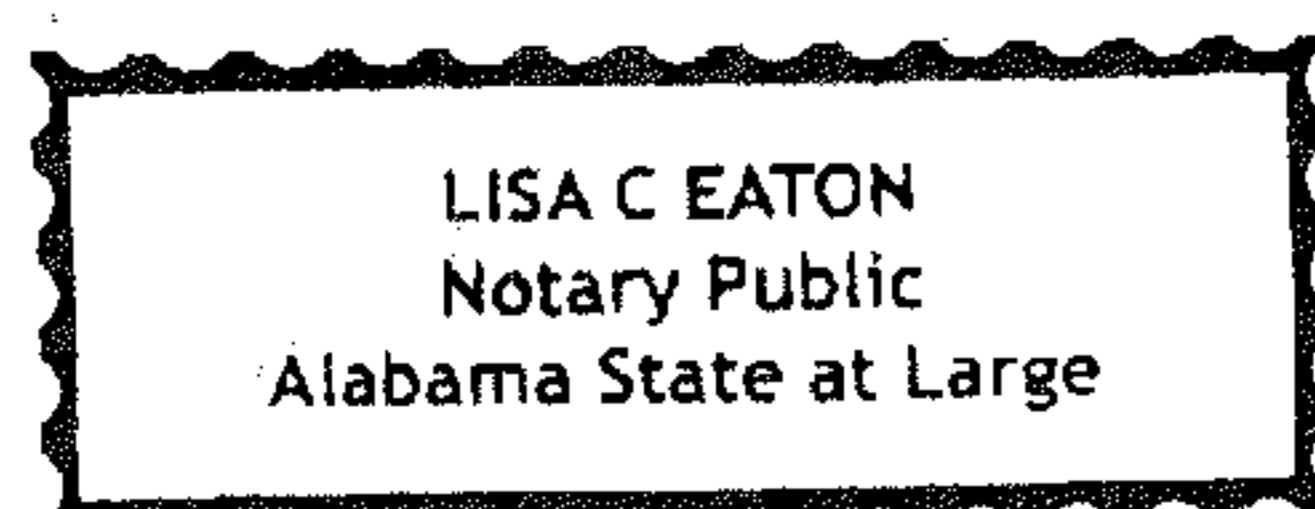


