Wilson, an unmarried person** (herein referred to as grantor), grant, bargain, sell and convey unto **James R. Ziegler Jr. and Keisha L. Crane**, (herein referred to as grantees), for and during their joint lives, and upon death of any of them, then to the survivor(s) of them in fee simple, together with every contingent remainder and right of reversion, the following described real estate situated in **Shelby County, Alabama**, to wit:

Lot 2, according to the Survey of Wood Ridge, as recorded in Map Book 30, Page 7, in the Office of the Judge of Probate of Shelby County, Alabama.

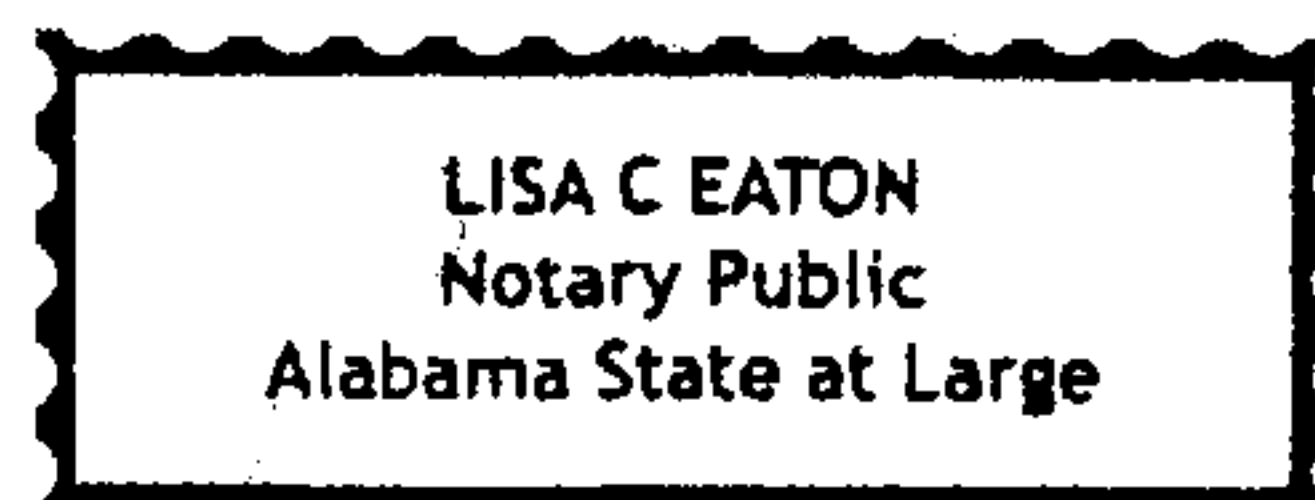
