KNOW ALL MEN BY THESE PRESENTS, That in consideration of the sum of Three Hundred Thirty-Nine Thousand And No/100 Dollars (\$339,000.00) paid by the grantee herein, the receipt of which is hereby acknowledged, I/we, Michael K. McDuff, husband and wife (hereinafter grantor, whether one or more), do grant, bargain, sell and convey unto Luke Keahey Horton and Katherine Morris Horton (hereinafter Grantees), as joint tenants with rights of survivorship, all of my/our right, title and interest in the following described real estate, situated in Shelby County, Alabama.

Subject to current taxes, all matters of public record, including, but not limited to easements, restrictions of record, and other matters which may be viewed by observation.


Subject to a third party mortgage in the amount of \$305,100.00 executed and recorded simultaneously herewith.




