WARRANTY DEED WITH JOINT RIGHT OF SURVIVORSHIP

**STATE OF ALABAMA
COUNTY OF SHELBY**

KNOW ALL MEN BY THESE PRESENTS,

On this October 30, 2020, That for and in consideration of **THREE HUNDRED THIRTY FIVE THOUSAND AND NO/100 (\$335,000.00) DOLLARS**, and other good and valuable consideration, this day in hand paid to the undersigned **ROBERT H. POLLARD and LORI W. POLLARD**, husband and wife, **PHIL POLLARD**, a married man, and **SANDRA GREENE**, a married woman, (herein referred to as "Grantors"), in hand paid by the Grantees herein, the receipt whereof is hereby acknowledged, the Grantors do hereby give, grant, bargain, sell and convey unto the Grantees, **BRIAN CHESHIRE and KERRIE CHESHIRE**, (herein referred to as "Grantees"), for and during their joint lives and upon the death of either, then to the survivor of them in fee simple, together with every contingent remainder and right of reversion, all of the Grantors' interest in the following-described Real Estate situated in, **SHELBY COUNTY, ALABAMA**, to wit:

Lot 46, according to the Map of Southern Pines, 5th Sector, as recorded in Map Book 9, Page 106, in the Probate Office of Shelby County, Alabama.

Subject to:

1. General and special taxes or assessments for the year 2021 and subsequent years not yet due and payable.
2. Municipal improvements, taxes, assessments, and fire district dues against subject property, if any.
3. Mineral and mining rights not owned by Grantors.
4. Any applicable zoning ordinances.
5. Easements, encroachments, building set back lines, rights-of-ways as shown of record by recorded plat or other recorded instrument, including any amendments thereto.
6. All matters, facts, easements, restrictions, assessments, covenants, agreements and all other terms and provisions in Map Book 9, Page 106.

Marjorie W. Pollard died on June 8, 2004 leaving a Last Will and Testament whereby she gave, bequeathed and devised all of her property, real and personal, to her only three children, namely Robert H. Pollard, Phil Pollard, and Sandra Greene. Marjorie W. Pollard was unmarried at the time of her death.


The purchase of the herein described real property is being financed in whole or in part by the proceeds of a purchase money mortgage being executed simultaneously herewith.

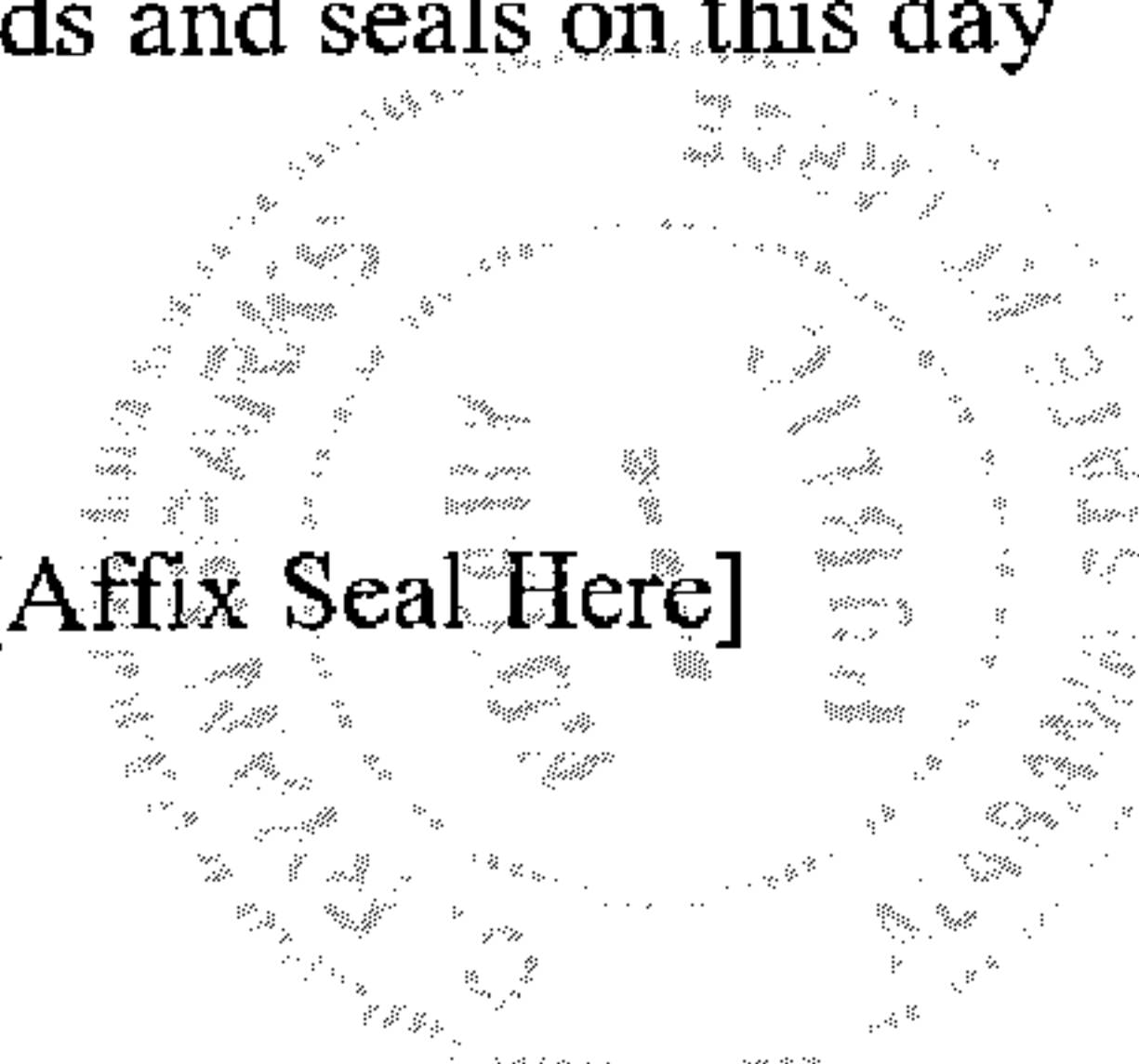

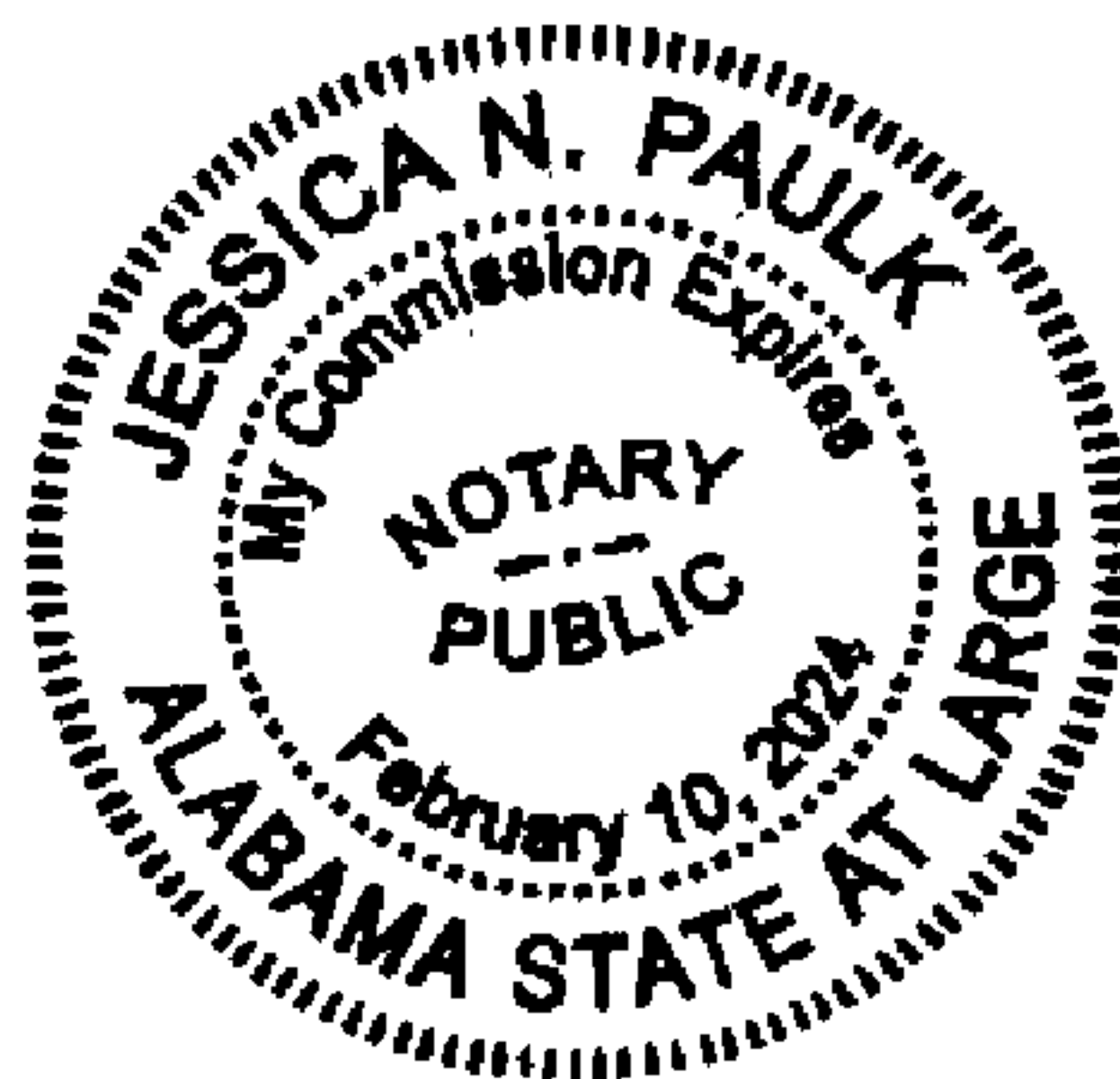


