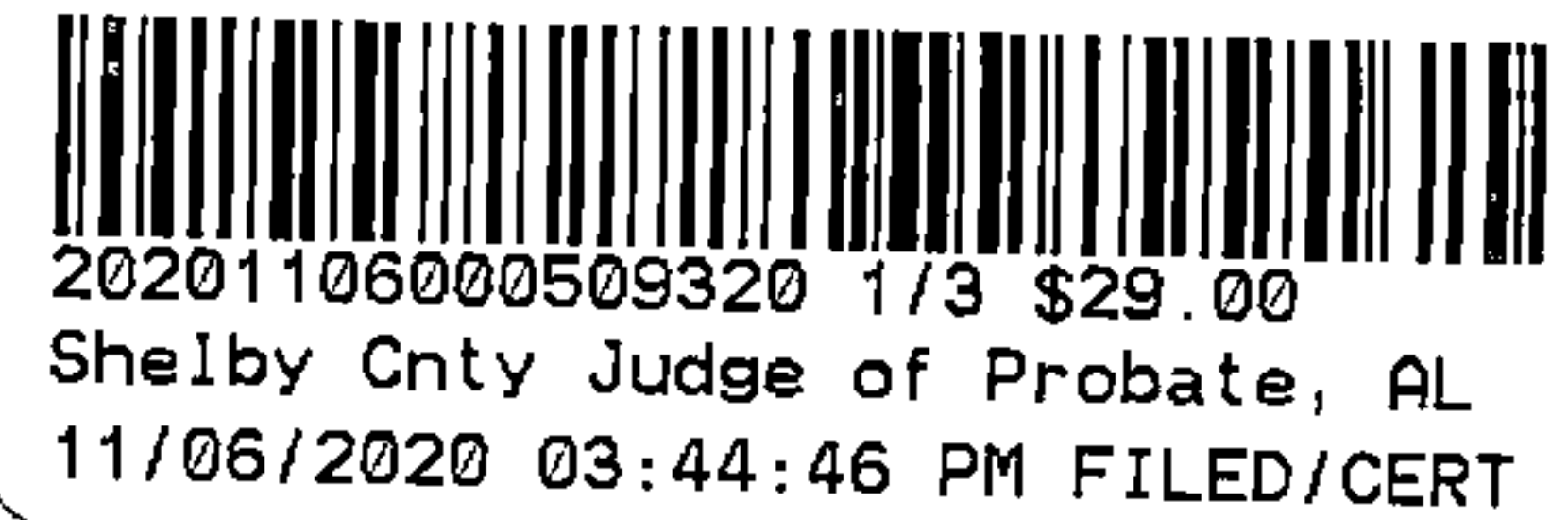

REDEMPTION DEED

WHEREAS, pursuant to a writ of execution issued out of the State Department of Revenue, State of Alabama, Montgomery, Alabama, under the authority of Section 40-2-11(16), Code of Alabama 1975, the Sheriff of Shelby County, Alabama, did on January 02, 2007 by virtue of his authority as Sheriff of said County offer for sale and did sell to the State of Alabama the following described property owned by taxpayer DANIEL P. FLYNN AKA DANIEL P. FLYNN JR., to wit:

Commence at the Southwest corner of Lot 8, Grady King's Subdivision, as recorded in Map Book 5, Page 81, in the Office of the Judge of Probate, Shelby County, Alabama; thence turn south along the East line of Dearing Downs - 11th Addition for a distance of 210.00 feet to the point of beginning; from the point of beginning thus obtained continue along the last described course for a distance of 130.00 feet; thence turn an angle to the left of 90 degrees and run East for a distance of 190.42 feet to the West line of Heather Ridge Drive; thence turn an angle to the left of 92 degrees, 48 minutes, 30 seconds and run North along the West right of way for a distance of 171.33 feet; thence turn an angle to the left of 99 degrees, 55 minutes, 21 seconds and run Southwest for a distance of 186.61 feet to the point of beginning. Contains 28,124 Square Feet.

WHEREAS, the Sheriff of Shelby County, issued a Sheriff's Deed to the State of Alabama which was subsequently recorded in the Probate Office of Shelby County, Inst# 20070129000043510; and

WHEREAS, DANIEL P. FLYNN AKA DANIEL P. FLYNN JR. tendered payment of the taxes due the State Department of Revenue together with interest, penalties and costs in order to redeem the above described property from the State Department of Revenue; and

WHEREAS, it has been certified to the Governor by Vernon Barnett, Commissioner of Revenue of the State of Alabama, that all requirements of law with respect to the redemption of said property have been complied with and that a sale has been obtained and negotiated;


NOW THEREFORE, I, Kay Ivey, as Governor of the State of Alabama, pursuant to the

provisions of Section 35-4-385, Code of Alabama 1975, for and in consideration of the taxes due the State Department of Revenue together with interest, penalties, and costs paid to the State of Alabama and receipt of which is hereby acknowledged, do hereby grant, bargain, sell and convey to DANIEL P. FLYNN AKA DANIEL P. FLYNN JR., the taxpayer's heirs and assigns, all interests in and to the said land described herein which shall or may have accrued to the State of Alabama at said execution sale pursuant to the writ set out in the said deed of the Sheriff of Shelby County, Alabama to the State of Alabama;



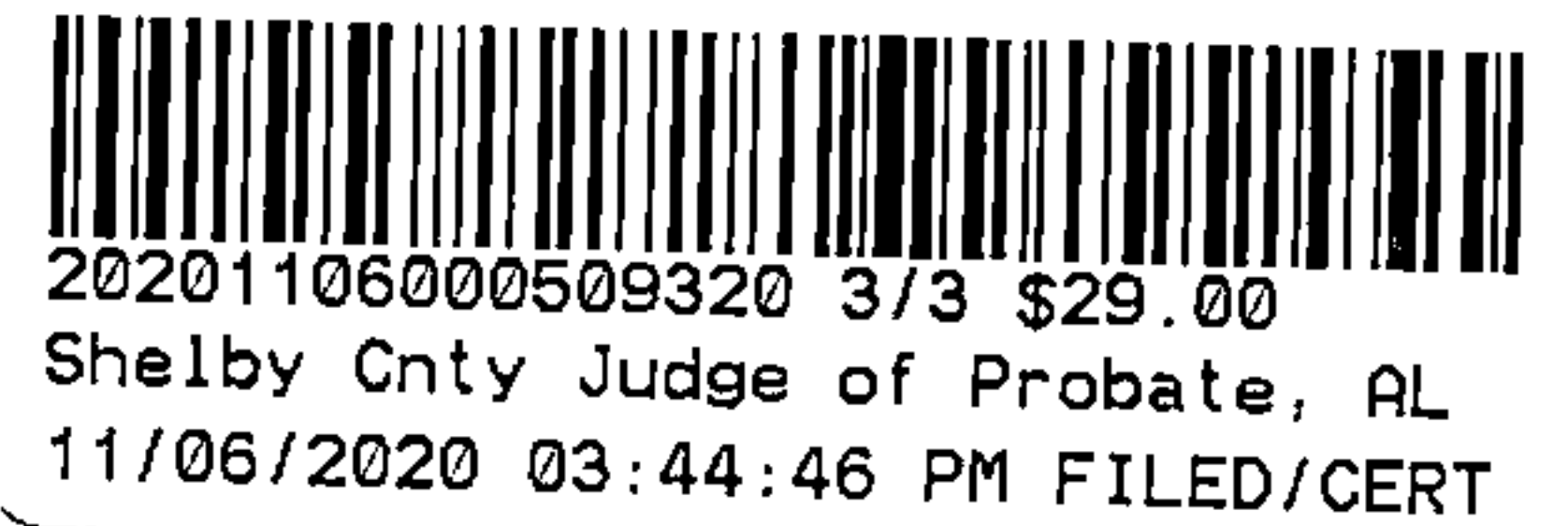

Total purchase price - the total amount paid for the purchase of the property, both real and personal, being conveyed by the instrument offered for record.

Actual value - if the property is not being sold, the true value of the property, both real and personal, being conveyed by the instrument offered for record. This may be evidenced by an appraisal conducted by a licensed appraiser or the assessor's current market value.

If no proof is provided and the value must be determined, the current estimate of fair market value, excluding current use valuation, of the property as determined by the local official charged with the responsibility of valuing property for property tax purposes will be used and the taxpayer will be penalized pursuant to Code of Alabama 1975 § 40-22-1 (h).
