**RANDY GOODWIN is one and the same person as JAMES RANDALL GOODWIN.**

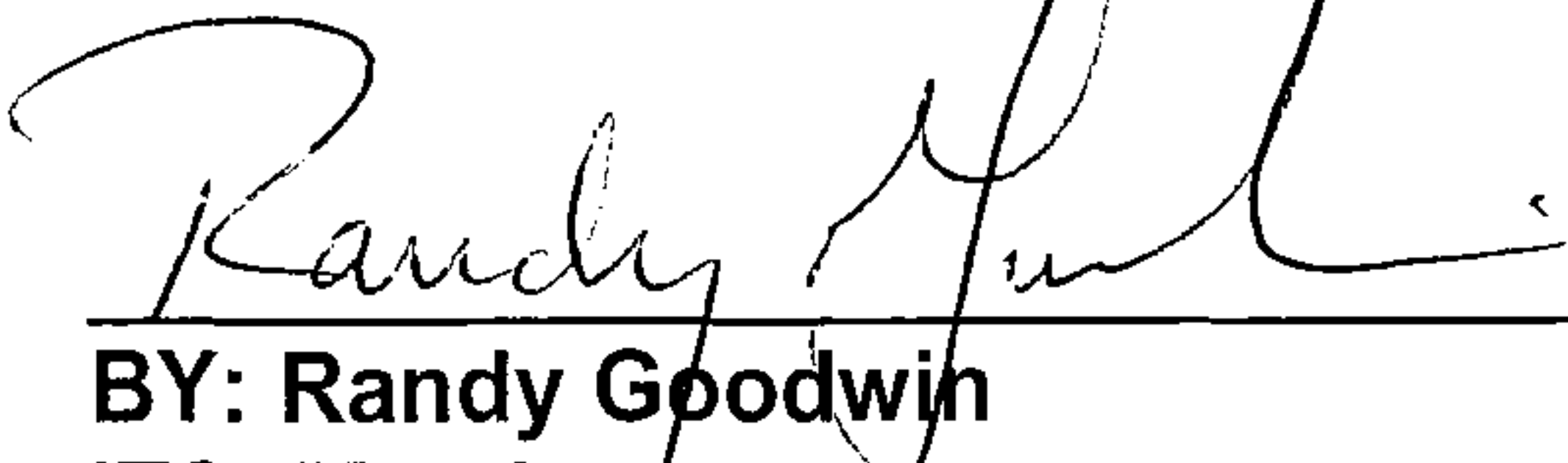
